

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Friendship Haven, Inc. Employees' Pension Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a single-employer defined contribution plan covering all employees of the Organization.

Employees of the Organization are eligible to make elective deferrals immediately upon employment commencement date under a salary reduction agreement. To qualify for Organization contributions, employees must have completed one year, as defined in the Plan, and 1,000 hours of service and reached the age of 21. All contributions are placed in the 403(b) plan and are subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees may make elective deferral contributions from pretax compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Participants may change their contribution percentage quarterly.

For eligible participants who have completed one year and 1,000 hours of service, the employer will provide a discretionary match of each participant's pretax compensation as defined by the Plan. The match was 2% for the year ended December 31, 2024.

The employer may also make a qualified non-elective contribution in an amount to be determined by the employer.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of income and expenses are based on the proportion that each participant's account balance bears the total of all participant account balances.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after five years of credited service.

Payment of Benefits

On retirement, death, disability or termination of service, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump sum payment equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,778 and \$10,355, respectively. Forfeitures may be used to reduce future employer non-elective contributions. In 2024, employer contributions were reduced \$470 from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual basis of accounting. The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation (Depreciation) in Fair Value of Investments

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Fees and expenses for the management of common trust funds by external service providers are paid from plan assets.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

Fair values of mutual funds are determined by reference to quoted market prices and other relevant information generated by market transactions.

Level 2 Fair Value Measurements

Fair values of fixed annuities are observable inputs based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into an investment contract with Empower Annuity Insurance Company of America to maintain the contributions in mutual funds and an insurance company general account. The accounts are credited with earnings on the investments, appreciation or depreciation in fair value, and charged for plan withdrawals and administrative expenses.

The Plan has a fully benefit-responsive investment contract in the fixed account investment option. Under the terms of the contract, a crediting rate is established for amounts invested in the fixed account. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. Upon plan discontinuance of the group funding agreement, it may be possible to receive the market value of the assets held in the fixed account.

The contract value of the fixed account at December 31, 2024 and 2023 was \$251,189 and \$244,638, respectively. The average yield earned by the fixed account was 1.6% for the year ended December 31, 2024.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of Friendship Haven, Inc. No such employees receive compensation from the Plan. Certain administrative expenses for the Plan are paid directly by Friendship Haven, Inc.

The Plan pays fees to The Finway Group, LLC, the third party administrator, for administrative services. For the year ended December 31, 2024, the Plan directly paid fees of \$26,491.

The Plan pays fees to Empower Annuity Insurance Company of America for record keeping services. For the year ended December 31, 2024, the Plan directly paid fees of \$17,577, of which \$4,685 is included in benefits paid to participants on the statement of changes in net assets available for benefits.

The Plan pays fees to Northwest Wealth Management, LLC for investment advisory services. For the year ended December 31, 2024, the Plan directly paid fees of \$14,776.

The Plan pays fees to World Investment Advisors, LLC for services. For the year ended December 31, 2024, the Plan directly paid fees of \$2,955.

Certain Plan investments are mutual funds managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian, as defined by the Plan. Therefore, these transactions qualify as party in interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - TAX STATUS

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon an examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for benefits, have been evaluated for possible adjustment to the financial statements or disclosure is October 3, 2025, which is the date the financial statements were available to be issued.
