Their report dated October 11, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **1. Description of the Plan**

The following brief description of the Laser Holdings, LLC 401(k) P/S Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### ***General***

The Plan is a defined contribution plan and was adopted by Laser Holdings, LLC (the Company) effective January 1, 2018, and restated effective December 12, 2022, to provide deferred tax benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### ***Eligibility***

The Plan covers all active employees of the Company who are at least 18 years of age and have completed one month of service, excluding employees covered by a collective bargaining agreement and non-resident aliens. Enrollment is allowed on the day coinciding with or subsequent to completion of the eligibility requirements. Participants who have completed 1,000 hours of service and are employed on the last day of the applicable Plan year are eligible to receive profit-sharing Company contributions and Company discretionary matching contributions (collectively, Company contributions). Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan.

#### ***Contributions***

Participants may elect to contribute, on a pre-tax basis contributions as defined by the Plan, through payroll deductions, not to exceed the limit under the Internal Revenue Code (IRC). Eligible employees who have attained age 50 before the close of the Plan year are allowed to make catch-up contributions up to the maximum allowed by the IRC. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Newly hired employees who become eligible to participate in the Plan are automatically enrolled at 2% of their compensation, unless another option is selected by them, with no automatic annual increases. Participants direct the investment of their contributions into various investment options offered by the Plan.

Company discretionary matching and profit-sharing contributions may be made and are determined annually by the Company. There were no such Company contributions made during 2024.

#### ***Participant Accounts***

Each Participant's account is credited with the Participant's contributions and Company contributions, as well as Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings (losses), account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### ***Vesting***

Participants are 100% vested in their deferrals, their voluntary and rollover contributions, plus actual earnings thereon. Vesting in any Company contributions is based on years of credited service. The Plan document allows crediting for years of service for Participants who terminate and are rehired, subject to certain rules.

#### *Vesting (cont.)*

Based on years of credited service, the vesting schedule is as follows:

Participants become 100% vested in their account upon termination of employment due to death or disability.

#### *Payment of Benefits*

Benefits may be paid to the Participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan document. The Plan provides for a normal retirement age of 65. The total vested portion of a Participant's account balance is distributed in the form of a lump sum payment or installments. Participants experiencing financial hardship may withdraw a portion of their vested account balance, as defined in the Plan document. Upon separation from service with the Company, if the participant's account is equal to or less than \$1,000, the Participant will receive an automatic cash lump-sum distribution equal to their vested account balance. If the account is greater than \$1,000 but less than or equal to \$5,000, any distribution that is made without the Participant's consent will be rolled over to an individual retirement plan designated by the Plan Administrator.

#### *Forfeitures*

The Plan allows forfeitures to be used to reduce Employer contributions or pay Plan expenses. During the year ended December 31, 2024, the Company utilized \$107 of forfeitures to pay Plan expenses. Unused forfeitures available for use at December 31, 2024 and 2023 were \$49 and \$9, respectively.

#### *Plan Expenses*

Certain administrative expenses of the Plan are paid by the Plan. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income earned by Plan Participants.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (cont.)

#### *Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan Participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Payment of Benefits*

Benefit payments to Participants are recorded upon distribution.

### 3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Ascensus, LLC (Ascensus), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

### 4. Fair Value Measurement (cont.)

#### *Basis of Fair Value Measurement (cont.)*

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methodology is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by Plan Administrators, Inc. The Internal Revenue Service (IRS) has opined and informed Plan Administrators, Inc. by a letter dated June 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, Participants would become fully vested in their Company contributions.

### **7. Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The recordkeeping and custody functions for the underlying investments held by the Plan are performed by Ascensus. Usual and customary fees were paid for investment management services. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

### **8. Risks, Uncertainties, and Concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances, and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 46% and 21% of the Plan's investments were invested in iShares Core Balanced Allocation ETF and Core S&P 500 ETF, respectively. At December 31, 2023, approximately 47% and 20% of the Plan's investments were invested in iShares Core Growth Allocation ETF and Core S&P 500 ETF, respectively.

### **9. Delinquent Participant Contributions**

During 2023, employee withholdings of \$618 were not remitted within the appropriate time period by the Company. The Company remitted the delinquent contributions of \$618 to the Plan during 2024 and plans to remit any applicable lost earnings to the Plan during 2025. These transactions constituted prohibited transactions as defined by ERISA.

### **10. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

### **11. Subsequent Events**

The Plan has evaluated subsequent events through October 07, 2025, the date the financial statements were available to be issued, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
