1. Description of the Plan

The following description of The MGM Resorts 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan covering eligible employees of MGM Resorts International and its related entities (collectively the "Plan Sponsor"). Both nonunion employees and employees covered by collective bargaining agreements that allow for participation in the Plan who have met the eligibility requirements defined in the Plan document are eligible to participate in the Plan. The Plan is subject to the provisions of Section 401(a) of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee (i) is responsible for oversight of the Plan and (ii) in conjunction with the Plan's independent investment consultant, is responsible for the Plan's investment options and the monitoring of investment performance.

Contributions to the Plan

Participants may contribute up to 75% of their eligible annual salary to the Plan subject to certain non-discrimination restrictions and an annual limitation of \$23,000 for 2024 (\$30,500 for those participants who are age 50 or over). Roth contributions are also permitted under the Plan.

The Plan permits the Plan sponsor to make matching contributions to participants who have met the eligibility requirements defined in the Plan document. The Plan sponsor elected to match 50% of deferral contributions up to 6% of eligible compensation.

Employees of MGM Yonkers, Inc. on September 9, 2019 and covered by the September 9, 2019 Agreement between MGM Resorts International, MGM Yonkers, Inc. and the New York Hotel & Motel Trades Council, AFL-CIO (the "YRPBA Employees") receive the following matching contribution: 50% of deferrals up to 4% of compensation per pay period.

MGM Grand Detroit makes contributions to the Plan for Bargaining Unit Members of all Detroit Casino Council (DCC) employee participants. These contributions are based on Years of Contribution Service (as defined in the Plan document) and are made following the completion of one Year of Contribution Service, as follows:

MGM Grand Detroit also makes contributions to the Plan for Bargaining Unit Members in the International Union, Security, Police and Fire Professionals of America (IUSPFPA). These contributions are based on Years of Contribution Service (as defined in the Plan document) and are made following the completion of one Year of Contribution Service, as follows:

Plan participants who are Bargaining Unit Members in the DCC and IUSPFPA are not eligible to receive matching contributions under the Plan.

MGM National Harbor makes a bi-weekly employer contribution to the Plan for National Harbor Teamster Union employees and National Harbor UAW Union employees. The contribution is based on Years of Contribution Service (as defined in the Plan document) and are made following the completion of one Year of Contribution Service, as follows:

National Harbor Teamster Union employees and National Harbor UAW Union employees are not eligible to receive matching contributions under the Plan.

Participant Accounts

All of the Plan's assets are invested, as directed by the participant, as pooled funds. A participant's account balance in the Plan is derived through an allocation of these funds. Each participant's account is credited with the participant's contribution, employer contributions, and an allocation of investment earnings and losses pursuant to the participant's selection of investments and timing of purchase.

Vesting and Forfeitures

Participants are immediately vested in their contributions, rollovers and related earnings thereon at all times. All participants except the above-referenced DCC, IUSPFPA and National Harbor Union members vest in employer matching contributions at the rate of 20% after one year of service and are 100% vested after five years of credited service. DCC, IUSPFPA, and National Harbor Union participants vest in the above-referenced DCC, IUSPFPA, and National Harbor Union Participant employer contributions as follows: 0% if less than 2 years; 50% if at least 2 years but less than 3 years; and 100% if 3 years or greater. Participants become 100% vested in the event of death, disability, or normal retirement. Forfeitures are used to make required contributions by the employer under the Plan. At December 31, 2024 and 2023, forfeitures available to offset employer contributions were \$511,319 and \$339,133, respectively. During the year ended December 31, 2024, forfeitures in the amount of \$388,035 were used to reduce employer contributions.

Payment of Benefits

The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship (as defined in the Plan), or termination of employment. In-service distributions are available for participants who are at least age 59½. Withdrawals of rollover contributions are also available. Participants who qualify for retirement benefits or withdrawals may receive their benefits in the form of a lump sum payment or to rollover to another eligible retirement plan or an individual retirement account (IRA). The benefit to which a participant is entitled is the benefit that can be provided solely from the participant's vested account balance. Participants who separate from service and have vested account balances equal to or less than \$7,000 and do not process their own distribution will receive a lump sum cash payment if the entire vested account balance is equal to or less than \$1,000. If the value of the vested account balance is greater than \$1,000 but equal to or less than \$7,000 the account will be rolled over to an individual retirement account. Participants who separate from service and have vested account balances greater than \$7,000 may receive a lump sum cash payment or direct rollover or defer receipt of the entire Plan account. This cashout rule does not apply to employees of MGM Detroit Casino Council whose job classification is seasonal coat check attendant. Retired

participants must begin receiving distributions from the Plan no later than April 1 of the year following the year in which the participant attains age 73.

Notes Receivable from Participants

The Plan permits participants to receive a loan based upon their vested account balance. Borrowings are limited to the lesser of \$50,000 or 50% of the participant's vested account balance. The minimum loan amount is \$500 and participants may only have one loan outstanding at any time. Loans bear an interest rate of one percent above prime rate determined on the date of the advance by the Plan administrator. Loans generally must be repaid with interest, by payroll deduction, within five years (longer for qualified residential loans). Loans are segregated investments and to the extent a participant borrows, his or her account will not share in the earnings and gains in value attributable to other Plan investments. Accordingly, the interest that participants pay on their loans will be directly credited to their accounts. All loans are immediately due upon termination of service, retirement, disability, or death, unless otherwise provided per the Plan's loan procedure. The loans are secured by the balance in the participant's account and in the event of default, the unpaid loan principal will be offset against the participant's vested account balance.

Plan Amendments

The Seventh Amendment was adopted on May 28, 2024 as follows: effective January 1, 2024, to codify the Plan's existing practice that any forfeitures be utilized only to make required contributions by an Employer under the Plan.

The Eighth Amendment was adopted on September 12, 2024 as follows:

Effective July 3, 2024, the matching contributions of YRPBA employees is calculated by combining pretax and Roth contributions.

The Ninth Amendment was adopted on November 22, 2024 as follows:

- Effective December 1, 2024, any MGM Detroit Casino Council Employee shall receive a one time matching contribution equal to 50% of deferral or Roth contributions made with respect to the 2023 lump sum bonus paid in December 2024 as long as they are employed at time of bonus payment and meet other eligibility requirements in the 2023 CBA.
- Effective January 1, 2024, the dollar limit for a mandatory distribution was increased to \$7,000.
- Effective March 1, 2024, the vested account balance of any MGM Detroit Casino Council employee with a job classification of seasonal coat check attendant shall not be subject to the mandatory cashout rule.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with ERISA. Contributions from participants are recorded when withheld from the participant. Employer contributions are recorded when approved by the Plan sponsor. Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value as determined by the Plan custodian (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to distributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Expenses

Administrative expenses of the Plan are paid by the Plan, a quarterly fixed percentage administrative fee amount paid by participants. Fees related to the administration of notes receivable from the participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

3. Certification of Assets

Empower Trust Company, LLC ("Empower") serves as the trustee and custodian of the Plan's assets. In that capacity, Empower holds the Plan's investment assets and executes investment transactions. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under the Employee Retirement Income Security Act of 1974 (ERISA). As permitted under such election, the Plan administrator has obtained certifications from Empower as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all investment information supplied to the Plan is complete and accurate. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends and net appreciation/depreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the certified information.

The framework for measuring fair value provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets and or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices

that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the quoted net asset value of shares of the underlying investments held by the plan at year-end.

Common stocks: Valued at the closing prices reported on the active market on which the individual securities are traded.

Common collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable Value Fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the net asset value (contract value) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Tax Status**

The Plan has received a favorable determination letter from the Internal Revenue Service dated August 18, 2022, stating that the Plan as amended and restated on December 7, 2021, generally effective as of January 1, 2021, including the First and Second amendments to the Plan, is qualified under Section 401(a) of the Internal Revenue Code and that the related trust for the Plan is exempt from taxation under Section 501(a) of the Internal Revenue Code. The Plan's Administrative Committee believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is

subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. **Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants who are affected by such termination shall become 100% vested and net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

7. **Related Party Transactions**

Empower Trust Company, LLC ("Empower") serves as the trustee and custodian of the Plan's assets. All transactions with Empower qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment.

Empower provides certain administrative services to the Plan pursuant to an agreement between the Company and Empower. For 2024, the administrative fees of Empower and other Plan service providers are paid from the fixed percentage administrative fees paid by participants; and any revenue that Empower receives from investment funds for services Empower provides, the funds are credited back to participants.

8. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

10. Prohibited Transactions

During the year ended December 31, 2024, the Plan sponsor did not remit certain participant contributions to the Plan in a timely manner as defined by ERISA. See the Schedule of Delinquent Participant Contributions. The Plan sponsor will compensate participants for any lost earnings resulting from the delay in contributions. These contributions are considered nonexempt party-in-interest transaction subject to an excise tax that the company intends to pay.

11. Subsequent Events

The Tenth Amendment was adopted on February 24, 2025 as follows: effective January 1, 2025, any eligible MGM Detroit Casino Council employee who (i) elected to defer 100% of his or her lump sum bonus paid in December 2024 and (ii) received a 50% matching contribution in December 2024 determined based on the amount of his or her bonus net of applicable payroll tax withholding, shall receive an additional one-time matching contribution during the 2025 plan year equal to the difference between (x) 50% of the gross amount of the lump sum bonus (before any deductions for payroll taxes) and (y) the amount of the matching contribution such employee received in December 2024.

The Eleventh Amendment was adopted on August 25, 2025 in order to provide for the two changes: Effective July 1, 2025, in the event that the payment of a participant's vested account balance upon termination of employment is less than or equal to \$1,000, the default payment method shall be a direct rollover to an individual retirement account (as is already the case for mandatory distributions between \$1,000 and \$7,000). In addition, effective October 1, 2025, participants are permitted to make in-Plan Roth conversions from all or a portion of their salary deferral account, rollover account and catch-up contribution account (other than outstanding loan amounts) under the Plan.
