Opinion

NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024

(A) DESCRIPTION OF PLAN

The following description of the Ojo Caliente Holdings, Inc. (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees who have completed one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with the applicable sections of the Internal Revenue Code. The Plan was restated effective January 1, 2022, under the IRS Cycle 3 restatement requirements. The restatement did not result in any material change to the provisions of the Plan.

Contributions – Each year, participants may elect to contribute up to the maximum percentage of compensation and dollar amounts permissible under Code Section 402(g) not to exceed the limits of Code Sections 401(k), 404 and 415, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may, at its discretion, make matching contributions allocated as a percentage of contributions of eligible participants for the plan year and profit-sharing contributions to the Plan. Contributions are subject to certain limitations.

Participant Accounts – Individual accounts are maintained for each participant. Each participant's account is credited with the participant’s contributions and an allocation of (a) the Company's discretionary contributions and, (b) Plan earnings and charged with an allocation of any Plan expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants’ non-vested accounts are available to reduce employer contributions and offset administrative expenses of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent (100%) vested after six years of credited service with regard to Company discretionary contributions.

Payment of Benefits – On termination of service, death, disability or retirement, distributions of an amount equal to the value of the participant’s vest account balance are required to be paid to the participant as soon as administratively feasible following the date the participant requests a distribution. In-service withdrawals are permitted for active participants who have attained 59½ of their vested account balances. Effective January 1, 2019, the Company amended the Plan to comply with the Bipartisan Budget Act of 2018. Participants are no longer required to take a loan prior to a hardship withdrawal and contributions are no longer suspended as a result of taking a hardship withdrawal.

Forfeited Accounts – For the Plan years ended December 31, 2024, and 2023, forfeited non-vested accounts after reinstatement of account balances of former participants of \$639 and \$1,340, respectively, were available to be used for administrative fees or allocated among participants based upon compensation of all participants eligible to receive an allocation.

(B) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (“GAAP”).

Use of Estimates – The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates, judgements and assumptions that affect the amounts reported in the financial statements and accompanying notes during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. The Plan’s investments consist of mutual funds and exchange-traded funds (ETFs).

The Plans investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold, as well as held during the year.

Contribution – Contributions from the company are accrued in accordance with the terms of the Plan. Participant contributions are recorded in the period the Company makes the corresponding payroll deduction.

Payment of Benefits – Benefits are recorded when paid.

Operating Expenses – Some expenses of maintaining the Plan are paid by the Company while other expenses may be paid from the assets of the Plan. The expenses that are paid from Plan assets will either be shared by all participants or will be charged directly to the account to the participant that incurred the expenses. Fees paid by the Plan for administrative services amounted to \$49,859 for the year ended December 31, 2024.

(C) FAIR VALUE MEASUREMENTS

The authoritative guidance defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The guidance also establishes a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

The guidance describes three levels of input that may be used to measure fair value, which are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities;

Level 2 – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the asset or liabilities; and

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other fair market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(D) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

(E) TAX STATUS

The Internal Revenue Service has informed CCH Incorporated by an opinion letter dated March 31, 2014, that the Volume Submitter Profit Sharing Plan with CODA is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

(E) TAX STATUS - continued

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

(F) ADMINISTRATIVE COSTS

The Plan sponsor absorbs some administrative fees. The costs absorbed by the Plan sponsor for the year ended December 31, 2024, were approximately \$12,500.

(G) RISK AND UNCERTAINTIES

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(H) VESTED BENEFITS PAYABLE

The Plan had several participants who had separated from employment with the Plan's sponsor. The total deferred vested benefits due to these participants at December 31, 2024, were \$942,033. In accordance with generally accepted accounting principles, no accrual has been established for these benefits payable.

(I) RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are managed by Merrill Lynch and therefore, Merrill Lynch qualifies as a related party with respect to the Plan. Investment transactions with Merrill Lynch qualify as party-in-interest transactions that are exempt from prohibited transaction rules.

(J) SUBSEQUENT EVENT

Management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.
