Basis for Opinion

Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Dennis Group 401 (K) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at year end – modified cash basis for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following brief description of Dennis Group 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants are eligible to participate for purposes of salary deferrals and rollover contributions on their date of hire. Actual entry date is the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date of eligibility (date of hire).

The plan sponsor is Dennis Group LLC, a Massachusetts Company (“the Company”) with a primary mission of providing engineering, design and construction management services to the food processing industry.

Contributions – For 2024, eligible employees of the Company (“Participants”) may contribute up to \$23,500 of pre-tax annual compensation as defined in the plan. Participants over the age of 50 can contribute a maximum of \$30,500. The Internal Revenue Service adjusts this maximum annually. Participants have sole discretion to direct their contributions into various investment options offered by the Plan.

Employer profit sharing option – For the years ended December 31, 2020 and prior, the Company could make, on an annual basis, a profit-sharing contribution at the option of the plan sponsor’s Board of Directors. On January 1, 2022, the Plan was amended to include a matching contribution and to eliminate the profit sharing contribution. The employer contributed \$2,177,541 and 1,878,921 for the years ended December 31, 2024 and 2023, respectively.

Rollovers – Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

Participant accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All accounts are participant directed.

Vesting – Participants are immediately vested in their contributions, non-elective contributions, and actual earnings thereon. Vesting in the Company’s contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes receivable from participants – Participant loans may be granted based on financial hardship or a specified financial need. Participants can borrow from their fund accounts, a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. All loans must be repaid within five years; however, a longer term may be granted for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear a reasonable rate of interest. Principal and interest is paid ratable through bi-weekly payroll deductions. The amount of any loans unpaid at the date of termination of employment is treated as a distribution to the participant. There were \$608,733 and \$486,728 in loans outstanding on December 31, 2024 and 2023, respectively.

1. DESCRIPTION OF THE PLAN (continued)

Investment options – Upon enrollment in the plan, a participant may direct employee contributions into various mutual fund options provided by Empower Annuity Insurance Company of America (“Empower”). Each Participant shall direct the investment of their account among the permissible investments designated in the Service Agreement.

Payment of benefits – On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in their account, or a life annuity with monthly payments payable during the lifetime of the participant or beneficiary. Refunds of contributions in excess of the Section 401(k) limits are included in this category.

Forfeited accounts – Participant forfeitures are used by the Company to reduce the Company’s administrative costs and/or its annual profit-sharing contribution. At December 31, 2024 and 2023, there were \$42,849 and \$108,615 respectively, in forfeited non-vested accounts.

2. SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan’s financial statements. The financial statements and notes are representations of the Plan’s management, who are responsible for their integrity and objectivity. These accounting policies conform to the modified cash basis of accounting and have been consistently applied in the preparation of the financial statements.

Basis of accounting – It is the Plan’s policy to prepare its financial statements on the modified cash basis of accounting; consequently, revenues are recognized when received rather than when earned, and expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred. Modifications from the cash basis of accounting include investments which are stated at their current market value and recognition of notes receivable from participants.

Business activity – The Plan is responsible for administrating employee and employer contributions for employees of the Company. The Plan collects funds from the employer and transfers the collections to Empower who invests and distributes the funds.

Investments – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. The Plan’s Trustees determines the Plan’s valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of benefits – Benefits are recorded when paid and based on the terms of the plan. Refunds of contributions in excess of the Section 401(k) limits are included in this category.

Operating expenses – All expenses of maintaining the Plan are paid directly by the Company, unless the forfeiture account is used, or a combination of both.

3. INVESTMENTS

The Plan maintains policies and procedures to value instruments using the best and most relevant data available. In addition, the Plan has an investment management team that reviews valuation, including independent price validation for certain instruments. Further, in most instances, management develops internal valuations of the assets and instruments held in the Plan.

The following section describes the valuation methodologies the Plan uses to measure the financial instruments at fair value.

Mutual funds – Valuation is done on a daily basis. The custodian receives share prices/net asset values directly from the fund companies. These values are compared to daily valuations received by the custodian through the National Securities Clearing Corp (NSCC) to ensure the accuracy of the valuation, and any differences are resolved.

The Plan has a fully benefit-responsive guaranteed investment contract with Empower, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administration expenses. The guaranteed investment contract issues are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Guaranteed Interest Fund for defined contribution plans is a Guaranteed Interest Account (GIA) provided through a group annuity contract (“the Contract”). Under the terms of the Contract, a crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at Contract Value. Contract Value represents contributions plus credited interest less participant withdrawals and fees.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

3. INVESTMENTS (continued)

The guaranteed investment contract is presented on the face of the statement of net assets available for benefits – modified cash basis at contract value as stipulated by Accounting Standards Codification. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and the administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract values for December 31, 2024 and 2023 were \$5,707,143 and \$6,591,216, respectively.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yields earned by the guaranteed investment contract are as follows:

4. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in all their accounts.

5. ERISA SECTION 103(a)(3)(C) AUDIT

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 2024 and 2023, was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Empower (the custodian of the Plan).

6. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower. Empower is the custodian and record keeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Empower provides certain administrative services to the Plan pursuant to a Service Agreement between the Plan. Empower receives revenue directly from mutual fund service providers for services Empower provides to the Plan. This revenue is used to cover and/or offset certain amounts owed to Empower for its administrative services to the Plan.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits – modified cash basis.
