Opinion

We have audited the accompanying financial statements of Southside Bancshares, Inc. Employee Stock Ownership Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Southside Bancshares, Inc. (the “Company”) Employee Stock Ownership Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan, established as of January 1, 1984, covering all employees of the Company, and its subsidiary, Southside Bank (the “Bank”). Participation in the Plan commences January 1 or July 1 after attainment of age twenty-one and completion of at least one year of service, which is a 12-month period beginning on the employee’s employment date during which 1,000 hours of service are completed. Any employee who is employed by the Company as a security officer or other security personnel and who is also employed on a full-time basis by any federal, state, county, or local law enforcement agency shall be excluded from participation in the Plan. The Plan's Administrator is a committee appointed by the Board of Directors of the Company. Assets of the Plan shall be primarily invested in common stock of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

The employer may contribute to the Plan an amount determined at the sole discretion of the Company’s Board of Directors. Contributions to the Plan may be in the form of cash, common stock, or a combination thereof. Participant contributions are not permitted.

PARTICIPANT ACCOUNTS

Each participant's account is credited with an allocation of (1) the Company's contribution, (2) Plan earnings, and (3) forfeitures of terminated participants' non-vested balances and is charged with his or her withdrawals and withdrawal transaction fees. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Investments are nonparticipant directed.

VESTING

A participant becomes vested in employer contributions in the following manner:

<u>Participant’s Years of Service</u>	<u>Vested Percentage</u>
Less than two years	0%
Two years	20%
Three years	40%
Four years	60%
Five years	80%
Six or more years	100%

Full vesting also occurs upon death, disability, or retirement, as defined in the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

PAYMENT OF BENEFITS

The value of a participant's account is distributed upon normal retirement, death, disability, or termination of employment. A participant or spousal beneficiary may elect to receive the vested value of his or her account in a lump-sum amount, rollover their account balance to an Individual Retirement Account (IRA) or elect to receive equal installment payments. Non-spousal designated beneficiaries can elect a lump-payment, rollover the distribution to an IRA or elect installments over the longer of the beneficiary's life expectancy or participant’s life expectancy. Distributions can be made in cash or in the form of Company stock.

NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

DIVERSIFICATION

Diversification is offered to participants close to retirement age so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan are considered Qualified Participants and may elect to diversify a portion of their account. In each of the first 5 years upon becoming a Qualified Participant, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year and each year thereafter, the percentage increases to 50 percent.

VOTING RIGHTS

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account, including fractional shares, and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

PUT OPTION

Under Federal income tax requirements, the Plan contains a put option that is exercisable by participants in situations where Company stock is no longer traded on an established securities market. Specifically, the put option is a right of the participants to require that the Company buy any shares of its stock distributed to participants when there is no market for the trading of such shares. The price paid in the event the put option is exercised shall be representative of the fair market value of such stock. If the distribution is a total distribution of the participant's account, payment shall be made in substantially equal annual payments, including interest, over a period beginning not later than 30 days after the exercise of the put option and not exceeding five years. If the distribution is not a total distribution, payment shall be made no later than 30 days after the participant exercises the put option.

FORFEITURES

Any portion of the final balance in a participant's account which is not vested will become a forfeiture as of the earlier of distribution of the entire vested account balance or the date the participant incurs five consecutive breaks in service after termination of employment. Non-vested participants are deemed to have received a distribution of their vested account the year following termination of employment.

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year, as defined by the Plan. During the year ended December 31, 2024, forfeitures of terminated non-vested account balances totaled approximately 1,195 shares of Southside Bancshares, Inc. common stock. All forfeitures plus earnings thereon were reallocated to remaining participants. There were no unallocated forfeitures as of December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES - CONTINUED

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are valued and reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

PAYMENT OF BENEFITS

Benefit payments are recorded when paid.

OPERATING EXPENSES

The Company and the Plan participants share in the Plan expenses. Plan expenses related to participant distributions and similar service fees are deducted from the participants' accounts and reported as administrative expenses on the statement of changes in net assets.

The Company, at its sole discretion, may pay the other administrative expenses of the Plan. If such expenses are not paid by the Company, they are paid out of Plan assets.

SUBSEQUENT EVENTS

Plan Management has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation method include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Common stock: Valued at closing prices reported on the nationally recognized securities exchanges on which the security is traded. This investment is classified as a Level 1 investment.

NOTE 5 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of shares of the Company's common stock, are held by the custodian and third party administrator of the Plan. Company contributions are held and managed by the custodian, which invests cash received and dividend income, makes distributions to participants and performs other custodial duties. The custodian also provides certain administrative and support services for the Plan, such as preparing the Form 5500, maintaining participant account records, preparing participant statements and processing transactions.

Officers or employees of the Company perform certain other administrative functions. No officer or employee receives compensation from the Plan. All administrative expenses of maintaining the Plan were paid by the Company.

NOTE 6 - TAX STATUS

The Internal Revenue Service (IRS) has previously determined and informed the Company that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the accounts of all participants affected will become fully vested and the assets remaining shall be distributed to the participants, former participants, and beneficiaries in proportion to their respective account balances.

NOTE 8 - RISK AND UNCERTAINTIES

The Plan invests principally in common stock of its sponsor, Southside Bancshares, Inc. Investments in general are exposed to various risks such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with the investment in common stock, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary to the Plan, any party rendering services to the Plan, the employer and certain others. As such, investments in Company common stock are related party and party-in-interest transactions. At December 31, 2024 and 2023, the Plan's assets include 352,473 and 366,791 shares, respectively, of Southside Bancshares, Inc. common stock valued at \$11,194,536 and \$11,487,887, respectively. Contributions receivable at December 31, 2024 and 2023 totaled \$1,000,000 and \$500,000, respectively. All such receivables are employer contributions due from the Company and, as such, are considered party-in-interest transactions.

The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
