Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nevada H.A.N.D., Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nevada H.A.N.D., Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Responsibilities of Management for the Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following description of the Nevada H.A.N.D., Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan under Section 401(k) of the Internal Revenue Code, which covers all employees of Nevada H.A.N.D., Inc., and the following related companies under common control: H.A.N.D. Property Management Company, H.A.N.D. Construction Company, and H.A.N.D. Senior Living Company (collectively referred to as the Company). The Plan was established on April 1, 2003 by Nevada H.A.N.D., Inc. and covers all employees who are at least 21 years of age, have completed at least one year of service, and have worked at least 1,000 hours during a 12-month period. Members of a collective bargaining unit where retirement benefits were the subject of good faith bargaining and non-resident aliens are excluded from Plan participation. Certain employees of the Company serve as Plan trustees. A Trustee Committee manages the operation and administration of the Plan, including the appropriateness of the Plan's investment offerings and investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Setting Every Community Up for Retirement Act 2.0 of 2022 (SECURE Act) Provisions

The Plan has implemented certain directives, where applicable, of the SECURE Act, which contain several provisions affecting retirement plans in the areas of distributions and loans. During the year ended December 31, 2024, the Plan implemented provisions related the involuntary distributions to terminated employees. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and Internal Revenue Service guidance.

Contributions

Each year, participants may contribute up to 100% of their eligible pre-tax annual compensation, as defined in the Plan agreement, not to exceed the maximum allowed by law. Participants who are age 50 or older can elect to make catch-up contributions to the Plan, not to exceed the maximum allowed by law. Roth elective deferral contributions are allowed under the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an automatic enrollment arrangement of 6% for all eligible participants. At the first day of each Plan year after the participant has contributions made pursuant to the automatic enrollment default election, the deferral will increase by 1% up to a maximum of 10%.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

The Company is allowed to make safe-harbor matching contributions and additional discretionary contributions under the Plan subject to certain eligibility requirements. For the year ended December 31, 2024, the Company made a safe-harbor contribution of 100% of the participant's elective deferral that did not exceed 3% of compensation, plus 50% of the participant's elective deferral that exceeded 3% of compensation but did not exceed 5% of compensation. The Company's contribution was \$536,924 for 2024. There was no additional employer discretionary matching contribution made for 2024.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions among investment choices in increments of 1%.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe-harbor contribution, an allocation of the discretionary employer contribution (if any), Plan earnings and losses, and charged with administrative expenses directly related to the participant's account. Allocations of the discretionary employer matching contribution are based on participant compensation. Allocations of Plan earnings and losses are based on participant investment choices and account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Certain investment and fund fees are charged to the funds and are included in Plan investment income and losses and charged to participant accounts. Participants should refer to the funds' prospectuses for further information on these fees.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the balance in the participant's account is paid to the participant or their beneficiary in a lump sum. The Plan does not allow in-service distributions. However, participants may be eligible to receive distributions from their elective salary deferrals in the case of financial hardship. The Plan allows for automatic cash-out of terminated participant balances up to and including \$5,000.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A participant may only have two loans outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. The notes must be repaid within a five-year period unless they are used for the purchase of a principal residence in which case the maximum repayment period may be longer.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their own contributions, rollover and safe-harbor amounts plus actual earnings thereon. Vesting in the discretionary matching contributions is based on years of credited service at a rate of 20% after two years, increasing 20% each year thereafter and becoming fully vested after six years. Participants become fully vested in the event of death, disability, normal retirement age, or Plan termination.

Forfeited Accounts

Forfeited non-vested accounts may be used to reduce Plan expenses or employer contributions. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$0.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value – see Note 6). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions

The Company's matching contributions are accrued in the period to which they relate.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3. INFORMATION CERTIFIED BY CUSTODIANS

The Plan administrator elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company.

NOTE 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5. NET ASSETS AVAILABLE FOR PLAN BENEFITS

As of December 31, 2024, there were no outstanding amounts to be paid from net assets available for plan benefits to withdrawing participants.

NOTE 6. GUARANTEED INVESTMENT CONTRACTS

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Trust Company (Principal), totaling \$413,507 and \$619,202, at December 31, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with a fixed rate of interest and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than a guaranteed minimum interest rate which is calculated as designated in the contract and ranges from 1% to 3% depending on the maturity of the guarantee. The crediting interest rate is decreased by the rate level service fee, as agreed to in the contract, to obtain the actual earned crediting rates for each Plan participant. The crediting interest rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events as specified in the contract might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents including complete or partial Plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events may allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

Pooled separate accounts: Valued at the NAV of shares held by the Plan at year end. The NAV is based on the market value of the pooled separate accounts' underlying investments. The NAV of the pooled separate accounts are not publicly quoted but are available to current investors. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date.

NOTE 7. FAIR VALUE MEASUREMENTS (CONTINUED)

Collective investment trusts: Valued at the NAV of shares held by the Plan at year end. The NAV is based on the market value of the collective investment trusts' underlying investments. The NAV of the collective investment trusts are not publicly quoted but are available to current investors. The NAV is the basis for current transactions and the collective investment trust can be redeemed at NAV as of the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value required to be categorized as of December 31, 2024. The Plan also invests in a guaranteed investment contract that is valued at contract value. This fund is not categorized within the fair value hierarchy.

NOTE 8. PARTY-IN-INTEREST

The Plan invests in funds managed by the Principal Life Insurance Company and Principal Trust Company. These investments represent party-in-interest transactions (as defined by the Department of Labor Rules and Regulations). The Plan paid administrative expenses of \$74,790 to Principal Life Insurance Company and Principal Trust Company for the year ended December 31, 2024.

NOTE 9. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 10. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 11. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan implemented Section 109 of the SECURE Act. This provision permits higher catch-up contribution amounts (super catch-up contributions) for participants aged 60 to 63 in the taxable year, starting in 2025. The 2025 IRS limit for super catch-up contributions is \$11,250, while the standard catch-up limit is \$7,500.

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.
