Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of McCown Gordon Construction, L.L.C. Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis For Opinion

1. Description Of The Plan

The following description of McCown Gordon Construction, L.L.C. Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2002, covering eligible employees of McCown Gordon Construction, L.L.C. (the Company), as defined in the Plan Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Full-time employees or part-time employees who are age 21 or older are eligible to participate in the Plan on the first day of the month following their date of hire.

Contributions

Eligible employees may elect to make salary deferral contributions of up to 100% of their annual eligible compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows participants to make Roth elective contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan includes 401(k) safe harbor provisions. Under these provisions, the Company makes required matching contributions equal to 100% of the first 3% of compensation, plus 50% of the next 2% of compensation deferred by each participant. Effective January 1, 2024, an amendment to the Plan modified the employer match to 100% of the first 4% of eligible compensation.

The Company may also elect to make discretionary profit sharing contributions, which are allocated based on eligible compensation, as defined in the Plan Agreement. The Company did not make a discretionary profit sharing contribution for the Plan years ended December 31, 2024 or 2023.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, allocation of Plan earnings, the Company's safe harbor matching contribution, and the Company's discretionary profit sharing contributions. Participant accounts are charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may self-direct their contributions and Company contributions in various investment options as made available and determined by the Plan Administrator. Participants may change their investment options at any time.

Vesting

Participants are immediately 100% vested in their contributions and the Company safe harbor matching contributions. Vesting in the profit sharing discretionary contributions plus earnings thereon is based on years of service. A year of service is defined as over 1,000 hours of service, while being employed for the entire Plan year. The graded vesting schedule is as follows:

A participant also becomes fully vested upon death, disability or termination after age 65.

Forfeitures

Nonvested portions of a participant's Company profit sharing contribution account are forfeited by the participant upon termination of employment prior to reaching normal retirement age and are used to cover Plan administrative expenses or reduce the Company's contributions during the year in which the forfeiture occurred. There were no forfeitures utilized to reduce Company contributions for the Plan year ended December 31, 2023. For the year ended December 31, 2024, \$5,089 of forfeitures were used to reduce Company contributions. The Plan did not use any forfeitures to pay administrative fees in 2024 or 2023. At December 31, 2024 and 2023, the Plan did not have any forfeited non-vested accounts.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to one outstanding loan at a time. The loans are secured by the vested balance in the participant's account and bear interest determined by the Plan Administrator. The loans are payable over one to five years except for loans for the purchase of a principal residence, which may be longer. Participant loans are due on various dates through December 2029 and bear interest at rates ranging from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions.

Payment Of Benefits

Upon termination of service, a participant may elect to receive their vested benefit. Benefits are made in a lump-sum amount.

In-Service Withdrawals

A participant may make an in-service withdrawal from his or her vested account balance at age 59 1/2 or later.

A participant may withdraw from the Plan that portion of his or her account resulting from elective deferral contributions subject to certain hardship withdrawal provisions.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

Interest income is recognized as earned. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution in accordance with the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Principal Life Insurance Company and Principal Trust Company (collectively, Principal), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal that the information provided to the Plan Administrator related to the following information is complete and accurate to the best of their knowledge and belief.

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts

Valued at the unit value or NAV of shares held by the Plan at year-end. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. All of the Plan's common/collective trusts may be redeemed between 1 and 30 days, and file an annual report on Form 5500 as a direct filing entity. There are no capital commitments related to any of the Plan's common/collective trusts.

Pooled Separate Accounts

Valued at the NAV of units held by the Plan at year end. The NAV as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. All pooled separate accounts have daily redemption frequencies at NAV with no redemption notice periods, and file an annual report on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's pooled separate accounts.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Income Tax Status

The Plan utilizes a pre-approved document for saving plans sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an updated opinion letter from the IRS dated June 30, 2022. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

7. Transactions With Party In Interest

Certain Plan investments are units of pooled separate accounts and common/collective trusts managed by Principal or an affiliate of Principal. Principal is the record keeper for the Plan, and therefore, these transactions qualify as party in interest transactions allowable under ERISA.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions.

8. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
