Note 1. Description of the Plan

The following description of the Industrial Dielectrics, Inc. 401(k) Profit Sharing and Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Industrial Dielectrics, Inc. (Company) for the benefits of its employees who have at least one year of service and are age 21 or older and are not Puerto Rico location employees. Employees of the Collective Bargaining Agreement of the International Union, United Automobile, Aerospace and Agricultural Implement Workers of America Local No. 1571 are eligible to participate in the Plan. Related employers who also participate in the Plan are Industrial Laminates/Norplex, Inc. (Norplex), Industrial Dielectrics Holdings, Inc., and Montana Advanced Composites, Inc. (fka Norplex Advanced Composites, Inc.), collectively (Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company (Principal) serves as the plan trustee and Principal Life Insurance Company serves as the plan custodian.

Effective October 31, 2024, Norplex was sold by the Company, but Norplex employees continued to participate in the Plan. The Plan was amended to become a multiple employer plan to include Norplex as a participating employer due to the change in ownership of Norplex. See Note 7 for subsequent events which occurred with Norplex employee accounts.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions up to the maximum allowed by law. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes qualified safe harbor matching contributions of 100% of elective deferral contributions, which are not over 3% of eligible compensation, plus 50% of elective deferral contributions, which are over 3% but are not over 5% of eligible compensation to all employees. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The deferral election percentage will increase 1% annually each January 1st to a maximum of 10% of eligible compensation.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their entire account balance, which includes participant and Company contributions and earnings thereon.

Payment of Benefits

Upon termination of service, an employee may elect to receive either a lump-sum amount equal to the value of his account or a joint or survivor annuity. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Puerto Rico location participants, who have maintained an account balance, are not eligible for this loan provision. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Pooled separate accounts are valued at estimated fair value as provided by Principal utilizing quoted market prices of the underlying mutual funds on the last business day of the plan year. There are no redemption restrictions, redemptions are daily and there are no unfunded commitments.

The Plan's interest in the collective investment trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end, which is valued at NAV. The investment objective of this fund is seeking principal preservation and a conservative consistent return. This fund seeks this objective by investing in synthetic guaranteed investment contracts. There are no redemption restrictions, redemptions are daily and there are no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal Life Insurance Company. The nonstandardized prototype document has received a favorable opinion letter from the Internal Revenue Service (IRS), therefore, the Plan has not been submitted to the IRS for an individual determination letter. The prototype has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. There are no Level 2 investments held by the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3. There are no Level 3 investments held by the Plan.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the plan trustee. The Plan paid \$108,073 and \$96,740 of recordkeeping fees to Principal during 2024 and 2023. The Plan has an ERISA Budget Account whereas quarterly credits are received and are used to pay investment advisory fees to Northwestern Mutual. Total credits and fees paid during 2024 and 2023 were \$78,988 and \$73,560, respectively.

The Company provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7. Reconciliation of Financial Statements to Form 5500

The net assets available for benefits per the financial statements are higher than the Form 5500 at December 31, 2024, by \$297,692. The Form 5500 reflects a notes receivable from participants transfer out of the Plan for a total of \$297,692, while the financial statements reflect the notes receivable from participants of \$297,692 as an asset at December 31, 2024.

Note 8. Subsequent Events

On January 8, 2025, all accounts of participants employed by Norplex, totaling approximately \$24,819,000 and 140 accounts, were transferred out of the Plan to the Industrial Laminates/Norplex 401(k) Plan. There was no blackout as part of this transfer due to the assets being transferred to another Principal sponsored 401(k) plan. Effective March 15, 2025, the Plan was amended to be a single employer plan again.

Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued.
