## INDEPENDENT AUDITORS' REPORT

### Notes to Financial Statements

#### (1) Description of Plan

The following description of the Harry Winston, Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document or a summary plan description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

##### **General**

The Plan was established effective January 1, 1985, and is a defined contribution plan with a tax deferred savings feature covering substantially all full-time employees of Harry Winston, Inc. (the “Company”), excluding leased employees, contractors, and non-resident aliens. Part-time, seasonal, or temporary employees who are credited with at least 1,000 hours of service during a consecutive 12-month period will also be eligible to participate in the Plan. An eligible employee of the Company who has attained age 21 can enter the Plan immediately following the day he/she has satisfied the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

##### **Contributions**

Each year, participants may contribute between 2% and 90% of pretax annual compensation, as defined in the plan document, up to an annual maximum as determined by the Internal Revenue Service (“IRS”). In addition, the Plan allows participants to make Roth 401(k) deferrals. Participants over the age of 50 can also contribute catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their accounts into various investment options offered by the Plan. The investment options available to plan participants include a variety of mutual funds, a money market fund and a stable value collective trust fund. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may elect to change the percentage invested in each fund with respect to their accounts on a daily basis.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with the deferral rate set at 6% of eligible compensation, unless they affirmatively elect not to participate in the Plan or elect a different percentage within 30 days of becoming eligible. Automatically enrolled participants’ contributions are invested in a designated age-appropriate target retirement fund until changed by the participant. The initial percentage of the automatic elective deferral will be increased automatically on January 1<sup>st</sup> of each year, by 1% up to a maximum of 10% of eligible compensation.

The Company’s matching contributions are 100% of the first 6% of base compensation that a participant contributes to the Plan. Company contributions made to an employee’s account relating to a calendar year will be made in a lump sum at the end of each January following a calendar year in which the employee has worked at least 1,000 hours and is employed on the December 31 immediately preceding the contribution.

### Notes to Financial Statements

#### (1) Description of Plan (Continued)

##### Contributions (Continued)

The Company may make a discretionary profit-sharing contribution to the Plan. An employee who has completed one year of service and has attained age 21 is eligible to share in the allocation of employer profit-sharing contributions. The Plan allows participants who are not actively employed at the end of the plan year to share in the employer profit-sharing contributions for the plan year. For the year ended December 31, 2024, no profit-sharing contributions were made to the Plan.

##### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, plan earnings, and an allocation of discretionary contributions, and charged with an allocation of administrative expenses. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are 100% vested after two years of credited service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range up to 5 years, or up to 30 years for the purchase of a primary residence. Interest on notes is charged at the prime rate on the date that the note is requested, plus 1%. The notes are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. All notes must be repaid by the participants upon termination.

##### Payment of Benefits

A participant who ceases to be an employee due to death or total and permanent disability shall be 100% vested in his or her account. On termination of service for any other reason, a participant shall receive the value of his or her vested interest. If the participant's vested interest is \$5,000 or less, benefit payments will be paid as a lump-sum distribution. If the participant's vested interest is greater than \$5,000, benefit payments may be paid as a lump-sum distribution, in substantially equal installments, or as partial withdrawals of vested accounts.

##### Forfeited Accounts

Forfeitures may be used to pay administrative expenses or used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts were \$222,424 and \$143,918, respectively. Also, for the year ended December 31, 2024, employer contributions and the related receivables were reduced by \$150,000 from forfeited nonvested accounts.

#### **(2) Summary of Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan have been prepared using the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

##### **Contributions**

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

#### (3) Information Prepared and Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company ("Vanguard"), the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest income and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### (4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described below:

- **Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- **Level 2** - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

#### (4) Fair Value Measurements (Continued)

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the collective trust maintained by the trust company. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Additionally, there are no unfunded commitments.

#### (5) Related Party Transactions

Certain plan investments are shares of mutual funds or units of a stable value collective trust fund managed by Vanguard, the trustee and recordkeeper, and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings thereon.

#### **(8) Tax Status**

The IRS has determined and informed the prototype plan sponsor by a determination letter dated June 30, 2020 that the prototype plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and has been operating in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **(9) Concentrations, Risks, and Uncertainties**

The Plan invests in various types of investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan’s exposure to a concentration of credit and market risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into various financial instruments.

At December 31, 2024 and 2023, approximately 19.2% of the Plan’s investments were invested in Vanguard Institutional Index Fund Inst’l Shares fund.

#### **(10) Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
