To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Virginia Tire & Auto 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Virginia Tire & Auto 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

Basis for Opinion

Note 1. Description of the Plan

The following description of the Virginia Tire & Auto 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1996, as a defined contribution plan covering all full-time employees of M.S.S., Inc., d/b/a Virginia Tire & Auto (the Company or Plan Sponsor) and affiliated controlled group members, as defined in the Plan document, with the exception of any non-resident aliens and union employees. Eligible employees may enter the Plan on the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's review committee is responsible for oversight of the Plan. The review committee determines the appropriateness of the Plan's investment offerings and monitors investment and overall Plan performance.

Effective March 2020, M.S.S., Inc., converted to a Virginia limited liability company and changed its name to VTA, LLC. VTA, LLC includes all the locations of M.S.S., Inc. In addition, Virginia Tire & Auto of Cascades, LLC, Virginia Tire & Auto of Ashburn/Dulles, LLC, and Virginia Tire & Auto of South Riding LLC became wholly-owned subsidiaries of VTA, LLC.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, which became effective in 2023, 2024 and beyond.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limit as allowed by the Internal Revenue Code (IRC) (\$23,000 for 2024 and \$22,500 for 2023).

Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who are age 50 or older may make additional catch-up contributions up to the maximum amount allowed (\$7,500 for both 2024 and 2023). Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

The Plan adopted an auto-enrollment provision, effective as of May 22, 2023, whereby all newly eligible and rehired employees are automatically enrolled in the Plan at a rate of 2% of eligible compensation, unless they affirmatively elect not to participate in the Plan or elect a different rate.

The Plan allows for the Company to make discretionary matching and profit-sharing contributions, to be determined by the Company for each plan year. Matching contributions, if any, are determined based on a discretionary percentage of participant elective deferrals. Profit-sharing contributions, if any, are determined at the discretion of the Company. The profit-sharing portion attributed to each eligible profit-sharing participant would be calculated as the lump sum discretionary profit-sharing contribution made by the Company multiplied by the participant's percentage of eligible compensation relative to eligible compensation of all eligible employees for the plan year. There was no employer matching or profit-sharing contribution for the plan years ended December 31, 2024 or 2023, nor have there been any such contributions since inception of the Plan.

Note 1. Description of the Plan (Concluded)

Participant Accounts

Each participant's account is credited with the participant's elective deferral contributions, discretionary employer contributions, if any, and credited or debited with investment earnings or losses (as applicable) and administrative expenses, if any. Participants direct the investment of all contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive a partial withdrawal, distribution in substantially equal installments, or a lump-sum distribution equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted if the participant has attained age 59½. In addition, the Plan allows for hardship distributions if certain criteria are met. Terminated participants with less than \$5,000 in their account may be subject to the automatic distribution provisions of the plan document.

Vesting

Participants are fully vested in their elective deferral accounts at all times. Employer matching and profit-sharing contributions, if any, vest according to the following schedule, based on the participant's years of service:

Forfeitures

The Plan provides that forfeitures may be used to reduce employer contributions or to pay plan administrative expenses. The Plan generally does not have forfeitures as no employer matching or profit-sharing contributions have been made since the inception of the Plan. However, distribution checks which are not cashed within a year after issuance, and other corrections may result in forfeited amounts. The balance in the forfeiture account at December 31, 2024 and 2023 was \$6,031 and \$1,961, respectively.

Administrative Costs

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are presented on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments included in the accompanying Statements of Changes in Net Assets Available for Benefits includes realized gains and losses from the sale of investments, and unrealized appreciation and depreciation in fair value of investments. Net unrealized appreciation and depreciation in the fair value of investments represents the net change in the fair value of the investments held during the period.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid. There were no significant benefits payable to terminated participants who have withdrawn from the Plan as of December 31, 2024 or 2023.

Note 3. Information Certified by Trustee/Custodian, Unaudited

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan trustee, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement* (ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Common/Collective Trusts (CCT) - Valued at the Net Asset Value (NAV) of the underlying investments as determined by Fidelity or the CCT's vendor/pricing agent.

Mutual Funds - Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

The Plan Sponsor is responsible for the determination of fair value. Accordingly, the Plan Sponsor performs periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the Plan Sponsor has not historically adjusted the prices obtained from the pricing services. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party and Party-In-Interest Transactions

Certain transactions that are considered to be exempt party-in-interest transactions relate to normal management and administrative services, and the payment of expenses related thereto. Certain Plan investments are managed by Fidelity, the trustee of the Plan, and a party-in-interest to the Plan. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as such fees are deducted from investment earnings, rather than a direct payment from the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA.

Note 7. Tax Status

Effective as of January 19, 2022, the Plan adopted a Fidelity pre-approved defined contribution plan document and adoption agreement. The pre-approved plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan sponsor has analyzed the tax positions taken by the Plan and is not aware of any uncertain tax positions that would require an adjustment to taxable income or disclosure in the financial statements as of December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions, however, there is no audit in progress for any tax period.

Note 8. Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks, including, but not limited to, interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Note 9. Subsequent Events

The Plan evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued. Other than the following, the Plan is not aware of any other subsequent event which would require recognition or disclosure in the financial statements.

Effective as of February 1, 2025, the eligibility service requirement for both matching employer contributions and nonelective employer contributions was changed to six months.

Also effective as of February 1, 2025, the vesting schedule for both matching employer contributions and nonelective employer contributions was revised as follows:
