Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. DESCRIPTION OF PLAN

The following description of Orthotic Holdings, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution 401(k) plan covering eligible employees of Orthotic Holdings, Inc. (the Plan Sponsor), as defined in the plan document. The Plan Administrator and Trustees are responsible for the oversight of the Plan, the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

All employees, except collectively bargained employees and non-resident aliens, are eligible to participate in the Plan and receive the Plan Sponsor's safe harbor matching, discretionary matching, and discretionary non-elective contributions upon completing 60 days of service and attaining the age of 18.

c. Contributions

Each year, eligible participants may contribute a percentage up to 100% of pre-tax and post-tax (Roth) annual compensation subject to Internal Revenue Service (IRS) limitations as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct investment of their contributions into various investment options offered by the Plan. Upon meeting the eligibility requirements of the Plan, all eligible employees are automatically enrolled in the Plan with a pre-tax deferral rate of 3%. Employees may change their deferral rate or opt-out of the Plan at any time.

The Plan provides for safe harbor matching contributions equal to 100% of each participant's contributions up to 3% of compensation, plus 50% of each participant's contributions up to the next 2% of the participant's compensation. The Plan Sponsor made safe harbor matching contributions of \$307,546 for the year ended December 31, 2024. The Plan also provides for discretionary matching and discretionary non-elective contributions in an amount determined by the Plan Sponsor to be made at the end of the plan year. There were no discretionary matching or discretionary non-elective contributions for the year ended December 31, 2024.

d. Participant Accounts

Each participant's account is credited with the participant's and Plan Sponsor's contributions and an allocation of plan earnings, and charged with an allocation of administrative expenses paid by the Plan, if any. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their voluntary contributions, safe harbor matching contributions, plus actual earnings thereon. Participants vest in the value of their accounts attributable to the Plan Sponsor's discretionary matching contributions as follows:

<u>Years of Credited Service</u>	<u>Vesting Percentage</u>
One year of service or less	0%
Two years of service	20%
Three years of service	40%
Four years of service	60%
Five years of service	80%
Six years of service or more	100%

Participants vest in the value of their accounts attributable to the Plan Sponsor's discretionary non-elective contributions as follows:

<u>Years of Credited Service</u>	<u>Vesting Percentage</u>
One year of service or less	20%
Two years of service	40%
Three years of service	60%
Four years of service	80%
Five years of service or more	100%

A participant must render 1,000 hours of service during the plan year to gain a year of credited service. Participants become fully vested in the Plan Sponsor's discretionary matching and discretionary non-elective contributions upon death or disability.

f. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half their vested account balance. The loans are secured by the balance in the participant's account. Participants may have one loan outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case is up to twenty years. The loans bear interest at a rate equal to the prime rate plus 1.5% at time of issuance. Principal and interest are paid ratably through payroll deductions.

g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 59 ½, with no option for early retirement. There are also retirement benefits available upon late retirement, disability or death. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account, partial payment of their account or installment payments. The Plan has an involuntary cash-out distribution provision for all account balances under \$5,000 and requires balances from \$1,000 to \$5,000 be rolled over to an Individual Retirement Account (IRA). Effective January 1, 2024, the involuntary cash-out was increased to \$7,000 in accordance with SECURE Act 2.0.

g. Payment of Benefits (Continued)

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a “hardship.” Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

h. Forfeitures

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to pay administrative expenses or to reduce future Plan Sponsor contributions. The Plan Sponsor used \$9,605 of forfeitures to offset safe harbor matching contributions during 2024. As of December 31, 2024, there were no unallocated forfeitures. There were \$608 in unallocated forfeitures as of December 31, 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There are \$9,498 of defaulted loans included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

Contributions

Contributions from plan participants, safe harbor and discretionary matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. Discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to participant's accounts and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of investments.

Subsequent Events

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), a qualified institution, has certified to the completeness and accuracy of all investments reported in accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled separate accounts: The fair value of accumulation units held by the Plan in pooled separate accounts is based on each account's daily net asset value (NAV) as a practical expedient, which is considered by the Plan's management to be the best approximation of fair value. The NAV is used as a practical expedient to estimate fair value, unless it is probable that all or a portion of the accounts will be sold for an amount different from NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the accounts at amounts different from NAV. Separate accounts are not exchange traded. Data for NAV is available daily to the Plan Administrator and client investors via the Voya website, and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. Redemption frequency and notice period are available on a daily basis. There are no unfunded commitments from participants in the Plan who invest in these accounts.

There has been no change in methodology used at December 31, 2024 and 2023.

4. FAIR VALUE MEASUREMENT (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments in pooled separate accounts that are measured at fair values using the NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. Accordingly, the pooled separate accounts have not been classified in the fair value hierarchy as of December 31, 2024 and 2023.

The following table presents the category, fair value, redemption frequency, and redemption notice period for the Plan's pooled separate accounts, the fair values of which are estimated using the NAV per share as of December 31:

4. FAIR VALUE MEASUREMENT (Continued)

(f) This fund seeks capital appreciation and invests in small capitalization companies defined as companies that are included in the Small Cap Index at the time of purchase.

5. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions' however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution, expenses paid to the Plan's third-party administrator out of plan assets, and notes receivable from participants are considered party-in-interest transactions. There were \$4,800 of administrative expenses paid to the qualified institution by the Plan for the year ended December 31, 2024.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect participant account balances, and the amounts reported in the accompanying statements of net assets available for benefits.
