Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Range Bank 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Range Bank 401(k) Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

1. Description of Plan

The following description of the Range Bank 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution plan with a 401(k) elective deferral arrangement, which covers substantially all employees of Range Bank (Employer) who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is overseen by the HR/Compensation Committee of the Board of the Directors. The Plan was amended effective January 1, 2024 and 2025, with revisions to the Plan provisions, as indicated below.

Eligibility

Employees that are age 21 and over are eligible to participate in the Plan who have at least one hour of service in the first one month of employment. Union employees, non-resident aliens who do not receive any compensation from U.S. sources, and temporary employees are excluded from the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless the employee affirmatively elects not to participate, with a default deferral rate set at 3% of eligible compensation in the first year, increasing by 1% annually up to a maximum rate of 6%.

Contributions

Each year, participants may elect to contribute up to 100% of their compensation, not to exceed the maximum contribution allowable by the Internal Revenue Code (IRC) adjusted annually for the cost-of-living changes. There is no minimum elective deferral for the Plan. Rollover contributions are allowable by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. The Plan also allows Roth deferrals.

Effective January 1, 2024, the Employer contributed safe harbor matching contributions of the first 3% of the participant's compensation, plus 50% of deferrals over 3%, not to exceed 5% of the participant's compensation. Prior to January 1, 2024, the Employer contributed safe harbor matching contributions of 100% of employee deferrals, up to 6% of the participant's compensation. Effective January 1, 2025, the Employer will contribute safe harbor matching contributions of 100% of employee deferrals, up to 6% of the participant's compensation. Participants are eligible for the Employer's safe harbor matching contribution and discretionary matching and nonelective contributions after one year of service.

Contributions (continued)

The Employer may make discretionary matching and nonelective contributions to the Plan. The Employer made no discretionary matching or nonelective contributions in 2024 or 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options and transfer between funds as desired.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and allocations of the Plan earnings. Allocations are based on the participant's account balances. There may be fees or expenses allocated to participant accounts, which are generally allocated either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. Fees related to the processing of distributions will be directly charged to the participant.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and the Employer's safe harbor matching contributions, plus actual earnings thereon. Participants are vested in Employer discretionary matching contributions and nonelective contributions at 25% for each year of service with 100% vesting after four years of service.

Payment of Benefits

Plan participants are eligible to receive distributions upon reaching retirement age of 65 or in-service distributions at age 59 ½. Hardship withdrawals are allowed to pay certain qualifying expenses as defined in the Plan document. In addition, upon separation of employment, because of death, disability, or for other reasons, participants receive their benefits as a lump sum, partial lump sum, or installment payments. If the participant's vested account balance is greater than \$5,000 at termination, the participant may request a lump sum, partial lump sum, or installment payments. If the participant's vested account balance is less than \$5,000, a lump sum distribution in the amount of their entire vested account balance will be made to the participant.

Forfeited Accounts

Forfeitures of the non-vested employer contributions of terminated participants' accounts are used to reduce employer's matching contributions or reduce administrative expenses under the Plan. As of December 31, 2024, forfeited non-vested accounts total \$8,922 (\$3,950 as of December 31, 2023). Employer contributions or administrative expenses were reduced by \$0 from forfeited non-vested accounts for the years ending December 31, 2024 and 2023.

Unallocated Account

As of December 31, 2024, the unallocated account totaled \$11,134 (\$8,917 as of December 31, 2023). During 2024, administrative expenses were reduced by \$10,779 from this account (\$7,908 in 2023). This account will be used to pay future Plan administrative expenses.

Administrative Expenses

Certain administrative expenses were paid for by the Employer. Additionally, certain administrative expenses were paid by the Plan and are reflected in the accompanying financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. At termination, participant accounts would become fully vested.

Participant Loans

The Plan does not permit participant loans.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Subsequent Events

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value, except the guaranteed investment contract, which is valued at contract value. The pooled separate accounts are valued at fair value based on the net asset value (NAV), as reported by the trustee.

The NAV is based on the fair value of securities held by the investment. There are no unfunded commitments related to the investments. See Notes 3 and 4 for details on the guaranteed investment contract and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain amounts in 2023 have been reclassified to conform with the 2024 presentation.

3. Guaranteed Investment Contract with Voya Retirement Insurance and Annuity Company

The Plan has entered into a traditional benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (VRIAC), the Voya Fixed Income Account. The contributions to the Voya Fixed Income Account are maintained in group annuity contracts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The account is guaranteed minimum rates of interest and may credit interest that exceeds the minimum guaranteed rate. The rate is subject to change, but will never fall below the guaranteed minimum. The contract is included in the financial statements at contract value as reported to the Plan by the Trustee. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Transfers to the Voya Fixed Income Account from other funds under the contract may not exceed 20% of the value of the funds in a calendar year. Transfers from the Voya Fixed Income Account to other funds are allowed at any time if the transfer is not to a competing investment option, a transfer into a competing investment option from a non-competing investment option has not occurred within 90 days, and a partial surrender has not occurred within 90 days. VRIAC may terminate and pay out the current value under the contract to the Plan provided 90-day notice is given.

5. Income Tax Status (continued)

Although the Plan has been amended and restated since the date of the opinion letter, the Plan administrators believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income tax is included in the accompanying financial statements.

Generally, tax years 2021 through current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

6. Financial Information Certified by the Trustee – Unaudited

The Plan's financial information and data was certified by the trustee, VRIAC, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment balances, interest, dividends, and net appreciation in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by the trustee. This certified information has not been audited by independent auditors.

7. Party-in-Interest Transactions

A party-in-interest is defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, auditors, and certain others. Certain investments are managed by VRIAC (the Plan's trustee and recordkeeper), therefore, qualifying as a party-in-interest. Fees of \$15,413 were paid to VRIAC during 2024 (\$12,836 during 2023). Pension Consultants Co., Inc. and Morningstar Investment Management, LLC are also parties-in-interest as they serve as third party administrator and investment advisor to the Plan, respectively. Fees paid to mutual fund managers, the amounts of which are unknown, are netted against investment income.

8. Risk and Uncertainties

The Plan invests in various investment securities. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and long-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
