Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Metals Solutions LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Metals Solutions LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. **NOTES TO FINANCIAL STATEMENTS
FOR THE YEAR ENDED DECEMBER 31, 2024**

Note A - Plan Description

The following description of Metals Solutions LLC (Sponsor) 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan available to qualifying employees of the Sponsor and its affiliates. Employees are eligible to participate immediately upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Eligible employees may elect to contribute up to 60 percent of compensation to the Plan, subject to limits set forth by the Internal Revenue Service. An individual, who has reached age 50, may defer an additional "catch-up" contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also provides for safe harbor matching and discretionary matching contributions. For 2024, the Sponsor made a safe harbor matching contribution of up to 100% of the first 4% of base compensation. No discretionary matching contribution was made for 2024.

Participants' Accounts. Participant accounts are credited with the participant's contributions and the allocation of Employer contributions, as well as Plan earnings, and charged with an allocation of administrative expenses. Participants may direct the investment of their account balances into various investment options offered by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are always fully vested in their deferral contributions and safe harbor employer contributions. Vesting in the employer nonelective contributions is based on years of vesting service, as defined by the Plan. Employer discretionary match contributions vest 100% after three years of service.

Payment of Benefits. Upon termination of service, a participant may receive an amount equal to the vested balance in his or her account in a lump sum payment, partial withdrawals or installments. Distributions are subject to the applicable provisions of the Plan document.

Forfeitures. Forfeiture allocations may be used to offset employer contributions. As of December 31, 2024 and 2023, there were no forfeitures available to be used to reduce employer contributions.

Administrative Expenses. The Sponsor pays most of the administrative costs of the Plan associated with professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent transactional fees paid directly by participants to the recordkeeper.

Notes Receivable from Participants. Participants may borrow from their accounts up to \$50,000 or 50% of the participant's vested balance. Loan transactions are treated as receivables in the Plan's financial statements. Loans are secured by the participant's vested account; therefore no allowance for financial credit losses is recorded. The loans bear interest at the rate commensurate with local prevailing rates as determined by the company's management. Interest rates on existing loans are 5% at December 31, 2024. Principal interest rates are paid ratably through payroll deductions. Participant loans are valued at their outstanding balances.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Financial Statement Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investments and Investment Income

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. All investments in the Plan are participant directed. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Employer and employee contributions are reported in the year services are rendered to the Company by plan participants.

Payment of Benefits

Benefits are reported in the year paid.

Date of Management's Review

Management has evaluated subsequent events through October 2, 2025, the date the statements were available to be issued and noted no events occurring during such periods that would require recognition or disclosure in the financial statements.

Note C - Information Prepared and Certified by Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, OneAmerica has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate with respect to investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

- Investments at fair value
- Investments at contract value
- Interest and dividends
- Net appreciation/depreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

Note D - Fair Value Measurements

FASB ASC Section 820 - *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset, including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares in each account held by the Plan and year end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the insurance company, is used as a practical expedient to estimating fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth the Plan investment assets at fair value, as of December 31, 2024 and 2023.

(a) In accordance with the Fair Value Measurements topic, certain investments that were measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The investments in this category seek to provide long-term growth of capital, as well as substantial dividend income by investing primarily in US equity and fixed income securities. There are no unfunded commitments, redemption frequency is immediate and there is no redemption notice period.

Note E - Guaranteed Insurance Contracts

For the years ended December 31, 2024 and 2023, the Plan held an investment in the AUL Fixed Account, a fully benefit-responsive guaranteed investment contract. The Fixed Account is an insurance contract for which contract value is guaranteed for participant transactions by the full faith and credit of American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This fund meets the fully benefit-responsive investment contract criteria and, therefore, is

reported at contract value. Generally, the term “fully benefit-responsive” describes the contract’s guarantee that (1) the crediting rate provided under the contract will not fall below zero, and (2) participant-initiated withdrawals from the fund will be covered at contract value. The AUL Fixed Account is fully benefit-responsive and contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the account. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the AUL Fixed Account at December 31, 2024 and 2023, was \$1,606,108 and \$1,681,455, respectively. The crediting interest rate is set by AUL and approved by management. Such interest rates are reviewed on a quarterly basis.

Certain events may limit the Plan’s ability to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement of plan incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different than contract value. Examples of such events include the contract owner’s failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, plan disqualification, and failure to adopt the plan in a reasonable period of time. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Note F - Party-in-interest Transactions

Certain plan investments are managed by AUL, the custodian of the Plan, therefore, these transactions qualify as party-in-interest.

Note G - Plan Termination

Although it has not expressed intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

Note H - Plan Tax Status

The Plan has adopted a volume submitter document that is restated to include the latest requirements. The document was approved by the Internal Revenue Service as being designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator believes the Plan is currently operated in compliance with applicable requirements of the Code, therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained by the tax authorities. The Plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S. federal tax examinations for years before 2022.

Note I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

Note J - Reconciliation of Financial Statements to Form 5500

There were no differences between the net assets available for benefits and changes in net assets available for benefits per the financial statements and Form 5500 as of December 31, 2024 and 2023.
