#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Jas. D. Easton 401(k) / Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Notes to Financial Statements**

---

### **1. Description of the Plan**

The following description of the Jas. D. Easton 401(k) / Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document and the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan was created on August 26, 1964 and is a defined contribution 401(k) plan covering substantially all employees of Jas. D. Easton, Inc. and its affiliates (collectively, the Company, Plan Sponsor or Employer) who have at least one month of service, as defined, and are age 18 or older. The Retirement Plan Committee controls and manages the operation and administration of the Plan. Fidelity Management Trust Company is the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Eligible employees automatically become participants and are enrolled into the Plan with a 6% deferral rate, unless they elect otherwise. Participants who have not elected a specific deferral rate will have their deferral rate automatically increased 1% annually on March 1 until their deferral rate is 10%. Contributions are made to the Plan by both participants and the Employer. Participating employees may contribute up to 50% of their annual eligible compensation not to exceed the dollar limit set by the Internal Revenue Code (IRC) of \$23,000 (\$30,500 for employees who are age 50 or older) for the year ended December 31, 2024. Eligible compensation is based on IRC Section 3401(a) which defines compensation as all cash and non-cash remuneration from the Employer which excludes reimbursements, fringe benefits, moving expenses, deferred compensation, welfare benefits and differential wages. Participants may also make contributions by rollover of distributions from other qualified retirement plans. Roth contributions from participants may be made on an after-tax basis. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a matching contribution to each participant's account equal to 50% of elective employee deferrals of the first 6% of each participant's contribution. The Company may also make profit sharing contributions and qualified non-elective contributions. The Company did not make profit sharing contributions for 2024; and qualified non-elective contributions for 2024 were minimal.

#### **Participant Accounts**

Individual accounts are maintained for each participant of the plan. Each participant's account is adjusted for participant contributions, Employer's matching contributions, and an allocation of the Plan's actual earnings or losses and administrative expenses allocated to and specifically identified with the participant's investment account. Participants may direct the investment of their account balance into various investment options offered by the Plan. The benefit to which a participant is entitled is the vested balance in the participant's account.

#### **Vesting**

Participants are immediately vested in their contributions, Company qualified non-elective contributions and actual earnings thereon. Vesting in the Company matching contributions and Company profit sharing contributions is based on years of service. A participant becomes vested at 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. However, upon reaching normal retirement age or if an active participant dies or becomes permanently disabled prior to attaining normal retirement age, the participant's account becomes 100% vested.

---

### ***Payment of Benefits***

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, unless the termination is due to a committed crime, in which case, the participant's distribution would be postponed for one year. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

### ***Notes Receivable from Participants***

Participants may borrow from their Plan accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of the vested portion of their account balance, whichever is less. The loans bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Retirement Plan Committee, are typically paid off through payroll deductions, and are secured by the participant's vested account balance. The interest rates on the outstanding loans as of December 31, 2024 ranged from 4.25% to 9.50%, with maturities through September 2031.

### ***Forfeitures***

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. The Plan document permits the use of forfeitures to first be used to pay administrative expenses and then they may be used to reduce future required Employer contributions. As of December 31, 2024 and 2023, forfeited unvested accounts totaled \$38,119 and \$53,413, respectively. During 2024, there were \$125,260 forfeited by participants, investment earnings of \$5,693 and reduced employer contributions of \$146,247.

### ***Administrative Expenses***

Plan administrative expenses may be charged directly to the Plan (either allocated to the participants or using forfeiture funds) or paid by the Employer as provided in the Plan Document. The Plan Sponsor pays certain administrative costs which the Plan would otherwise have to pay, including third-party legal, auditing and accounting fees, as well as internal administrative costs. Charges for loan and benefit payment transactions, if any, are deducted from the account balances of those participants initiating the transaction. For the year ended December 31, 2024, the Plan paid \$67,766 in administrative expenses.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with US GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

---

***Risks and Uncertainties***

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit, liquidity, overall market volatility, and changes in economic conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

***Investment Valuation and Income Recognition***

The Plan's investments in mutual funds, U.S. government securities, and self-directed brokerage account assets are stated at fair value based on quoted market prices.

The stable value fund is stated at net asset value (NAV) per unit as a practical expedient of fair value, which is based on the fair value of the underlying net assets on the last day of the Plan year. The trustee determines unit values by dividing the net assets of the stable value fund at fair value by the number of units outstanding as of the valuation date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Dividends and interest are reinvested as earned. The net appreciation in fair value of investments, which includes realized gains (losses) and unrealized appreciation (depreciation) on those investments, is presented in the statement of changes in assets available for benefits.

***Notes Receivable from Participants***

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized over the terms of the notes at the rates specified in the loan documents. Fees related to notes receivable from participants are recorded as administrative expenses when they are incurred and reduce the accounts of the applicable participants. Delinquent participant loans are recorded as distributions when the participant has a distributable event.

***Payment of Benefits***

Benefits are recorded when paid by the Plan.

***Terminated and Defaulted Loans***

Loans are terminated when a participant withdraws from the Plan. Any unpaid loan balance is settled by reducing the amount of the participant's vested interest in the account balance upon distribution. Active participants who have loans with scheduled repayments that remain unpaid as of the last business day of the calendar quarter following the calendar quarter in which repayment was due are in default. If an active participant defaults, the entire outstanding principal and accrued interest shall be immediately due and payable. The carrying amount of the note receivable from the participant is eliminated and a benefit payment is recorded at the time the participant is deemed to have received a distribution.

***Subsequent Events***

Plan management has evaluated events occurring subsequent to year end through October 7, 2025 which is the date the financial statements were available to be issued.

### 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Financial Accounting Standards Board established a framework for measuring fair value in the form of a fair value hierarchy, which prioritizes inputs into valuation techniques used to measure fair value into three broad levels. This hierarchy requires assets to be classified by level in their entirety based upon the lowest level of input that was significant to the fair value measurement. The three levels of the fair value hierarchy are as follows:

Level 1 : Quoted prices in active markets for identical assets or liabilities.

Level 2: Observable inputs other than Level 1, including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.

Level 3: Unobservable inputs supported by little or no market data for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

#### 4. Exempt Party-In-Interest Transactions

Certain Plan investments are managed by Fidelity Investments Institutional Operations Company, Inc., which is the Plan's custodian. These transactions are considered exempt party-in-interest transactions. Fidelity Investments Institutional Operations Company, Inc. also executes transactions for the Plan's self-directed accounts which are also exempt party-in-interest transactions. Notes receivable from participants are also exempt party-in-interest transactions.

#### 5. Federal Income Tax Status

The Plan uses a prototype plan document sponsored by Fidelity Management & Research Company. Fidelity Management & Research Company received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the Internal Revenue Service. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. Plan management has analyzed the tax positions of the Plan and has concluded that as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits in tax jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

#### 6. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under that election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule of assets (held at end of year):

- All investment assets held by the Plan
- Notes receivable from participants
- The recording of transactions related to all investment assets and notes receivable from participants, including related earnings (losses) and interest and dividends.
