Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Van Horn Automotive Group 401(k) Plan as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered Van Horn Automotive Group 401(k) Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, we do not express an opinion on the effectiveness of Van Horn Automotive Group 401(k) Plan's internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis.

We are required to consider relevant plan provisions that affect the risk of material misstatement at the relevant assertion level when designing and performing audit procedures. When audit work performed results in the identification of items that are not in accordance with specified criteria, such as plan provisions as set forth in the plan instrument, we are required as the auditor to evaluate whether the matter is a reportable finding. Reportable findings are matters that are one or more of the following:

- a. An identified instance of noncompliance or suspected noncompliance with laws or regulations.
- b. A finding arising from the audit that is, in the auditor's professional judgment, significant and relevant to those charged with governance regarding their responsibility to oversee the financial reporting process.

- c. An indication of deficiencies in internal control identified during the audit that have not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention.

A reportable finding may be a material weakness, a significant deficiency, or a control deficiency defined as follows:

A material weakness is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented or detected and corrected on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible*. The chance of the future event or events occurring is more than remote but less than likely.
- *Probable*. The future event or events are likely to occur.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

A control deficiency is a deficiency, or combination of deficiencies, in internal control that does not rise to the level of a material weakness or significant deficiency but is of sufficient importance to merit management's attention.

We consider the following reportable finding in the plan's internal control to be a significant deficiency:

### **Contributions and Eligible Compensation**

During our testing, there was one participant where the employee contributions were not withheld from their final pay checks. This error could expose the Plan Sponsor to make necessary corrective actions for the plan to remain in compliance with regulations and may include corrective contributions on behalf of the participant. We recommend that you work with your third-party administrator and double check payroll procedures to ensure that the correct amounts are being deferred for each participant.

In addition, during our testing, there were three earnings pay codes incorrectly included as eligible compensation and therefore, employee contributions were withheld from these earnings. This error could expose the Plan Sponsor to make necessary corrective actions for the plan to remain in compliance with regulations and may include corrective distributions on behalf of the participants. We recommend consulting an ERISA attorney and reviewing all earnings pay codes to correctly identify the treatment for eligible compensation based on the plan documents or make amendments to the definition of eligible compensation, as needed.

We consider the following reportable findings in the plan's internal control to be control deficiencies:

### **Timeliness of Contributions**

Department of Labor Regulation 2510.3-102 requires the deposit of employee deferrals into the plan trust as soon as the contributions can reasonably be segregated from the employer's general assets, but no later than 15 business days following the month in which the deferrals were withheld from the employees. This regulation was effective February 3, 1997. The 15 days is not a safe harbor, in other words, if the Department of Labor determines that funds can reasonably be segregated from your general assets within a certain number of days after a payroll run, they will require the deposits to be made into the trust by that time. If deposits are not made within the required time, they must be reported as nonexempt transactions with parties in interest (prohibited transactions) in the audit report and on the form 5500. The plan sponsor is also required to pay an excise tax. We recommend that you review your procedures relating to depositing employee deferrals into the plan to determine if you are in compliance with the requirement to deposit the money as soon as it can be reasonably segregated from your general assets.

### **Personnel File Documentation**

During our testing of the current year information, there was one participant where the employee's personnel file was missing support for hire date and termination date. Not maintaining proper documentation may result in incorrect eligibility, incorrect vesting calculations, as well as potential questions related to gross pay. We recommend controls are put in place to retain important information within employee personnel files.

### **Timecard Approval**

During our testing, we noted that no support of supervisors' approval of employee timecards from DealerTrack were retained. The accuracy of employee timecards is significant to the Plan as hours worked by employees are a determinant of Plan compensation and, ultimately, Plan contributions. Failure to retain documentation of the review and approval of timecards may expose the Plan Sponsor to increased risk of error or fraud. We recommend management implement a process for timecard approval, including the retention of evidence of such approvals.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be considered reportable findings, including material weaknesses, significant deficiencies, or control deficiencies, and, therefore, reportable findings in these categories may exist that were not identified.
