**Note 1. Plan Description**

The following description of the MGE Underground, Inc. 401(k) Plan (the Plan) provides only general information. MGE Underground, Inc. (the Company) is the Plan sponsor. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan covering all employees of the Company who are age 18, have met the service requirement of 6 consecutive full calendar months of employment during the which the employee is credited with at least 500 hours of service in a 6 month period from the hire date, and are not members of a collective bargaining unit or non-resident aliens. If the eligibility criteria is not met within the first 6 months of employment, employees become eligible if credited with 1,000 hours in the 12 months immediately after date of hire or any subsequent calendar year. Employees enter the Plan on the first day of the calendar month that occurs after the employee has completed the eligibility service period. In addition, long-term part time employees who do not satisfy the standard service requirements of the Plan are eligible to make employee contributions into the Plan after completing 500 hours of service during each of three consecutive years (two consecutive years starting January 1, 2025) under the long-term part time rules. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan administration:**

The Company is the Plan sponsor and Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under ERISA, including oversight of the Plan, appropriateness of investment offerings, and monitoring investment performance.

The Company contracts with Charles Schwab Bank to act as the custodian. Evolve and Hilde Minkel and Associates act as the recordkeeper and third-party administrator, respectively, to process and maintain records of participant data.

**Contributions:**

Each year, participants may contribute into the Plan a percentage of pretax annual compensation as defined in the plan document. Participants may also designate a portion or all of the deferral contributions as Roth 401(k) contributions that are includable in the participant's gross income at the time deferred. Elective contributions may not exceed the maximum deferral limit per section 402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans from pre-tax sources (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor non-elective contribution in the amount of 3% of each eligible participant's compensation during the year. For the year ended December 31, 2024, the Company made a \$580,605 safe harbor non-elective contribution to the Plan, funded annually after year-end.

The Company may, in its discretion, make employer profit sharing or matching contributions to the Plan. Discretionary employer profit sharing contributions may be allocated to participants annually. For the year ended December 31, 2024, the Company made a \$192,322 profit sharing contribution to the Plan, funded annually after year-end.

For prevailing wage employees, a prevailing wage contribution is made based on the contribution requirements of the type of work being performed. Prevailing wage contributions replace any other employer contributions that would be received under the Plan, if any. For the year ended December 31, 2024, the Company made a \$11,590 prevailing wage contribution to the Plan, funded during the year.

For the year ended December 31, 2024, the Company made a \$600 corrective contribution to the Plan, with \$345 funded before year-end and \$255 funded after year-end.

Contributions are subject to certain IRS limitations.

***Participant accounts:***

Each participant's account is credited with the participant's contributions, prevailing wage contributions, Company discretionary employer contributions, safe harbor contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting:***

Participants are vested immediately in their contributions plus actual earnings thereon. All safe harbor and prevailing wage contributions are 100% vested immediately. Vesting in the Company's discretionary matching or profit sharing contribution portion of their account balance, if any, is based on years of service, as defined in the Plan document, as follows:

***Notes receivable from participants:***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the date of the loan by the Plan administrator at a reasonable rate of interest, commensurate with local prevailing rates, which is the prime rate plus 1%. Principal and interest is paid ratably through weekly payroll deductions, or through direct payments from the participants.

***Benefit payments and withdrawals:***

On termination of service for any reason, a participant is entitled to a lump sum amount equal to the value of the participant's vested interest in his or her account. If the terminated participant's vested and non-forfeitable balance is less than \$7,000, the participant's balance may be distributed in the form of a lump sum, as a cash distribution if the balance is under \$1,000, and as a direct rollover to a default IRA if the balance is over \$1,000 but under \$7,000, without authorization from the participant. A participant may withdraw for reasons of hardship.

***Forfeited accounts:***

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. At December 31, 2024 and 2023, the forfeiture balance was \$2,878 and \$2,499, respectively. At the discretion of the Plan administrator, forfeitures may be applied to offset Plan expenses and employer contributions. During the year ended December 31, 2024, forfeitures or expense account amounts applied to reduce administrative expenses of the Plan and reduce employer contributions totaled \$65.

***Note 2. Significant Accounting Policies***

***Basis of accounting:***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of estimates:***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment valuation and income recognition:***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor's management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants:***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Excess contributions payable:***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

***Payment of benefits:***

Benefits are recorded when paid.

***Administrative expenses:***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the record-keeping services, third-party administrative services, investment advisory services are included in administrative expenses and allocated to participant accounts based on a pro rata formula. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses or as an offset to earnings. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

**Note 4. Investments and Fair Value Measurements**

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual funds (and cash equivalent)*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Note 5. Related Party and Party-in-Interest Transactions***

The Company contracts with Charles Schwab Bank to act as trustee and custodian. Evolve and Hilde Minkel and Associates act as the recordkeeper and third-party administrator, respectively, to process and maintain records of participant data. Corvus Wealth Advisors is the financial advisor for the Plan. Therefore, transactions with these entities qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Certain fees incurred by the Plan for investment services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

Notes receivable from Plan participants and related interest income are also considered party-in-interest transactions.

#### ***Note 6. Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### ***Note 7. Tax Status***

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Including any applicable amendments, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2024, and is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ***Note 8. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Note 9. Reconciliation of the Plan Financial Statements to the Form 5500***

Certain amounts included on Schedule H Part I and II on the Annual Return/Report of Employee Benefit Plans (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

There were no reconciling items between the financial statements and Form 5500 as of December 31, 2024 and 2023 in total.

***Note 10. Subsequent Events***

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
