Independent Auditor's Report

To the Plan Administrator

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Harkins Group Employees 401(k) Profit-Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). **Note 1 - Description of Plan**

The following description of The Harkins Group Employees 401(k) Profit-Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of Harkins Builders, Inc. (the "Plan Sponsor"), who have three months of full-time service and are 21 years of age or older. The Plan became effective on April 30, 1982 and was restated on November 13, 2015. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Eligible compensation of the Plan includes all wages excluding reimbursements, other allowances, fringe benefits, moving expenses, deferred compensation and any certain other exclusion as defined in the Plan document. Fidelity Management Trust Company is the Trustee of the Plan.

The Plan was amended effective January 1, 2025 to reduce the age of eligibility to 18 years old.

**Contributions**

Each year, participants may contribute up to 60% of annual compensation subject to an annual Internal Revenue Service ("IRS") limitation, as defined in the Plan, and 100% of bonuses. Participants may also contribute amounts representing catch-up contributions. All contributions are subject to annual IRS limitations. The participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants are eligible to receive a matching contribution upon completing one year of service. The Plan Sponsor matches 100% of the participant contribution up to 4% of their eligible compensation.

The Plan Sponsor may also make additional nonelective contributions. Their contributions in excess of the matching contributions, if any, are allocated first to the participants by the ratio of their compensation in excess of the taxable wage base to the total compensation in excess of the taxable wage base for all participants. Allocations to any participant are based on excess compensation limited to 5.7% of their excess compensation. Remaining contributions are allocated to participants in the proportion that their compensation bears to total compensation of all participants for the Plan year.

**Participant accounts**

Each participant's account is credited with the participant's contribution, the Plan Sponsor's matching contribution and allocations of: (a) the Plan Sponsor's profit-sharing contribution, if any; (b) Plan earnings; and (c) charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions account, employer matching contribution account, rollover account and all earnings thereon. Vesting in the nonelective employer contributions and earnings is based on the following years of service:

**Investment options**

Upon enrollment in the Plan, a participant may direct the investments of their account among any of 31 investment options.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator at the time the loan is granted. Principal and interest is paid ratably through bi-weekly and weekly payroll deductions.

**Payment of benefits**

On termination of service and in accordance with the Plan provisions, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, annual installments over a period of not more than his or her assumed life expectancy, or the purchase of a different form of annuity.

**Hardship withdrawals**

Participants are eligible to withdraw all or any part their vested account for certain hardship situations resulting from elective deferral contributions subject to the provisions set forth in the Plan and applicable federal law.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,836 and \$11,285, respectively. These accounts will be used to reduce future employer contributions. In 2024, none of the forfeited nonvested accounts were applied to employer contributions.

**Note 2 - Summary of significant accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared based on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered Investment Companies:* Shares of registered investment companies (mutual funds and money market funds) are reported at fair value based on the quoted market price of the fund, which represents the net asset value ("NAV") of the shares held by the fund at year-end.

*Common/Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 4 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 5 - Income tax status**

By opinion letter dated June 30, 2020, the IRS has determined that the nonstandardized pre-approved Plan document used by the Plan is acceptable, and therefore the form of the Plan satisfies the requirements for tax qualification on the terms set forth in the opinion letter. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Administration of plan assets**

The Plan's assets are held by the Trustee of the Plan. Contributions are held and managed by the Trustee, which invests cash received, interest and dividend income as directed by participants. The Plan administrator administers the payment of interest and principal on participant loans, which are remitted to the Plan through the Plan Sponsor.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Fees related to the refund of excess deferrals, contributions or annual additions are absorbed directly by the Plan Sponsor. Administrative expenses and trustee fees are paid by participants.

**Note 7 - Party-in-interest transactions**

Certain Plan investments were invested in funds managed by Fidelity Investments Institutional Operations Company, Inc., an affiliate of the Trustee of the Plan and recordkeeper of the Plan and therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan receives a plan servicing credit from Fidelity, which is first applied towards Plan administrative expenses, and any remaining credit is allocated to participant accounts. During the year ended December 31, 2024, a Plan servicing credit of \$24,409, net of expenses, was received and is included as other income on the statement of changes in net assets available for benefits.

**Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.
