**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Minuteman Senior Services 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Minuteman Senior Services 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **1. *Description of Plan***

The following description of the Minuteman Senior Services 403(b) Plan (the Plan) provides only general information. Participants should refer to the summary plan description or the plan document for more complete information of the Plan's provisions.

#### *General*

The Plan is a defined contribution retirement plan covering employees of Minuteman Senior Services, Inc. (the Organization). All employees are immediately eligible to participate in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization is responsible for oversight of the Plan. The Organization determines the appropriateness of the Plan's investment offerings, monitors investment results and reports to the Plan's Board of Trustees.

#### *Contributions*

Each year, participants may contribute a percentage of their annual compensation, as defined in the plan document. Participants may make pretax 403(b) contributions and post-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Plan was amended effective January 1, 2016, to allow the Organization to make discretionary contributions to the Plan. Participants are eligible to receive Organization contributions after completing one year of service. Once eligible, the participant must work 910 hours each year to qualify for Organization contributions.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, 1% above the prime interest rate as determined at the time the loan is taken from the Plan. Interest rates on outstanding loans, as of December 31, 2024 and 2023, range from 4.25% to 9.50%. Principal and interest payments are made ratably through payroll deductions.

*Vesting Provisions*

Participants are immediately vested in their contributions plus actual earnings thereon. A vested benefit cannot be taken away from participants or forfeited. Participants vest in the Organization's contributions and earnings based on years of service, with a minimum of 910 hours per year. The vesting schedule is as follows:

<i>Years of Service</i>	<i>Vesting Percentage</i>
1	33%
2	66%
3	100%

If the participant reaches the normal retirement age under the Plan, dies, or becomes disabled while still employed by the Organization, the participant will automatically become 100% vested.

*Payment of Benefits*

Participants may make either hardship or in-service withdrawals from their accounts within the Plan while still employed. Both types of withdrawals have specific limitations and conditions. Withdrawal elections may be made at any time. There is no limit on the number of hardship or in-service withdrawals a participant may make during employment with the Organization.

Upon termination of service, attainment of retirement age, disability or death, a participant may choose from the following options:

If the vested account is less than \$5,000, the participant can elect to receive a distribution in a single lump sum or rollover to an IRA or another qualified plan. If the total vested benefit is between \$1,000 and \$5,000 and the participant does not consent to a distribution of their vested account balance upon termination from the Organization, the Plan will automatically roll the vested account to an IRA. If the vested account is less than \$1,000, the account will be paid in a single lump sum to the participant, even if the participant does not consent to a distribution.

If the vested account is greater than \$5,000, the participant may choose from a lump sum payment equal to the value of the participant's vested interest in his or her account and a variety of annuity options. However, participants in the Plan prior to January 1, 2008, may elect installments as a form of distribution. If the participant is married, a spouse's consent to the election is necessary.

Distributions from a Roth account must satisfy the following two conditions in order to be deemed a qualifying distribution:

- 1) The distribution must occur after the participant has attained age 59½, unless the distribution is processed as a result of the participant's death or disability.
- 2) The participant's five-year period must have elapsed.

**2. *Significant Accounting Policies***

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. For the years ended December 31, 2024 and 2023, there were no fully benefit-responsive investment contracts.

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Payment of Benefits*

Benefits are recorded when paid.

*Investment Valuation and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Administrative Expenses*

All expenses of maintaining the Plan are paid by the Organization. Administrative expenses, which relate to the servicing of notes receivable from participants and certain investment fees, are paid via a reduction of participant account balances. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected.

**3. *Information Prepared and Certified by Custodian (Unaudited)***

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB (Nationwide), a qualified institution.

**4. *Fair Value Measurements***

The Financial Accounting Standards Board (FASB) *ASC 820, Fair Value Measurements and Disclosures* (ASC Topic 820) defines fair value as the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. ASC Topic 820 requires disclosure of the extent to which fair value is used to measure financial and non-financial assets and liabilities, the inputs utilized in calculating valuation measurements, and the effect of the measurement of significant unobservable inputs on earnings, or changes in net assets, as of the measurement date. ASC Topic 820 establishes a three-level valuation hierarchy based upon the transparency of inputs utilized in the measurement and valuation of financial assets or liabilities as of the measurement date, which are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Valued at the unit value held by the Plan at year end. The unit value includes the net asset value and any dividends and capital gains declared. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed Interest Accounts*

Valued using a market approach based on the daily interest rates published by the financial institution that holds the investment. The interest rates are reset on day one of the guaranteed period to match market rates of comparable securities with similar ratings.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

The earnings on the guaranteed interest account are included within interest and dividends on the accompanying statements of changes in net assets available for benefits. This account is measured at fair value on a recurring basis based on crediting interest rates, reset at least annually using comparable market data. The crediting interest rate used for 2024 and 2023 was 1.71% and 2.37%, respectively.

**5. *Related Party and Party-in-Interest Transactions***

Certain Plan investments are shares of mutual funds overseen by HUB Retirement and Wealth Management, the third party administrator. These funds are held by Nationwide, the custodian, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Payment of related fees is made by the Plan. Total fees paid during 2024 and 2023, amounted to \$7,391 and \$33,021, respectively.

**6. *Plan Termination***

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**7. *Tax Status***

The Plan, as a 403(b) plan, currently is not required to be submitted to the IRS for determination. The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain its tax-exempt status. The plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

**8. *Risks and Uncertainties***

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risk such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. *Delinquent Participant Contributions***

During 2024 and 2023, participant contributions and loan repayments were made through payroll withholdings according to the biweekly payroll schedule of the Organization. Remittances of these amounts were made each pay period to the Plan. For the year ended December 31, 2024, one pay period resulted in delinquent contributions totaling \$22,002. Management plans to correct the 2024 delinquent contributions during 2025, outside of the Voluntary Fiduciary Correction Program following the Department of Labor's guidelines and calculator.

**10. *Subsequent Events***

Subsequent to year-end on June 15, 2025, all assets held by Nationwide were transferred to a new custodian, Empower Annuity Insurance Company of America.

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.
