Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Indiana Beverage, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Indiana Beverage, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

The following description of Indiana Beverage, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Indiana Beverage, Inc. (Company). Employees who are eligible are those employees who have at least one year of service and are age 21 or older for all contributions. Effective February 1, 2024, the Plan was amended to allow participants to make elective deferrals when reaching 18 years of age, and entry to the plan occurs immediately upon hire. The eligibility requirements for Company contributions remained the same. Employees with the job title of "Draft Line Cleaners" are not eligible to participate in the Plan. A related employer who also participates in the Plan includes Coastal Valley Water Company, (collectively, Company). Members of Local Union No. 142 of the International Brotherhood of Teamsters and members of Teamsters Local Union No. 364 are eligible to participate. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective April 1, 2023, Empower Trust Company serves as the Plan trustee. Prior to April 1, 2023, Reliance Trust Company (Reliance Trust) served as the Plan trustee. JPMorgan Investment Holdings, LLC (J.P.Morgan) serves as the Plan's custodian and recordkeeper. Certain recordkeeping and administrative services are provided on behalf of J.P. Morgan by FASCore, LLC. FASCore, LLC is a subsidiary of Empower Annuity Insurance Company of America, which are all part of Empower Retirement Services.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make contributions of up to 80% of eligible compensation, each payroll period, up to the maximum allowed by law. Employee rollover and Roth contributions are allowed by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Company matching and profit-sharing contributions are discretionary as determined by the Company's Board of Directors annually. For 2024 and 2023, the Company made matching contributions of 25% of employees' salary deferral on the first 10% of eligible compensation calculated each payroll period. The Company made annual profit-sharing contributions of 7% of eligible compensation for all eligible employees active at December 31st, unless disabled or terminated due to early or normal retirement. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and Company's contributions plus earnings thereon. Forfeiture balance as of December 31, 2024 and 2023 totaled \$2,240 and \$14,679, respectively. The forfeiture balance was due to corrections and unclaimed benefits. Approximately \$13,500 was a reissued benefit check on February 15, 2024.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his account. Terminated participants with account balances less than \$5,000 will be automatically distributed for force-out rules provided by the Plan. In-service withdrawals are available under certain circumstances provided by the Plan.

Notes Receivable From Participants

Participant loans are not allowed by the Plan.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end, which uses NAV as the practical expedient. The investment objective is to preserve the value of money invested, perform better than the average money market fund and earn consistent, reliable returns. There are no redemption restrictions or unfunded commitments and redemption frequency is daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and custodial document sponsored by Empower Trust Company, LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document has received favorable opinion letter from the IRS. The Plan has been amended since this prototype received its favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company and Reliance Trust, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities held by the Plan include mutual funds. Where quoted market prices are not available, fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows and are classified within Level 2. There are no Level 2 securities held by the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities held by the Plan.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. The Plan paid recordkeeping fees to J.P. Morgan of \$1,669 and \$865 in 2024 and 2023, respectively. The Plan paid investment advisor fees to CAPTRUST Financial Advisors of \$36,000 during 2024 and 2023. The Company provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.
