1. Description of Plan

The following brief description of the BMS Intermediaries, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 2009. BMS Intermediaries, Inc. (the "Company"), a provider of risk management and distribution services to insurance and reinsurance companies, is the Plan Sponsor and Administrator. The trustee of the Plan is Principal Trust Company, the "Trustee". All employees, as defined in the Plan document, who have reached age twenty-one are eligible to participate in the Plan.

Contributions

The 401(k) feature allows participants to contribute a portion of their compensation to the Plan on a pretax basis. Participants may contribute up to 100% of pretax annual compensation.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make a discretionary matching contribution for eligible participants. The percentage of the match, if any, is a percentage determined by the Company and shall apply to all eligible employees for each pay period during the plan year. The Company matched 6% of eligible compensation during the year ended December 31, 2024. The Company may also make a discretionary profit sharing contribution for each plan year in an amount determined by the Company. No discretionary profit sharing contributions were made during the year ended December 31, 2024. Participant and Company matching contributions are subject to certain limitations set forth by the Internal Revenue Code ("IRC").

Participant Accounts

Each participant's account is credited with the participant's contribution, rollover contributions, and the Company's matching or discretionary contributions. Participants may direct the investment of their accounts and the contributions thereto. Earnings are allocated based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral contributions and earnings thereon. The participants' vesting in employer matching and discretionary nonelective contributions is 33.33% per year for each of the first through third years of service until fully vested. A participant's account also becomes fully vested upon reaching normal retirement age, or upon death or disability.

Forfeited Accounts

Forfeitures of matching and additional discretionary contributions are used to reduce plan expenses and discretionary contributions, respectively. The forfeiture balance was approximately \$2,000 and \$19,000 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions totaled approximately \$196,000 for the year ended December 31, 2024.

1. Description of Plan (Continued)

Notes Receivable From Participants

The Plan allows participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. Only one loan can be outstanding at a time per participant. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through regular payroll deductions.

Investment Options

Plan participants may direct their entire account balances in partial percentage increments to any of the various investment options through Principal Trust Company. Company contributions are also invested based upon participant allocation elections. Participants may change their investment options on a daily basis.

Payment of Benefits

Benefits may be withdrawn from the Plan upon termination of employment, retirement, death, or disability. A participant may elect to receive either a lump-sum amount equal to the value of the vested balance in their account or annual or more frequent installments over a period not to exceed the participant's life expectancy or the joint and last survivor life expectancy of the participant and their designated beneficiary. Benefits may also be withdrawn upon attaining the age of 59½ or incurring a qualified financial hardship. In addition, a participant may withdraw any contributions that were rolled or transferred into the Plan at any time.

The distribution will be in the form of a lump sum payment if the participant's vested benefit is \$5,000 or less, unless the participant elects a direct rollover or distribution of their vested account balance. The distribution will be automatically rolled over to an individual retirement account in accordance with the IRC if the participant's vested benefit is greater than \$1,000 (but less than \$5,000) unless the participant elects, within the applicable period, to have the distribution paid to them or rolled over to another IRA or other eligible plan able to receive rollovers.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under accounting principles generally accepted in the United States of America.

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at quoted market prices, which are based on the net asset value ("NAV") of shares held by the Plan at year end. Mutual funds traded in active markets are classified within Level 1 of the fair value hierarchy. The NAV is based on the fair value of the underlying assets owned by the Plan, minus its liabilities then divided by the number of units outstanding.

Collective Investment Trust

Valued at NAV per unit as determined by the collective trust as of the valuation date. The unit values are determined based upon the fair value of the underlying assets. The NAV, as provided by the Trustee, is used as practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Self-Directed Brokerage

The self-directed brokerage holdings consist of common stocks and mutual funds. These investments are valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain fees and expenses of the Plan for legal, accounting, and other administrative services may be paid directly by the Company, or, at the Company's discretion, may be paid in whole or in part from the Plan assets. Investment management fees are paid by the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through September 3, 2025, the date which the financial statements were available to be issued.

3. Certification of Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H - schedule of assets (held at end of year) as of December 31, 2024.

At the direction of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

The collective trust is calculated using the NAV per share. The trust has no unfunded commitments. The redemption notice period of 12 months is when the entire trust is redeemed. The collective trust has a daily redemption frequency.

5. Party-In-Interest Transactions

The Plan's investment funds are primarily managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee for the administrative service amounted to approximately \$28,000 for the year ended December 31, 2024.

6. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

7. Income Tax Status

The Plan has adopted the Principal Life Insurance volume submitter plan. The volume submitter plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype basic plan document, as then designed, was in compliance with applicable requirements of the IRC. The Plan has adopted certain amendments. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

9. Secure 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. Most of the provisions of SECURE 2.0 will become effective in 2024 and beyond. Effective January 1, 2024 the Plan adopted following provisions:

- Federally Declared Disaster Loans: Eligible participants may borrow up to the lesser of \$100,000 or 100% of their vested account balance. Loan repayments may be delayed up to one year. Loans must be issued within 180 days of the applicable disaster date.
- Federally Declared Disaster Withdrawals: Participants affected by a federally declared disaster may withdraw up to \$22,000, exempt from the 10% early withdrawal penalty. Withdrawals may be repaid within three years and are includable in taxable income over three years if not repaid.
- Domestic Abuse Withdrawals: Participants may withdraw the lesser of \$10,000 or 50% of their vested account balance if they self-certify as victims of domestic abuse. These distributions are penalty-free, not subject to 20% withholding, and may be repaid within three years.
