I, Michael Morin, enrolled actuary (EA #23-04030), hereby confirm that the actuarial valuation for the plan year beginning January 1, 2024, and ending December 31, 2024, excludes the assets held in segregated rollover accounts from the funding target, target normal cost, and minimum required contribution calculations.

These accounts consist of participant assets rolled into the plan from other qualified retirement plans and are maintained separately from the general plan trust. They are not available to pay general plan benefits and are used solely to provide benefits to the respective account holders.

The total value of these segregated rollover accounts as of the valuation date, December 31, 2024, is \$1,822,735.69. These assets are included in the total plan assets reported on Form 5500-SF but are excluded from the actuarial funding calculations in accordance with applicable regulations under IRC §430 and ERISA.

No actuarial assumptions have been applied to these accounts, and they do not impact the development of the plan's prefunding balance or carryover balance.
