NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the Cadwell Industries, Inc., 401(k) Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General – The Plan, effective December 1, 1983, is a defined contribution plan established by Cadwell Industries, Inc. (the Company), for employees of participating employers. Beginning July 23, 2018, participating employers are the Company and its related entities with common ownership including Cadwell Laboratories, Inc., Regnostics, Inc., and Cadwell Sales, Inc. The Company is the designated Plan Sponsor who has overall administrative responsibility for plan governance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent statutory revisions thereto, and was created for the benefit of substantially all employees. During the year ended December 31, 2022, The Pacific Clinic and Court Club Physical Therapy were sold to an unrelated party and the corresponding assets were transferred out of the Company's plan into an unrelated plan. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Eligibility – To participate in the Plan, employees must have attained age 21 and have three months of service. For all employees, to be eligible to receive employer contributions they must work 1,000 hours during the plan year and be employed on the last day of the plan year.

Contributions – Each year, participants may make voluntary tax-deferred contributions by salary reduction arrangements subject to dollar limitations of 60% of wages or an amount determined by the Internal Revenue Service (IRS) annually. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a stable value fund, and a participant-directed brokerage account as investment options for participants. The employer makes discretionary matching contributions equal to a percentage of the participant's contribution. For each of the years ended December 31, 2024 and 2023, the employer made a matching contribution of 25% of participant's contributions, up to a maximum of 15% of the participant's eligible wages. Catch-up contributions for participants 50 or older are not eligible for the employer match calculation. Individual accounts are maintained for all participants and reflect their contributions, allocations of employer contributions, and any earnings and losses on the Plan's investments.

Participant accounts – Each participant's account is credited with the participant's contributions, the Company's matching contributions, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (continued):

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion to their accounts is based on years of continuous service. Employer contributions vest over six years on a graduated schedule of 20% each year, beginning in year two and ending in year six.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance subject to the approval of the Administrative Committee. The loans are secured by the balance in the participants’ accounts and bear a reasonable rate of interest. Repayments are generally made over a period not to exceed five years; however, loans used to acquire a principal residence may be repaid over a reasonable period up to ten years. Principal and interest are paid ratably through the monthly payroll.

Payment of benefits – On termination of service due to death, disability, retirement, or for certain hardship cases, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Distributions are paid under various options as described in the plan document.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$47,502 and \$42,320, respectively. These accounts are retained in the Plan and will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Company contributions payable under the Plan. No forfeiture funds were used to pay administrative expenses or used to reduce employer match for the years ended December 31, 2024 or 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board *Accounting Standards Codification* 820, *Fair Value Measurements and Disclosures*, are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Money market accounts (Level 1): Interest bearing accounts valued at fair market cash value.

Mutual funds (Level 1): Valued at the daily closing price reported in the active market in which they are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant-directed brokerage accounts (Level 1): Accounts primarily consist of cash, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator of \$4,161 and \$5,714, for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan’s operations.

The Plan had fee refunds or net credits from Fidelity, which were \$40,951 and \$17,594 for the years ended December 31, 2024 and 2023, respectively.

NOTE 5 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 – TAX STATUS:

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – INFORMATION CERTIFIED BY THE TRUSTEE:

Information contained in the financial statements and supplemental schedule that was certified to be complete and accurate by the trustee, Fidelity Management Trust Company, is as follows:

- Investment amounts included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule as of December 31, 2024.
- Net appreciation in fair value of investments, interest, and dividend amounts included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500:

NOTE 10 – SUBSEQUENT EVENTS:

Subsequent events have been evaluated by the Plan's management through October 1, 2025, which is the date the financial statements were available to be issued.
