## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor of the  
Emery Sapp 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Emery Sapp 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

## **Other Matters**

### ***Supplemental Schedule Required by ERISA***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTES TO THE FINANCIAL STATEMENTS

#### (1) Plan Description

The following description of Emery Sapp 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### *General Information*

The Plan, which was established January 1, 1996 and subsequently amended, is a defined contribution and 401(k) plan covering substantially all employees of Emery Sapp Construction, Inc. and Subsidiaries. (the “Company”) who meet the eligibility provisions of the Plan. The sponsor of the Plan is Emery Sapp Construction, Inc., who owns 100% of the Company. The Plan is subject to provisions of ERISA.

The Plan has a transfer agreement with the Emery Sapp Employee Stock Ownership Plan (“ESOP”), where any elective diversification (ESOP Diversification) or mandatory diversification (ESOP Segregation) from the ESOP will be immediately transferred from the ESOP to the Plan.

##### *Contributions*

All participants may make contributions of their annual compensation under a salary deferral agreement as a pre-tax deferral or a Roth deferral. Contributions are limited to the maximum amount allowed by law. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company may make discretionary matching contributions of the participants’ elected cash contributions at a rate determined annually by the Company’s Board of Directors. The Company may also make other discretionary contributions as determined by the Company’s Board of Directors and allocated to eligible participant accounts. Participants direct the investment of the contributions into various investment options offered by the Plan.

##### *Eligible Participants*

Employees are eligible to participate in the Plan on any day following their employment commencement date. An eligible employee means any employee of the Plan Sponsor other than a leased employee, union employee, non-resident alien with no United States source income, or an individual classified as an independent contractor.

##### *Participant Accounts*

Each participant’s account is credited with (a) the participant’s contributions, (b) the Company’s discretionary contributions, and (c) Plan earnings and appreciation. Each participant’s account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### *Vesting*

Participants are immediately vested in their elective deferrals, rollover and transfer contributions, plus or minus actual earnings or losses thereon. Participants are also fully vested upon the attainment of normal retirement age, retirement due to disability, death, or the termination of the Plan.

For employer contributions to the Plan, participants will vest as follows:

Participants are considered to have completed one year of service upon the completion of 1,000 hours of service at any time during the employment year. The Plan recognizes years of service credited under all plans merged with the Plan for purposes of determining years of service.

#### *Forfeited Plan Assets*

If a participant forfeits any unvested balances in his/her account, the forfeited assets are used to reduce any potential future employer contributions or pay plan expenses. There were immaterial forfeitures for the years ended December 31, 2024 and 2023.

#### *Notes Receivable from Participants*

Subject to provisions under the Plan, participants may borrow from the Plan an amount which does not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Notes receivable, which are secured by the balance in the participant's account, bear interest at a rate established by the plan administrator, and have terms not to exceed 5 years, unless the loan was made for the participant to acquire his/her principal residence. In this case the terms are extended as determined by the plan at the time of the loan. Principal and interest are paid ratably through payroll deductions. Participants are not allowed to borrow funds from the ESOP Segregation accounts.

#### *Retirement and Terminations*

In the case of normal retirement or retirement due to permanent disability, participants will receive the value of their vested benefits, in accordance with the provisions of the Plan, in a lump-sum distribution.

In the event that a participant dies before retirement, the beneficiary will receive the value of the participant's vested benefits in a lump-sum distribution.

In the case of termination of an employee, pursuant to plan provisions, the participant may request early payment of the vested benefit by submitting a written request to the plan administrator. The portion of the terminated participant's account balance that is not vested is forfeited and remains in the Plan.

## EMERY SAPP 401(k) PLAN

### NOTES TO THE FINANCIAL STATEMENTS

#### (1) Plan Description (Continued)

##### *In-Service Distributions*

The Plan allows for in-service distributions upon the attainment of the normal retirement age (defined in the Plan as the later of (i) the date a participant attains age 59 1/2 or (ii) the fifth anniversary of the date a participant commenced participation in the Plan, unless otherwise stated above for certain mergers), and only from funds in which the participant is 100% vested. Participants are not allowed to take in-service distributions from the ESOP Segregation funds.

##### *Hardship Withdrawals*

The Plan allows for hardship withdrawals, as defined in the Plan, that are limited to the amount needed to meet the financial need. If a participant receives a hardship withdrawal, he/she is still eligible to participate in employer contributions to the Plan. These withdrawals may not be recontributed to the Plan and may be subject to income tax and penalties. Participants may not use the ESOP Segregation funds for hardship withdrawals.

##### *Administration*

All assets of the Plan are held and managed by Fidelity Investments Institutional Operations Company, Inc. ("Fidelity").

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual method of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. The fair value of the Plan's other financial instruments approximates their carrying amounts, either because the expected collection or payment period is relatively short or because the terms are similar to market trends. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTES TO THE FINANCIAL STATEMENTS

#### (2) Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Investment Risk*

Participants in the Plan assume all adverse investment risk connected with any decrease in value of plan assets, and such assets are the sole source of payments under the Plan.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

It is the policy of the Plan that certain administrative expenses pertaining to the Plan be paid by the Plan, except for the fees of the independent auditor issuing the accompanying report, which are paid by the Company.

##### *Subsequent Events*

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

#### (3) Transactions with Parties-In-Interest

The Plan is administered by the Company. Employees of the Company serve as the Plan's administrators and participate in the Plan. The Plan pays for all administrative expenses related to the Plan, except for the fees of the independent auditor issuing the accompanying report. All investment funds are managed by Fidelity.

### NOTES TO THE FINANCIAL STATEMENTS

#### (4) Fair Value Measurements

Under the Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”), a guideline is provided for measuring fair value under generally accepted accounting principles. The topic establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs include quoted prices in active markets for similar assets, quoted prices in inactive markets for similar assets, or inputs that are observable or can be corroborated by observable market data or other means for substantially the full term of the asset; and Level 3 inputs have the lowest priority and are based on prices or valuation techniques that are unobservable and not corroborated by market data. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses Level 2 inputs when an active market comparable is not available and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### *Level 1 Fair Value Measurements*

The fair values of registered investment companies and pooled separate accounts are based on quoted market prices.

The Plan enters into common/collective trusts with Fidelity, which are valued at net asset value, which serves as a practical expedient to estimate the fair value of the common/collective trusts. The net asset value, which is not publicly quoted, is based upon quoted market prices in active markets for similar assets, quoted prices in inactive markets for similar assets, or inputs that are observable or can be corroborated by observable market data or other means.

#### (5) Certification

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, the Plan administrator has obtained certifications from Fidelity that the investment and loan balances and their related income as reported in the accompanying financial statements are complete and accurate.

#### (6) Plan Termination Policies

Although it has not expressed intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of termination of the Plan, the right of all participants to benefits would become 100% vested and nonforfeitable. The amount of the account balance due to each participant would be distributed in accordance with the payment provisions of the Plan.

#### (7) Internal Revenue Service Status

The Internal Revenue Service has determined and informed the plan administrator by a letter dated February 1, 2023 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan was amended subsequent to this date; however, the plan administrator and management believe the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **(7) Internal Revenue Service Status (Continued)**

The Plan accounts for any uncertain tax positions in accordance with the Income Taxes topic of the FASB ASC. The topic prescribes a recognition threshold and measurement process for financial statement recognition of uncertain tax positions taken or expected to be taken in an annual return/report of an employee benefit plan. In evaluating the Plan's tax position, interpretations and tax planning strategies are considered. The Plan believes its tax-exempt status is appropriate based on current facts and circumstances.

#### **(8) Plan Amendment**

Effective January 1, 2024, the Plan sponsor, who acquired 100% of the common stock of Rummel Holding Group, Inc. as of September 30, 2022, merged Rummel Construction, Inc. 401(k) Plan into the Plan.

Effective July 15, 2024 and December 1, 2024, the Plan Sponsor amended the Plan to include a transfer agreement with the ESOP (see Note 2).

#### **(9) Risks and Uncertainties**

The Plan invests in various securities. The underlying investments may include corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
