1. DESCRIPTION OF THE PLAN

The following description of The Phillips Collection Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General -

The Plan is a defined contribution plan covering all eligible employees of The Phillips Collection (the Employer). The Plan is effective as of January 1, 1992 and qualifies under the Internal Revenue Code as a 403(b) Pension Plan. The Plan was most recently amended and restated effective January 1, 2021.

In December 2022, Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Most of the provisions will become effective in 2024 and forward, therefore, there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

Contributions -

Employees may elect to defer an amount of pre-tax compensation up to the annual IRS deferral limit. The employer may elect to contribute a discretionary matching contribution equal to 100% of the employee elected deferral, not to exceed 3%.

For each pay period, the Employer may elect to make discretionary nonelective contributions; such contributions will be allocated under a three-tiered formula:

- Nonelective contributions will be allocated in the ratio that each participant's compensation for the pay period bears to the total of all participants' compensation for the pay period, but not in excess of 3% of each participant's compensation.
- Any nonelective contributions remaining after the first allocation will be allocated among participants grandfathered under the 2015 amendment who are senior management employees in the ratio that each such participant's compensation for the pay period bears to the total of all such participant's compensation for the pay period, but not in excess of 2.4% of each such participant's compensation.
- Any remaining nonelective contributions will be allocated in the ratio that each participant's compensation for the pay period bears to the total of all participants' compensation for the pay period.

Vesting -

Participants are fully vested in their elective deferral contributions, employee rollover contributions, and employer qualified nonelective contributions, plus actual earnings thereon.

Participant accounts -

Each participant's account is credited with (a) the employee's contributions, (b) investment earnings and losses and (c) the employer's contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of investment earnings and losses, and administrative expenses, are based on account balances, or specific participant transactions, as defined in the Plan document.

Investments elections -

Contributions to the Plan are invested according to participant instructions. The Plan Administrator has made available to all eligible participants the investment options via Ascensus' (Custodian) website.

1. DESCRIPTION OF THE PLAN (Continued)

Payment of benefits -

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions and net earnings thereon, allocated to such participant's account, less any outstanding notes receivable. Benefit payments are made in the form of participant directed lump sum, installment, or annuity payments upon separation, retirement, total and permanent disability, or death, as applicable. Benefits are recorded when paid whether directly to or on behalf of a participant.

Hardship distributions to employees are permitted if certain conditions are met.

Notes receivable from participants -

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. All notes receivable from participants are secured by the balance in the participant's account. Interest rates on loans to participants range from 9% to 9.5%.

Plan termination -

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting -

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

Use of estimates -

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Fair value measurement -

The Plan applies the provisions of FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs (assumptions that market participants would use in pricing assets and liabilities, including assumptions about risk) used to measure fair value, and enhances disclosure requirements for fair value measurements.

The Plan accounts for a significant portion of its financial instruments at fair value or considers fair value in their measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of investments -

Investments are stated at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Certain Plan assets are invested in pooled accounts. Under the pooled investment concept, the investment advisors account for the Plan's share of the total portfolio on a unit basis and reports the pooled separate accounts at net asset value (NAV).

The guaranteed annuity contracts are reported at contract value which is the relevant measurement attributable to guaranteed annuity contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the contracts represents contributions plus earnings, less participant withdrawals, and administrative expenses. In determining the reasonableness of the methodology, a number of factors are considered, such as economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms, while others are substantiated utilizing available market data.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are loans for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date.

Benefit payments -

Benefits are recorded when paid.

Administrative expenses -

Certain expenses of maintaining the Plan are paid directly by the Employer and some are paid out of the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net appreciation of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits. Expenses that are paid by the Employer are excluded from these financial statements.

Excluded contracts and accounts -

The Plan Administrator has elected to exclude certain contracts and accounts from Plan assets in accordance with DOL FAB 2009-02 due to the following factors:

- The contract or account was issued to a current or former employee before January 1, 2009;
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and in fact stopped making contributions to the contract or account before January 1, 2009;

Excluded contracts and accounts (continued) -

- All the rights under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the Employer; and
- The individual owner of the contract is fully vested in the contract or account.

3. INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. INFORMATION CERTIFIED BY CUSTODIANS

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's Administrator instructed the Plan's independent auditors not to perform, and they did not perform, such auditing procedures with respect to the information certified by Ascensus, LLC, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, Inc. Ascensus, LLC, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, Inc. issued Certification Statements, certifying the information presented in the Schedule of Assets (Held at End of Year) and the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by Ascensus, LLC and Transamerica Financial Life Insurance Company, Inc., who provide recordkeeping, Plan management, and day-to-day support to the Plan. Therefore, these transactions qualify as party-in-interest.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

7. GUARANTEED ANNUITY CONTRACT

The Plan maintains investments in a fully benefit-responsive guaranteed annuity contract with Transamerica Financial Life Insurance Company, Inc. (TFLIC). The Fixed Fund seeks to provide maximum returns with the guarantee of principal and interest. It provides participants with book value distributions at retirement and other events, as described on the group annuity contract.

The Fixed Fund is supported by TFLIC's general account, which invests in investment grade fixed income securities, including U.S. Government, agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. A 5% withdrawal charge will be withdrawn from this fund upon transfer. TFLIC will transfer to the designated payee 95% of the contract value of the Fixed Fund assets.

The Fixed Fund's average yield based on actual earnings was 3.50% in 2024 and 2023.

The average yield based on interest rates credited to participants was 3.50% in 2024 and 2023.

As described in Note 2, because the guaranteed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for Plan benefits attributable to the guaranteed investment contract.

Contract value, as reported to the Plan by TFLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

8. POOLED SEPARATE ACCOUNTS

The Plan maintains investments in a fully benefit-responsive pooled separate account with Transamerica Financial Life insurance Co. (TFLIC). The Government Fixed Fund invests in obligations of the U.S. Government and its Agencies, and provides a book value guarantee in all market environments.

The Government Fixed Fund seeks to provide higher yields than short-term. A 5% withdrawal charge will be withdrawn from this fund upon transfer. TFLIC will transfer to the designated payee 95% of the contract value of the Fixed Fund assets.

The Government Fixed Fund's average yield based on actual earnings was 3% in 2024 and 2023. The average yield based on interest rates credited to participants was 3% in 2024 and 2023.

9. FAIR VALUE MEASUREMENT

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

9. FAIR VALUE MEASUREMENT (Continued)

Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

Level 1. These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

Level 2. These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

Level 3. These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for investments measured at fair value.

- *Registered Investment Companies (Mutual Funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
- *Guaranteed Annuity Contract* - This account is a fixed rate annuity contract that is fully and unconditionally guaranteed by the trustee and guaranteed a minimum rate of return with the potential for additional interest. The guaranteed annuity contract is reported at contract value, which represents accumulated cash contributions, interest credited to the Plan's contracts, less withdrawals to include any transfers in and out of the contracts. Contract value is deemed a reasonable approximation of fair value.
- *Pooled Separate Account* - Valued at the number of participation units held at year-end multiplied by the current participation-unit value. Investments in pooled separate accounts represent ownership of units of participation in various funds, and not ownership of specific assets. The value of a unit of participation is the total value of each fund within the separate accounts divided by the number of units outstanding.

The fair value of investments within the scope of FASB issued Accounting Standards Update (ASU) 2009-12, *Investment in Certain Entities that Calculate Net Asset Value per Share*, can be determined using NAV per share as a practical expedient when the fair value is not readily determinable, unless its probable that the investment will be sold at something other than NAV. The ASU requires disclosure of certain attributes by major category for investments within the scope of the ASU, regardless of whether the practical expedient was used. The Plan Administrator has determined that the Pooled Separate Accounts can be measured using the practical expedient.

Certain investments that are measured at net asset value and contract value have not been categorized in the fair value hierarchy; however, the net asset value and contract value amounts presented in the tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Changes in Net Assets Available for Benefits.
