1. Description of Plan

The following description of The Elisabeth Morrow School 403(b) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Elisabeth Morrow School (the "School"). All employees are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute a percentage of their annual compensation on a pre-tax basis up to the applicable dollar amount which is established annually by the Internal Revenue Service ("IRS"). The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants will have their deferral rate set at 5% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount.

Participants may also rollover or transfer amounts representing distributions from other eligible retirement plans.

The School will make matching contributions for participants who make contributions based on years of service. The School will contribute 5% of participant's compensation for participant's with less than 6 years of service; 7.5% for participant's with 6 to 10 years of service; and 10% for participant's with 11 or more years of service. If a participant's contribution is less than percentages noted, the School will only match the amount contributed by the participant.

The School may also make an additional matching contribution and a qualified non-elective contribution. For the 2023 Plan year, no additional matching contribution or qualified non-elective contributions were made.

Vesting

Participants are fully vested at all times in their contributions and qualified non-elective contributions. Participant's are 100% vested in matching contributions and additional matching contributions upon completion of one year of service.

Forfeitures

At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$6,279 and \$4,182. These accounts will be used to reduce employer contributions, administrative expenses or reallocated to participants. In 2023, forfeitures of \$13,505 were used to pay administrative expenses. No forfeitures were used to reduce employer contributions or reallocated to participants.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50 percent of their account balance with a minimum loan of \$1,000. The loans are secured by the balance in the participant's account. All loans bear interest at a rate for similar loans from commercial lending institutions. Principal and interest are paid ratably through payroll deductions. The loan must be repaid within a period not to exceed five years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan must be repaid within the period permitted.

Expenses

Certain expenses of maintaining the Plan may be paid by the School and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the employer contributions, if any, and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in their account.

Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (*continued*)

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2023 and 2022, all investments, that were valued at fair value, were valued using level 1 inputs.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. The mutual funds are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and they are required to publish their daily net asset value and to transact at that price. These mutual funds are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is June 18, 2024.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividend income, other income and interest on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

4. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the “PFIGO”) is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant’s account balances. This net crediting rate is after the deduction for fees for administrative and record-keeping services provided to the Plan. The rate is reset on a semiannual basis.

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. An employer level liquidation or employer initiated transfer of the Plan’s interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the employer chooses. Notification of a Plan’s intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan’s interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan’s interest in the contract. If this scenario occurs, the surrender charge will be billed to the employer.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (A1 as of January 2022), Standard and Poor’s (A+ as of April 2024), A.M. Best Company (A+ as of March 2024), and Fitch (AA- as of June 2023).

5. Tax Status

The School has adopted a restated plan document effective September 1, 2021 which was issued an opinion letter from the IRS dated March 31, 2017. The School believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

5. Tax Status (*continued*)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2020; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments are managed by an affiliate of Principal Trust Company ("Principal"), the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

Certain employees of the School, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

The Plan has an agreement with Principal whereby Principal will pay certain Plan expenses on behalf of the Plan. The payments come from Principal and are not a Plan asset. For the year ended December 31, 2023, \$24,000 was used to offset Plan expenses.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2023 are not reflected in these financial statements.
