**Note A - Description of Plan and Summary of Accounting Policies**

**Description of Plan**

The following description of the Stoney Creek 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- 1) General. The Plan is a safe harbor defined contribution plan covering all employees of Stoney Creek Hospitality Corporation and the following individually owned entities ("Company"): Stoney Creek Investors of Broken Arrow, LLC; SCI Columbia, LLC; SCI Des Moines, LLC; SCI Galena, LLC; SCI LaCrosse/Onalaska, LLC; Headwaters Development, LLC; HPI Partners, LLC; Stoney Creek Investors of Independence, LLC; SCI Moline, LLC; SCI East Peoria, LLC; SCI Quincy, LLC; SCI St. Joseph, LLC; SCI Sioux City, LLC; TC Lodging Partners, LLC; Stoney Creek Partners of Waukon, LP; SCI Wausau, LLC; SCI Builders, Inc.; Torgerson Thompson and Co.; and SC Development Corporation. Employees become eligible to participate in the Plan after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- 2) Contributions. Annually, participants may contribute up to 100% of their gross compensation to the Plan, subject to the statutory maximum allowed by the law. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various registered investment companies offered by the Plan.  
  
Effective September 1, 2017, the Plan was amended to allow Roth participant deferrals.  
  
The Company made a safe harbor matching contribution equal to 100% of each participant's elective deferrals not exceeding 3% of the participant's compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation during the years ended December 31, 2024 and 2023.  
  
Participants also direct the investment of the Company's matching contributions among the aforementioned investment options.
- 3) Participant Accounts. Each participant's account is credited with the participant's contribution, the Company's matching contributions, and an allocation of the Plan earnings and administrative expenses paid by the plan. Because all accounts are 100% participant directed, Plan earnings are attributable to the investments selected by each participant and allocated to each participant in a manner that reflects the investment experience of each participant's directions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- 4) Vesting. Participants are immediately vested in their elective deferrals, rollovers, and employer safe harbor contributions, plus earnings thereon.
- 5) Payment of Benefits. Upon termination of service, a terminated participant may request payment of his or her account balance in the form of a lump-sum distribution. The distribution is to commence as soon as administratively feasible after the participant's termination date.

**Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as determined by Fidelity Management Trust Company (the Custodian), and are based on the net asset value of units held by the Plan at year-end. The collective investment trust is stated at fair value, is maintained by Great Gray Trust Company, LLC, and is based on the net asset value of units held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. All administrative expenses are charged to participant accounts.

Financial Instruments and Concentration of Credit Risk

The Plan's investments subject the Plan to concentrations of credit risk in that all of those investments were held by Fidelity Management and Trust Company (Fidelity). Following customary practices, the Plan does not hold collateral for debt investments made through these sources. The maximum potential credit loss to the Plan is limited to total Plan investments as shown on the accompanying statements of net assets available for plan benefits.

Payments of Benefits

The Plan records benefit payments to withdrawing participants when paid.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 6, 2025 which is the date the financial statements were available to be issued.

**Note B - Tax Status**

The Plan has adopted a volume submitter plan document provided by a third-party provider. The Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note C - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note E - Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Level 1* - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
