### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of the Community Human Services Corporation 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Effective May 25, 2024, the Plan was established as a separate 401(k) plan pursuant to a spinoff from the ADP TotalSource Retirement Savings Plan, a multiple employer plan (MEP) administered by ADP TotalSource. This spinoff was conducted in accordance with applicable Internal Revenue Service (IRS) and Department of Labor (DOL) regulations. All participant account balances and plan assets attributable to the Organization under the prior MEP were transferred into the newly established plan. The transition did not affect participant investment elections, account balances, or loan terms, and plan features were maintained to ensure continuity of retirement benefits. This is the initial set of financial statements for the Plan.

#### General

The Plan is a defined contribution plan covering all employees of the Organization who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Securities Act (ERISA) of 1974, as amended. The Board of Trustees oversees governance of the Plan. The Plan's investment advisors determine the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

#### Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan and in accordance with the Internal Revenue Code (IRC) section 415 limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set

at 3% of eligible compensation. Contributions are automatically invested in a designated fund until changed by the participant.

The Organization provides safe harbor matching contributions equal to 100% of each participant's elective deferrals up to 3% of compensation, plus 50% of elective deferrals between 3% and 5%. The Plan permits employer nonelective contributions; however, no such contributions were made during the plan year. Contributions are subject to certain statutory limitations.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in 100% of their elective salary deferrals, rollover contributions, employer match contributions, and earnings thereon.

### Forfeitures

Participants are fully vested in all contribution types and related earnings upon entry. Accordingly, no forfeitures are incurred upon withdrawal.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding from the Plan. Borrowings are considered to be collectible, as they are secured by the balance in the participant's account. Interest is charged at a reasonable rate as defined in the Plan document and is recorded on the accrual basis. The interest rate is 9.50% for the Plan year ended December 31, 2024. Principal and interest are paid ratably

through bi-weekly payroll deductions. Terms may not exceed five years unless the loan is granted for the purpose of acquiring the participant's principal residence. Notes receivable are stated at their unpaid principal balance plus accrued unpaid interest.

### Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any of the choices provided under the Plan. These are determined by the Plan sponsor, and participants may change their investment options daily.

### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account.

### Plan Transfers

At plan inception, as discussed previously, the transfers from the ADP TotalSource Retirement Savings Plan, a qualified plan, were \$1,141,400 for the year ended December 31, 2024.

## **2. Summary of Significant Accounting Policies**

### Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis of accounting. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant notes are reclassified as benefit payments subject to the terms of the Plan document.

### Payment of Benefits

Benefits are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of December 31, 2024.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

### Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

Fair values for Level 1 investments are determined by reference to unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access. Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Common Collective Trust Funds – The fair value of common collective trust funds is based on quoted net asset values of the shares as reported by the fund. The funds publish their daily net asset value and transact at that price. The common collective trust funds held by the Plan are considered to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **4. Information Certified by the Plan's Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation (depreciation) of fair value investments and dividends and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya), the custodian of the Plan.

#### **5. Plan Termination**

Although it has not expressed any intent to do so, the Organization has reserved the right to terminate the Plan or reduce or cease contributions at the discretion of the Board of Directors, or to amend the Plan at any time and in any respect, subject to the provisions of ERISA.

#### **6. Tax Status**

The Organization has adopted a pre-approved plan document that has received an opinion letter from the IRS dated May 27, 2021, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified. In addition, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

### **7. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Voya. Voya is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan for management services amounted to \$6,477 during 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.
