Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of FirstLight Power 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note 1. Description of the Plan

The following description of the FirstLight Power 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution profit sharing and 401(k) plan established to provide employees of FirstLight Power Services LLC (Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan was originally established on June 1, 2016. Effective January 1, 2021, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in the 6-year pre-approved plan restatement cycle. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA"). Empower Trust Company, LLC is the trustee and custodian of the Plan.

Eligibility

All employees of the Company, except non-resident aliens, leased employees or those that are governed by a collective bargaining agreement (unless the applicable bargaining agreement requires such employees to be included under the Plan), as defined by the plan document, are eligible to participate in the Plan. Participants are eligible for employee deferrals and all employer contributions immediately upon hire.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions up to 100% of eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC. Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution. The Plan also allows rollover contributions from other qualified plans as defined in the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

The Plan also allows participants to defer funds into a "Roth 401(k) deferral," and additional "after-tax employee contributions". These deferrals and contributions are subject to federal income taxes. Roth 401(k) deferrals and after tax employee contributions are limited to the provisions of IRC section 415 limitations.

The Plan includes an automatic enrollment provision whereby all eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate. Participants who are automatically enrolled have their deferral rate set at 3% of eligible compensation. In accordance with the automatic enrollment provision, the deferral rate will increase by 1% annually, not to exceed 6% for those participants who have been automatically enrolled.

Employer Contributions

The Company will make a matching contribution of 50% of the first 6% of eligible contributions, as defined, to all eligible employees of the Company. Matching contributions for 2024 totaled \$666,830.

Certain participants, who are not covered by a collective bargaining agreement, will receive a non-elective fixed employer contribution of 3% of their eligible Plan compensation, as defined. Non-elective fixed employer contributions for 2024 totaled \$501,095.

Certain participants, who are covered by a collective bargaining agreement, will receive a non-elective 401(k) plus contribution. Participants who are not tenured, as defined by the Plan, will receive a non-elective 401(k) plus contribution of 2% of their eligible Plan compensation, as defined. Participants who are tenured, as defined by the Plan, will receive a non-elective 401(k) plus contribution based on a combination of their age and 401(k) plus service, as defined by the Plan, as follows: Less than 40 years of age – 3% of eligible Plan compensation, age 40

through age 61– 4% of eligible plan compensation, age 62 or more – 6% of eligible plan compensation. Non-elective 401(k) plus contributions for 2024 totaled \$150,623.

Participant Accounts

Each participant's account is credited with the participant's contribution and its allocation of (a) the Company's contributions and (b) Plan earnings or losses.

Vesting

Participants are immediately 100% vested in their contributions, employer matching contributions, non-elective fixed employer contributions, non-elective 401(k) plus contributions, and actual earnings thereon.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Participant loans are subject to approval by the plan administrator and the interest rate is set at prime plus 1%. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Participants are allowed one loan at any given time. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, a participant or a participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump sum, installments, or partial withdrawals for participants after attainment of normal retirement age, as defined. Further, withdrawals from the Plan before leaving the Company are available after attaining the age of 59 ½ or for special "hardship" reasons, as defined. Benefits to participants are recorded when paid.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the custodians. See Note 8 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company may, at its discretion, pay the expenses incident to administer the Plan. In the event that the Company does not pay the Plan expenses, the expenses shall be paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Empower. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the value of the participant's accounts will be distributed to them.

Note 6. Related Party Transactions

Certain Plan investments are managed by Empower Trust Company, LLC. As Empower Trust Company, LLC. is the custodian of the Plan, recordkeeping or other administrative fees paid to them qualify as party-in-interest transactions that are exempt from the prohibited transactions rules, as defined by ERISA.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets.

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for the assets or liabilities.

Level 3 - Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain investment contracts and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.
