To the Plan Administrator of the
Albert S. Smyth Co., Inc. 401(k) Plan and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Albert S. Smyth Co., Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management having determined it is permissible in the circumstances, has elected to have the audits of the Albert S. Smyth Co., Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Albert S. Smyth Co., Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Albert S. Smyth Co., Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, which was established on September 1, 1998, is a defined contribution plan qualified under the Internal Revenue Code (the Code), covering substantially all employees of Albert S. Smyth Co., Inc. (the Company) as well as employees of affiliates (Participating Companies) of the Company who have adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended and restated effective January 1, 2022 to adopt a Cycle 3 pre-approved plan document and an opinion letter from the Internal Revenue Service (IRS).

Participating Companies and their effective dates for adoption of the Plan are as follows:

Smyth Annapolis, LLC (November 16, 2008)
Smyth Ellicott City, LLC (February 1, 2009)
Smyth Enterprises, LLC (May 1, 2010)

Eligibility

All employees, excluding collectively bargained employees, non-resident aliens, leased employees and gift wrappers, who are at least 18 years of age and have completed six months of service, as defined by the Plan, may participate in the Plan. Participants may enter the Plan on the first day of the calendar month following the date on which all eligibility requirements are met.

Participant Contributions

Participants may contribute to the Plan through payroll deductions up to 100% of their compensation, as defined by the Plan. Participant contributions may not exceed the maximum allowable contributions under the Code, which totaled \$23,000 for the year ended December 31, 2024. Participants are automatically enrolled to defer 4% of pre-tax compensation each payroll period unless the participant makes a different election. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants are also permitted to make rollover contributions into the Plan from other qualified retirement plans.

Company Contributions

The Company allows for discretionary contributions to be made on behalf of each eligible participant, provided that the eligibility conditions described above are met. The Company did not make any such contributions during the year ended December 31, 2024.

1. DESCRIPTION OF THE PLAN – cont'd.

Participant Accounts

Each participant's account is participant-directed and credited with the participant contributions, rollover contributions, withdrawals, and allocations of: (a) Company contributions, if any, (b) Plan earnings (losses) and (c) administrative expenses. Any earnings, losses, and administrative expenses are allocated to participant accounts based upon the investments selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral and rollover contribution account balances at all times. Participants vest in Company contributions plus actual earnings and losses thereon based on years of service according to the following schedule:

Upon retirement, death, or disability, a participant becomes 100% vested in their Company contributions.

Forfeitures

Forfeitures of nonvested accounts are applied to reduce Plan expenses or to reduce Company contributions for the Plan year following the Plan year in which the forfeitures occur. Forfeitures totaled \$0, and \$122 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures totaling \$122 were used to pay administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. Participant notes must be at least \$1,000 and a participant can hold no more than one note at any given time. Notes are collateralized by the participant's vested account balance. The notes bear interest at rates commensurate with those offered by financial institutions at the time of the note's issuance. The maximum term for a note is 5 years unless for the purchase of a principal residence. Notes for a purchase of a primary residence must be repaid within 10 years. Principal and interest is paid ratably through payroll deductions.

1. DESCRIPTION OF THE PLAN – cont'd.

Payment of Benefits

Participants may elect to receive a lump sum distribution upon termination of service due to death or retirement (age 60), attainment of age 59 ½, or becoming disabled. Upon termination of service, participants with vested account balances of less than \$5,000 will receive a lump sum distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan document. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to the accounts of participants who had elected to withdraw from the Plan that had not received such distributions prior to year-end.

Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid with net assets of the Plan, unless paid by the Company, at its discretion. Expenses that are paid directly by the Company are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur that materially affect participant account balances and amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes become due immediately upon termination of the participant's employment. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value Measurement – cont'd.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests bearing cash: Valued at amortized cost plus accrued interest, which approximates fair value.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through August 6, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Matrix Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. INCOME TAX STATUS

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing plan document, which received a favorable opinion letter from the IRS dated June 30, 2020. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income, the provision did not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. The Plan is subject to routine audits by the Department of Labor and IRS; however, there are currently no audits for any tax periods in progress.
