To the Plan Administrator and Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sharel Ventures, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). December 31, 2024 and 2023

1. Description of Plan

The following brief description of the Sharel Ventures, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a salary reduction plan pursuant to Section 401(k) of the Internal Revenue Code. It covers substantially all employees of Sharel Ventures, LLC (the “Company”) who meet the conditions of eligibility. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participation

Employees are eligible to participate in the Plan upon attaining the age of 21 and the completion of one year of service.

Contributions

The Company shall make deferral contributions (elective deferrals) on behalf of each participant who has an executed salary reduction agreement in effect with the Company. The maximum contribution each participant may make each year is subject to federal limits.

The Company may make discretionary matching contributions on behalf of each participant who deferred into the Plan and is employed on the last day of the plan year. The discretionary matching contribution is determined by the Company each year. In 2024 and 2023, the Company elected to make an employer matching contribution of 40% of the first 5% of deferrals. During 2024 and 2023, matching contributions totaled \$70,595 and \$46,319, respectively.

The Company may also contribute an amount which it designates as a qualified discretionary contribution (qualified non-elective contribution). This contribution may be included in the actual deferral percentage test or the actual contribution percentage test. Qualified discretionary contributions shall be allocated only to non-highly compensated employees in proportion to his or her compensation as a percentage of the compensation of all eligible employees for the plan year. During 2024 and 2023, the Company made no qualified discretionary contributions.

The Company may also decide each plan year to make a discretionary profit-sharing contribution on behalf of the eligible participants. Such contributions shall be allocated to eligible participants in the ratio that each participant’s compensation bears to the total compensation paid to all eligible participants for the plan year. In order for a participant to qualify to receive a discretionary profit-sharing contribution the participant must be employed on the last day of the plan year. Discretionary profit-sharing contributions may vary annually and are determined by the Board of Directors of the Company. During 2024 and 2023, the Company made no discretionary profit sharing contributions.

Contributions (Continued)

In addition, participants may transfer funds from other qualified plans, with the consent of the plan administrator.

Participant accounts

Each participant shall have an account which will be credited with the participant's contributions, Company contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined.

Vesting

As of January 1, 2019, the Plan was amended to offer 100% vesting on employer match contributions. Participants are immediately 100% vested in their elective deferrals and rollover contributions, plus actual earnings thereon.

Participants vest in discretionary employer profit share contributions plus actual earnings thereon in accordance with the following schedule:

Payment of benefits

Upon termination of service due to death, disability, termination or retirement, the entire vested account balance will be distributed in the form of a lump sum. In addition, if the account balance is greater than \$5,000, lump-sum distributions may be made, with participant consent, upon separation from service. If a participant balance is below \$5,000, an involuntary force out distribution may occur.

Notes receivable from participants

The Plan does not allow participants to borrow funds from their elective deferrals.

Administrative expenses

Sharel Ventures, LLC (the "Sponsor") has elected to pay a portion of the administrative fees of the Plan, while a portion is also paid out of the Plan assets.

2. Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) and present the net assets available for plan benefits and changes in those net assets.

Cash and cash equivalents

The Plan considers all highly liquid investments with a maturity of three months or less to be cash equivalents.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded in the year incurred.

Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair measurement.

Fair value measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Values are determined based on quoted market prices in active markets.

Cash equivalents: Includes money market accounts, certificates of deposit and all highly-liquid instruments purchased with an original maturity date of three months or less.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The Plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examinations by the applicable taxing jurisdiction for periods prior to December 31, 2021.

Plan management's review of subsequent events

The Plan administrator evaluated events occurring between the end of the most recent plan year and October 2, 2025, the date the financial statements were available to be issued.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Plan's prototype document obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and is tax-exempt as of the financial statement date.
