Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 - Description of Plan

The following description of The Ulven Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, except those covered by a collective bargaining agreement or leased employees, of The Ulven Companies, Ulven Forging, Inc., and Ulven Machinery Company, Inc., (collectively, the Company) who are age 18 or older and has completed 30 days of service. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan engages Reliance Trust Company and Standard Insurance Company (the Custodians) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of pre-tax and after-tax annual compensation, subject to limits of the tax law as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants are automatically enrolled at a deferral rate of 3% of eligible wages. Deferral rates are automatically increased after three years of service and increases 1% each year up to a maximum of 6%. The automatic enrollment can be declined by the employee upon request by the employee to change the deferral percentage to zero. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has elected to make Qualified Automatic Contribution Arrangements (QACA) safe harbor matching contributions equal to 100% on the first 1% of eligible earnings that a participant defers and an additional 50% on the next 5% of eligible earnings the participant defers. The Company made safe harbor matching contributions of \$153,709 for the year ended December 31, 2024. The Plan Sponsor may provide a discretionary profit-sharing contribution, which is determined by the Company, and is allocated to participants who are employed by the Company on the last day of the Plan year. There were no profit-sharing contributions made in 2024.

The Company also has elected to make discretionary employer match contributions for participants contributing equal to or greater than 10% of their eligible earnings. The discretionary employer match contribution is 0.50% for participants with less than 7 years of service with the Company, 1.0% for participants with 7 to 15 years of service, and 1.50% for participants with 15 years or more years of service. The Company made discretionary employer match contributions of \$17,117 for the year ended December 31, 2024.

Investment Elections

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants have the opportunity to change their investment combinations on a daily basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of Plan, continued

Vesting

Participants are immediately vested in their voluntary contributions. A participant becomes 100% vested in the employer QACA safe harbor match after two years of credited service. Vesting in the Company's discretionary employer match begins at 20% after one year of service and the amounts become fully vested on a graded vesting schedule after 5 years of service. A participant becomes fully vested in the entire balance of their account upon attainment of normal retirement age, permanent disability, death, or termination of the Plan. Any amount not vested upon a participant's separation from service is forfeited and may be used to reduce the Company's contribution or pay Plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or up to 10 years for the purchase of a principal residence. Principal and interest is paid ratably through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by commercial lenders for loans made under similar circumstances. The interest rates were 4.25% to 9.50% for the years ended December 31, 2024 and 2023.

Payment of Benefits

On termination of service due to any reason, participants with vested account balances of less than \$7,000 may only receive a distribution in a single lump-sum payment. Participants with vested account balances of \$7,000 or more may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, partial withdrawals, or installment payments over a period of time, as specified in the Plan document. Participants who have attained age 59 ½, are fully vested, and have not severed employment with the Employer are eligible to receive a pre-retirement distribution of all, or a portion of, their account. Participants who receive a pre-retirement distribution in this manner continue to be eligible to participate in the Plan.

Participants may also elect to take in-service or hardship withdrawals subject to the terms of the Plan document and Internal Revenue Service (IRS) regulations.

Forfeiture Accounts

Participants who terminate employment with the Company forfeit the non-vested portion of employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$782 and \$5,832, respectively. During the year ended December 31, 2024, \$9,730 of forfeitures were used to pay Plan expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Investment decisions are made at the direction of the participants.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events September 29, 2025, the date these financial statements were available to be issued.

Note 3 - Information Certified by Custodians

The Plan's investments are held by Reliance Trust Company and Standard Insurance Company, the Custodians of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings and charges for withdrawals and expenses as charged by the Custodians. The Plan Administrator has obtained a certification from the Custodians as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Custodians is complete and accurate:

- Investments, at fair value
- Investment, at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest on notes receivable from participants

Note 4 - Fair Value Measurements

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Guaranteed Investment Contracts

The Plan invests in a guaranteed investment contract which is a fully benefit-responsive investment contract with Standard Insurance Company, the Custodian of the contract. The Custodian maintains the contributions in general accounts. The accounts are credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value of the benefit responsive investment was \$6,231 and \$5,836 at December 31, 2024 and 2023, respectively.

The contract is fully benefit-responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Key variables influencing future crediting rates for the guaranteed investment contract include current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

The contract does not specify any events which would limit the ability of the Plan to transact at contract value with the issuer or any events which would allow the issuer to terminate the contract and settle for an amount different from contract value. The Company does not intend to surrender the contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on earnings of the underlying assets in the entire medium-long term new portfolio compared to minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Such interest rates are reviewed on a quarterly basis for resetting.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, The Ulven Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax Status

The IRS has determined and informed the Plan's volume submitter sponsor by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA sponsored by Pension Plan Specialists PC, which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-in-Interest Transactions

Pension Plan Specialists, PC provides third-party administration services to the Plan, Deschutes Investment Consulting, LLC provides investment advisory services to the Plan, and StanCorp Financial Group provides recordkeeping services to the Plan. Additionally, Reliance Trust Company and Standard Insurance Company provide custodian services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.
