Note 1 - Description of Plan

The following description of the Complete Mobile Dentistry 401(k) Plan (“Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is intended to meet the requirements of Section 401(a) of the Internal Revenue Code (IRC) and qualify as a defined contribution plan and was established to provide retirement benefits to eligible employees of Complete Mobile Dentistry, Inc. (“Company”) excluding union employees, leased employees, and all field staff.

The assets of the Plan are held for the exclusive benefit of the participating employees. There is no minimum age or service requirement for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan allows participants to make pre-tax contributions of up to 100 percent of their base salary, subject to certain Internal Revenue Code (IRC) limitations (\$23,000 for 2024) in each calendar year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. Employee contributions are fully vested.

The Company will make a Safe Harbor matching contribution for employees who satisfy the eligibility requirements. Safe Harbor matching contributions for the years ended December 31, 2024 and 2023 equaled 100 percent of the employee contributions to four percent of the participant’s eligible compensation each period.

The Company may make a discretionary matching contribution based on employee contributions that do not exceed six percent of the participant’s eligible compensation each period. The total discretionary matching contribution will not exceed four percent of the participant’s eligible compensation each period, regardless of the amount the employee contributes to the Plan. The Company may also make a discretionary employer contribution for participants who are employed on the last day of the Plan year and have worked 1,000 hours during the Plan year.

Contributions (Continued)

The Company will make a contribution to the Plan for eligible participants based on their classification as a prevailing wage employee. The Company contributes an amount based on hourly fringe rates set by the Department of Labor (DOL), multiplied by hours worked by participants. Cumulative fringe contributions in excess of individual insurance premium benefits are contributed to the Plan. Any contributions received under the prevailing wage will replace contributions participants would receive under employer discretionary or Safe Harbor contributions.

The Plan also accepts rollovers from other tax-qualified plans.

Participant Accounts

Participants are allowed to direct their account balance, their contributions and employer contributions into any of the investment options available.

Each participant's account is credited or charged with the participant's contribution and the employer's matching contribution and an allocation of Plan investment income or loss. Participants share pro rata in any investment income or loss of the funds, based upon individual participant account balances in the respective funds as of the end of each day. Each participant's account may also be charged with an allocation of the Plan's administrative expenses.

Plan Termination

During 2024, nearly all employees of the Company were terminated. The Plan is being terminated by the Company in 2025 (see Note 11). The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

Vesting

Participants are fully-vested in their contributions (including rollovers), Company Safe Harbor matching contributions and in the Company's prevailing wage contributions, plus actual earnings thereon. Vesting in the Company's discretionary match and discretionary employer contributions portion of their accounts plus actual earnings thereon is based on years of credited service. A participant vests 100 percent after two years of service. Participants are credited with a year of service for each year they work at least 1,000 hours. Participants who are at the normal retirement age, or leave the Plan due to death or disability, are considered 100 percent vested in all amounts allocated to their account.

Payment of Benefits

In the event of normal retirement, death, or permanent disability, a participant is entitled to receive the entire amount credited to the participant's account. Benefit distributions are payable in either a lump sum or as a rollover to another qualified plan. Accounts less than an amount as defined by the Plan automatically will be distributed in a lump sum. Participants also have the ability to receive hardship distributions in certain situations, as defined by the Plan document. If employment is terminated for any other reason, a participant is entitled to the vested portion of the account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 not to exceed the lesser of \$50,000 or 50 percent of their vested balance. The notes are secured by the balance in the participant's account and bear interest at one percent above the prime rate. Notes are repaid by payroll deductions. The interest rates on notes receivable from participants ranged from nine percent to 9.5 percent at December 31, 2024.

Upon participant termination or retirement, the outstanding loan balance is treated as a distribution to the participant if repayment is not made by the participant, or if an on-going repayment arrangement has not been made with the Plan. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Forfeited Accounts

The Plan provides that upon a participant's termination for reasons other than retirement, death or disability, the participant's non-vested funds are forfeited. Forfeited amounts from employer matching contributions are used to pay plan expenses or reduce Company matching contributions. During the year ended December 31, 2024, forfeitures totaling \$7,522 were used to reduce Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,626 and \$7,309, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP"). The financial statements and supplemental schedules have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Benefits Paid to Participants

Benefits are recorded when paid to participants.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investments in an insurance company general account are reported at contract value, based on information reported by the contract-holder of the assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Plan related expenses, consisting primarily of record keeping, administrative fees, custodian fees, and other professional fees are paid for by the Plan and have been recorded as administrative expenses on the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are also included in administrative expenses. Expenses related to investments are included in net appreciation (depreciation) of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

Level 1 - which refers to securities valued using unadjusted quoted prices from active markets for identical assets;

Level 2 - which refers to securities not traded on an active market but for which observable market inputs are readily available; or

Level 3 - which refers to securities valued based on significant unobservable inputs. There are no Level 2 or Level 3 investments in this plan.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts - valued based on the underlying investments (i.e. common stock, mutual funds, short-term securities). While the majority of the underlying assets values are based on quoted prices, the net asset value (NAV) of the pooled separate accounts is not publicly traded. The NAV is reported by Voya as of the financial statement date based on recent transaction prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Contributions to the VFA are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a minimum rate of interest. Voya may credit interest at a current rate higher than the guaranteed minimum interest rate. The guaranteed minimum interest rate and the current rate are expressed as annual effective yields. For the year ended December 31, 2024, the declared rate was 1.65 percent. The interest rate credited to participant accounts was guaranteed not to be below one percent.

The VFA is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk. There are no unfunded commitments.

Note 5 - Guaranteed Investment Contract (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (3) premature termination of the contract.

Note 6 - Administration of Plan Assets

The Plan assets were held and managed by Voya as of December 31, 2024 and 2023 and for the year ended December 31, 2024. Voya invests cash, interest and dividend income as directed by the participants of the Plan.

Note 7 - Party-In-Interest Transactions

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted by Voya qualify as party-in-interest transactions.

The Plan is administered by the Company. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. The Plan paid for expenses related to its investment activity and plan operations. Those transactions qualified as party-in-interest (see Note 2 - administrative expenses).

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 9 - Tax Status

The Plan adopted the Non-Standardized Pre-Approved Profit Sharing Plan with Cash or Deferred Arrangement (CODA) which has a favorable opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020. This opinion letter states that the form of the volume submitter plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 10 - Delinquent Participant Contributions

The Company failed to remit certain contributions to the Plan in a timely manner, according to DOL regulations, in the amount of \$149 in 2024. The Company calculated and remitted lost earnings to the Plan in 2025.

Note 11 - Subsequent Events

Management has evaluated subsequent events through October 6, 2025 which is the date the financial statements were available to be issued.

The Company is terminating the Plan in October 2025. Upon termination of the Plan, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan are expected to be allocated to participant accounts. Participant balances will be distributed to the Plan participants.
