Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Kelly Retirement Plus (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Kelly Retirement Plus (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that provides benefits to eligible employees of Kelly Services, Inc. (the "Company") according to the provisions of the plan document. All eligible employees, as defined by the Plan, are eligible to participate upon hire and attainment of age 18. Participants are eligible to receive employer contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute a percentage of eligible earnings, as defined in the Plan, of no less than 1 and no more than 75 percent up to the current Internal Revenue Service (IRS) maximums (\$23,000 in 2024) to the Plan each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, not to exceed \$7,500 in 2024. Effective January 1, 2023, newly eligible participants are automatically enrolled in the Plan with a deferral rate of 3 percent unless the participant elects a different percentage or opts out of automatic enrollment.

The employer matching contributions are discretionary, where the Company matches participant contributions using a predetermined formula. The Company made employer matching contributions equal to \$0.50 per dollar of participant contributions up to 6 percent of eligible earnings that employees contributed for 2024. Employer contributions are allocated in the same manner as participant contributions.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2021 and 2022 were paid after the time frame required by the Department of Labor. The Company remitted certain 2021 delinquent contributions during 2022. The Company remitted certain 2022 delinquent contributions during 2022 and their related lost earnings during the year ended December 31, 2024. All remaining delinquent contributions for 2021 and 2022 and their related lost earnings are expected to be remitted to the Plan in 2025.

Participant Accounts

Each participant's account is credited with the participant's contributions, the discretionary employer matching contribution, an allocation of investment earnings, and an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Administration

The Plan is administered by a committee appointed by the board of directors of the Company (the "Board"). This committee is composed of the executive vice president and chief financial officer, the senior vice president and chief human resources officer, and the senior vice president and corporate secretary and serves at the pleasure of the Board.

Investment Options

All contributions were invested by Bank of America, N.A., the trustee of the Plan, as directed by the participants, among the investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting and Benefits

Participants become fully vested in discretionary employer matching contributions upon attainment of age 65 or completion of three years of service, whichever comes first. The first year of service begins at the later of age 18 or date of hire. Participant contributions are immediately 100 percent vested.

The value of the vested portion of a participant's account is payable to the participant upon retirement, total and permanent disability, death, or termination of employment, typically in a lump-sum distribution. If the vested portion of a participant's account exceeds \$7,000 (or such other amount to be prescribed in Treasury regulations), the participant may defer receipt of the distribution until any time prior to or upon attaining age 73. Vested accounts with balances of \$7,000 or less are paid in an immediate lump-sum distribution.

Participant Forfeitures

Pursuant to the plan agreement, participant forfeitures can be used by the Plan to (1) restore the participant's account in the event of rehire, (2) reduce the discretionary employer matching contributions, or (3) reduce plan expenses.

In-service Withdrawals

Participants may request in-service distributions of vested account balances any time after the attainment of age 59½, or they may request in-service distributions from participant contributions if experiencing a hardship, as defined by the IRS, under safe harbor rules.

Participant Notes Receivable

The Plan, as currently designed, does not allow participants to borrow from their accounts; however, as part of plan mergers that occurred during the year ended December 31, 2023 and prior plan years, outstanding participant notes receivable were transferred into the Plan. No other participant notes receivable are permitted.

Party-in-interest Transactions

Certain administrative expenses of the Plan are paid by the Company and qualify as party-in-interest transactions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Contributions

Participant contributions are recorded in the period during which the Company makes payroll deductions from participants' earnings; discretionary employer matching contributions are recorded in the same period.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses incurred shall be paid by the Plan to the extent not paid by the Company.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Bank of America, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. Note 5 - Priorities on Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions and/or to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the accounts of all participants shall become fully vested and shall be distributed to the participants, with all participants receiving the full value of their accounts on the date of such distribution.

Note 6 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7 - Transfers

During the normal course of business, employees transfer between temporary and permanent employment status. As a result, employees previously participating in Kelly Retirement Savings Plan (KRSP) may become eligible under the Plan. Employees previously participating in the Plan may become eligible under KRSP. After the change in employment status, the participant accounts and related assets of the employees are then periodically transferred to the respective plan. In 2024, net transfers from the Plan to KRSP totaled \$136.
