**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Ergotron 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan covers all employees of Ergotron, Inc., (collectively the “Employer” or the “Company”) who are not leased employees, non-resident alien employees, or are covered by a collective bargaining agreement (unless specifically bargained with the union for coverage under the Plan).

Contributions: Each year, participants may contribute up to 30% of eligible compensation, as defined in the Plan, subject to certain limitations. Employees are automatically enrolled at a 3% deferral rate commencing with the first paycheck following forty-five days of employment. Deferral percentages are increased by 1% annually on January 1<sup>st</sup>, up to a maximum of 6%. Employees may elect to change or discontinue deferrals at any time. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions as of the January 1<sup>st</sup> of that year. Participants may also contribute amounts representing distributions from other qualified plans.

For the year ending December 31, 2024, an Employer discretionary matching contribution of 50% up to 6% of eligible elective contributions was made to all nonunion employees. The Plan Sponsor may, at its discretion, make additional Employer non-elective contributions and qualified non-elective contributions to the Plan on an annual basis. There were no non-elective contributions contributed for the year ending December 31, 2024.

Investment Options: Participants may direct their contributions, as well as Employer contributions, among any of the Plan's available investment options.

Participant Accounts: Each participant's account is credited with the participant's qualifying rollover contributions, the participant's contributions, the Company's discretionary contributions, profit sharing contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting: Participants are immediately vested in their contributions, qualified non-elective contributions, and rollovers plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of service and type of contribution. A participant is 100% vested in Employer discretionary matching contributions after three years of service and 100% vested in Employer non-elective contributions after 5 years of service. A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants may receive their vested account balances as a single lump sum. Participants may also elect to receive a distribution of their vested account balance in partial withdrawals or installments but only with respect to minimum required distributions. Prior to termination of employment, participants may make withdrawals after reaching the age of 59½. Participants may also make withdrawals from their Rollover Account at any time during employment.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. The term of participant loans will be no greater than 5 years, unless the loan is utilized for the purchase of a principal residence. All loans are covered by demand notes and are repayable through payroll deductions. A participant may have only one loan outstanding at a time.

Forfeitures: Participant forfeitures of employer matching and employer non-elective contributions credited during the Plan year are first applied to reduce or satisfy any discretionary or required employer matching contributions. The use of any remaining forfeitures shall be determined by the Employer in its sole discretion. Forfeitures may be used to pay administrative expenses or to restore any previously forfeited amounts for Participants who are rehired and have repaid prior distributions to the Plan.

Administrative and Investment Management Expenses: The Plan's administrative and investment management expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Investment management fees pertaining to Plan specific investments are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other administrative expenses of the Plan are paid by the Company on behalf of the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments, which are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 2, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, in connection with the Company's acquisition of Enovate Medical, the Enovate Medical 401(k) Plan was merged into the Plan. Approximately \$5.9 million (unaudited) in net assets transferred into the Plan in January 2025.

**NOTE 3 – RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan).

**NOTE 5 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**NOTE 5 – FAIR VALUE MEASUREMENTS** (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair value of participation units held in the stable value collective trust is based on the net asset values per unit as reported by the fund manager. The investment generally provides for redemptions on a daily basis and has redemption prices that are determined by the fund's net asset value per unit. The fund does not have advance notification requirements.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Trustee and recordkeeping fees paid by the Plan qualify as parties in interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants are also party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated September 21, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS or Department of Labor. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
