## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Kelly Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Note 1 - Plan Description

The following description of Kelly Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that provides benefits to eligible temporary employees of Kelly Services, Inc. (the "Company") according to the provisions of the plan agreement. Generally, temporary employees become eligible to participate in the Plan upon attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants may contribute a percentage of eligible earnings, as defined in the Plan, of no less than 1 and no more than 75 percent up to the current Internal Revenue Service (IRS) maximum (\$23,000 in 2024) to the Plan each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, not to exceed \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The employer contribution consists of two parts: (1) employer discretionary contributions, under which the Company may make a discretionary contribution on behalf of all eligible participants in an amount determined by the Company, and (2) employer matching contributions, which are discretionary where the Company matches participant contributions using a predetermined formula. The Company did not make an employer discretionary contribution to the Plan for 2024. The Company made employer matching contributions equal to \$0.50 per dollar of participant contributions up to 6 percent of eligible earnings that employees contributed for 2024. In addition, under federal regulations, the Company shall make contributions for eligible government contract employees at a rate per hour, as required under government regulations. These government contract contributions are also recorded as employer contributions.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the employer matching contribution, an allocation of the employer's discretionary contribution (if applicable), an allocation of the contribution for government contract employees (if applicable), an allocation of investment earnings, and an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Plan Administration**

The Plan is administered by a committee appointed by the board of directors of the Company (the "Board"). This committee is composed of the executive vice president and chief financial officer, the senior vice president and chief human resources officer, and the senior vice president and corporate secretary and serves at the pleasure of the Board.

#### **Investment Options**

All contributions are invested by Bank of America, N.A., the trustee of the Plan, as directed by the participants, among any of the investment options offered by the Plan.

### Note 1 - Plan Description (Continued)

#### ***Vesting and Benefits***

Participants are immediately 100 percent vested in employee and employer contributions. Upon retirement, disability, death, or other termination of employment, the value of the vested portion of a participant's account is payable to the participant in a lump-sum distribution. If the vested portion of a participant's account exceeds \$7,000 (or such other amount to be prescribed in Treasury regulations), the participant may defer receipt of the distribution until any time prior to or upon attaining age 73. Vested accounts with balances of \$7,000 or less are paid in an immediate lump-sum distribution.

#### ***Participant Forfeitures***

Pursuant to the plan agreement, participant forfeitures can be used by the Plan to (1) restore the participant's account in the event of rehire, (2) reduce the employer discretionary contributions or employer matching contributions, or (3) reduce plan expenses.

#### ***In-service Withdrawals***

Participants may request in-service distributions of vested account balances any time after the attainment of age 59½, or they may request in-service distributions from participant contributions if experiencing a hardship, as defined by the IRS, under safe harbor rules.

#### ***Participant Notes Receivable***

The Plan, as currently designed, does not allow participants to borrow from their accounts; however, as part of plan mergers that occurred during the year ended December 31, 2023, outstanding participant notes receivable were transferred into the Plan. No other participant notes receivable are permitted.

#### ***Party-in-interest Transactions***

Certain administrative expenses of the Plan are paid by the Company and qualify as party-in-interest transactions.

#### ***Basis of Accounting and Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### **Contributions**

Participant contributions are recorded in the period during which the Company makes payroll deductions from participants' earnings. Employer matching contributions, including contributions to government contract employees, are recorded in the same period. Employer discretionary contributions are recorded in the period during which they were earned.

#### **Benefit Payments**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses incurred shall be paid by the Plan to the extent not paid by the Company.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **Subsequent Events**

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Bank of America, N.A. (the "Trustee") holds the Plan's investments and the participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

### Note 4 - Fair Value Measurements (Continued)

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 5 - Priorities on Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions and/or terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the accounts of all participants shall remain fully vested and shall be distributed to the participants, with all participants receiving the full value of their accounts on the date of such distribution.

### **Note 6 - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7 - Transfers**

During the normal course of business, employees transfer between temporary and permanent employment status. As a result, employees previously participating in the Kelly Retirement Plus plan (KRP) may become eligible under the Plan. Employees previously participating in the Plan may become eligible under KRP. After the change in employment status, the participant accounts and related assets of the employees are then periodically transferred to the respective plan. In 2024, net transfers out of KRP to the Plan totaled \$136.
