Opinion

Note 1. Description of Plan

The following description of the Healthcare Management Solutions Employee Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General Description

The Plan was formed on January 1, 2021 as an employee stock ownership plan (ESOP). The Plan covers all eligible employees of HMS Holdings, Inc. and its subsidiary, Healthcare Management Solutions, LLC (collectively, the Company). The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended, (Code) and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan is administered by the Trustee, as appointed by the Company's Board of Directors, who hold and invest the Trust assets.

In June 2022, the Plan purchased certain Company common shares (see Note 4) and holds the stock in a trust established under the Plan.

Eligibility

Employees of the Company who have attained the age of 18 are eligible to participate in the Plan after having completed one year of employment with at least 1,000 hours of service completed during the plan year. Employees of the Company become eligible to participate on the first day of the plan year in which these requirements are met.

Contributions

The Company may make a discretionary cash or stock contribution as determined annually by the Company's Board of Directors. Participants are not permitted to make contributions to the Plan. Contributions are subject to certain limitations. As discussed in Note 5, during 2022, in conjunction with the Plan acquiring Company common shares, the Plan entered into a loan payable to the Company. The Company is required to make contributions related to Plan's debt agreement. In 2024, the Company contributed \$863,712 to the Plan, of which \$346,814 was applied to principal payments, \$470,744 was applied to interest payments. The remaining \$46,154 was used to pay benefits.

Participant Accounts

Each participant's account reflects their portion of the Company's contributions and allocations of shares of Company stock, income or loss from Plan investments, and forfeitures, and charged with an allocation of administrative expenses. Allocations are based on eligible compensation as a percentage of total eligible compensation of the Plan's participants, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting is based on years of credited service with the Company. Participants become vested in contributions received after January 1, 2021 at the rate of 20% per year beginning with the second year of service with full vesting occurring in the sixth year. Years of service for vesting are credited if an employee works at least 1,000 hours during a calendar year. Credited service shall not include years prior to January 1, 2021.

Payment of Benefits

Participants are eligible for retirement benefits upon attaining normal retirement age (65). Upon termination of service for reasons other than death, disability or retirement, distribution of the participant's vested account may commence no later than one year after the end of the fifth Plan year following the Plan year during which the

participant terminates service. Upon termination of service due to death, disability, or retirement, distributions will begin no later than one year after the last day of the year in which the participant's normal or early retirement, disability or death occurs. The Plan also provides an involuntary cash out provision whereby terminated participants with vested accounts balances of up to \$7,000 will be paid out in a lump sum in the Plan year following termination. Benefit payments are recorded when paid.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. Participants can only vote on those matters required by ERISA, otherwise the Trustee votes in their best interest. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Forfeitures

Forfeited nonvested accounts will be reallocated to eligible participants based on compensation. During 2024, 6,284 shares of stock were reallocated to eligible participants. There were no unallocated forfeited shares or cash at December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income, if any, is recorded on an accrual basis. Dividends, if any, are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 2, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There is a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Common Stock

The fair value of the Company's common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation methods. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

Note 5. Loan Payable

In conjunction with the purchase of 1,000,000 Company common shares effective June 1, 2022 for \$18,000,000, the Plan paid \$2,000,000 in cash and entered into a \$16,000,000 term loan agreement with the Company. Unallocated shares are collateral for the loan. The loan bears interest at 3.11%. The loan calls for 30 annual payments of \$817,558, including interest.

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan, as well as fund diversification and distribution requirements.

Note 7. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Trustee will be directed to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Note 8. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is relying on the IRS approval of the non-standardized pre-approved ESOP plan document (prototype) that it is utilizing. The IRS has determined and informed the plan document sponsor by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Terminated Participants

Amounts allocated to terminated participants with vested balances in the Plan, and which were still included in net assets available for benefits at December 31, 2024 and 2023, were \$90,319 and \$136,256, respectively.

Note 10. Risks and Uncertainties

The Plan invests in the Company's common stock. There are certain business risks with the industry in which the Company operates; therefore, it is at least reasonably possible that changes in the fair value of the Company's common stock may occur in the near term and that such changes could materially affect participant's account balance and the amounts reported in the statements of net assets available for benefits.
