Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Albuquerque Asphalt, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1) Description of Plan

The following description of the Albuquerque Asphalt, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Albuquerque Asphalt, Inc. (the "Company") who have completed two months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a prototype non-standardized profit sharing plan designed by Pension Planning Consultants, Inc. The Plan administrator is Albuquerque Asphalt, Inc. and operates under the authority of the Company.

Contributions

Participants may contribute up to the maximum percentage allowable of compensation, as defined by the Plan, not to exceed annual limits set by the Internal Revenue Code. For 2021, the limit was \$19,500. Catch-up contributions of \$6,500 are allowed for participants 50 and over. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has an automatic enrollment feature, when, after meeting eligibility requirements, the participant will be deemed to have made an elective deferral contribution election of 6%.

The Company will contribute a Safe Harbor matching contribution in an amount equal to: (i) 100% of the matched employee contributions that are not in excess of 1% of the Plan compensation, plus (ii) 50% of the amount of the matched employee contributions that exceed 1% of the Plan compensation but that do not exceed 6% of the Plan compensation. The Company may, in its sole discretion, make a non-elective or qualified non-elective contribution to the Plan.

The Plan may accept rollover contributions made on behalf of any eligible employee, regardless of whether such employee has met the age and service requirements of the Plan.

Participant Accounts

Each participant's account is credited with the participant's deferrals, the Company's contributions, plan earnings and an allocation of certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeited Accounts

Each Plan year, forfeitures are used to reduce any matching or nonelective contributions or to pay expenses of the plan. The forfeiture account had an account balance of \$209 at December 31, 2021.

Vesting

Participants are immediately vested in their contributions, rollover contributions, qualified non-elective contributions and safe harbor matching contributions.

Participants are vested in the company non-elective contributions based on years of service as follows:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

Years of vesting service is a period during which the participant completes 1,000 hours of service during the plan year.

Payments of Benefits

Upon termination of service, death, disability or retirement, vested benefits are distributed in accordance with specific requirements outlined in the Plan agreement.

A participant may request a hardship distribution for an immediate and heavy financial need as outline in the Plan agreement.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Administrative Expenses

The participant may be charged for some or all of the costs and expenses of operating the Plan.

Valuation of Investments

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value. If available, quoted market prices are used to value investments. In accordance with valuing investments at fair value, the net unrealized appreciation is presented in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefit payments are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

5) Plan Termination

Although it has not expressed intent to do so, the Company, as the Plan's sponsor, has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6) Tax Status

The Plan is operating as a tax-exempt profit sharing plan under a prototype document with a non-standardized plan adoption agreement. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the prototype plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype sponsor. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

7) Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements - The fair value of shares of registered investment companies are measured using quoted prices in an active market.

Level 2 Fair Value Measurements - The fair value of collective investment trusts and pooled separate accounts are measured using quoted net asset value of the underlying investments in active or inactive markets.

8) Corrective Contributions

During the audit, it was noted that some eligible employees were not included in the Plan. The Plan issued corrective contributions for failure to implement the automatic enrollment feature and failure to implement an affirmative election. The corrective contribution includes a 50% qualified nonelective contribution (QNEC) for the missed deferral opportunity. The corrective contributions were \$43,372 and \$31,765 for the years ended December 31, 2021 and 2020, respectively. The corrective contribution receivable was \$75,137 at December 31, 2021. The Plan is working with the third-party administrator to correct the error under the Voluntary Correction Program.

9) Party-in-Interest Transactions

Certain Plan investments were managed by Principal Trust Company. Principal Trust Company was the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11) Contingencies

The Plan has not complied with the Department of Labor reporting requirements which required the Plan to be audited timely. The possibility exists that the Plan could be subject to fees and penalties related to noncompliance. The Plan is addressing these issues and will comply by retroactively correcting the reporting requirements under the Delinquent Filer Voluntary Compliance program.
