Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the Financial Statements

1. Description of Plan

The following description of the Color Intermediate 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Color Intermediate, LLC and affiliated companies (collectively, the Company) effective November 15, 2022, except for members of a collective bargaining agreement, leased employees, or nonresident aliens who do not receive any earned income from the Company which constitutes United States of America source income. Employees become eligible to participate in the Plan upon completion of one month of service. Effective January 1, 2025, employees become eligible upon hire. Seasonal employees and temporary employees are eligible to participate in the Plan upon attaining age 21 and completion of at least 1,000 hours of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Upon satisfying the eligibility requirements, participants are automatically enrolled into the Plan on the first day of the following month and pre-tax contributions are withheld at 5% of eligible compensation, unless the participant elects differently. Contribution rates will automatically increase by 1% each year, up to 10%, unless the participant elects otherwise. Effective January 1, 2025, participants are automatically enrolled at 6% with a max of 15%. Participants may make pre-tax and/or Roth contributions of up to 75% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500, for participants who have reached at least 50 years of age by the end of the year. An eligible employee may also elect to make voluntary after-tax contributions up to 25% of base compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants are also permitted to make Roth direct rollover contributions into the Plan and in-plan Roth conversions are also allowed.

The Company makes a safe-harbor matching contributions equal to 100% of the first 1% of participants' elective deferrals plus 50% of the next 5% of participants' elective deferrals. The Company may also make discretionary matching contributions. There were no discretionary matching contributions in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, and earnings and losses on the investments in their account and is charged with certain administrative expenses. Participants direct the investment of their account into various investment options

offered by the Plan and may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Company safe-harbor matching contributions, plus actual earnings and losses thereon. Participants are fully vested after 2 years of service in their qualified automatic contribution arrangement safe-harbor matching contributions. Participants vest 50% after one year of service and are fully vested after 2 years of service in Company discretionary matching contributions. Participants who previously participated in predecessor plans may be subject to different vesting schedules. Effective January 1, 2025, participants are immediately vested in their qualified automatic contribution arrangement safe-harbor matching contributions, and Company discretionary matching contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest. During 2024, notes had fixed rates ranging from 3.25% to 8.50%, respectively, for the term of the note not to exceed 5 years unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions. All notes must be repaid immediately after termination of employment or death.

Payment of Benefits

At the time of death, disability, attainment of age 59½, termination of service, or retirement, the participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump distribution. A participant's account balance between \$1,000 and \$5,000 may be paid as a direct rollover to an individual retirement account established by the Company for the benefit of the participant. If the account balance is \$1,000 or less, the Plan may, upon termination of service, pay the benefits owed in a lump sum. The participant's contributions may also be withdrawn in certain hardship situations. Effective January 1, 2025, participants may also elect to receive partial withdrawals or installment payments of their vested account balance.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,519 and \$17,412, respectively. These accounts may be used to pay administrative expenses of the Plan or to reduce future Company matching contributions. In 2024, \$20,812 was used to reduce Company matching contributions.

Administrative Expenses

The Plan has an established ERISA account to pay for third-party administrative fees. The Plan is responsible for payment of operational and administrative expenses. During 2024, \$5,361 was deposited into the ERISA account, including investment earnings, and no funds were used to pay administrative expenses. The ERISA account assets totaled \$7,842 and \$2,481 as of December 31, 2024 and 2023, respectively.

Certain account activity charges are paid from the accounts of the participants that incur the charge. The Plan allows for payment of administrative expenses from the Plan's assets which are allocated proportionately based on the value of the account balances. These expenses are paid to service providers of the Plan and therefore qualify for party-in-interest transactions. All other expenses are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary matching contributions are payable to the Plan after approval by the Company. Any unfunded participant or employer contributions are included in participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's (FASB) Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 24, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

4. Investments

Plan investments include mutual funds, a money market fund, and a stable value fund managed by Fidelity, a service provider of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to several risks, such as market, interest rate, currency and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, or other events. It is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participants' account balances.

The FASB established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund which trades daily at the net asset value (NAV) per share of the fund (Level 1).

The stable value fund has redemption restrictions that limit the timing of withdrawals. Participant directed withdrawals may be made on any business day, provided that the exchange is not directed into a competing fund. Transferred amounts must hold a non-competing investment option for 90 days before funds may be transferred to a competing fund. In addition, redemptions of the stable value fund directed by the Plan must be preceded by twelve months written notice to Fidelity.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

6. Income Tax Status

The Plan uses a non-standardized, pre-approved profit sharing plan with CODA (pre-approved plan) sponsored by FMR, LLC (FMR) (an affiliate of Fidelity). FMR received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since FMR received the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns since inception are subject to examination by taxing authorities and may change upon examination.
