Independent Auditor's Report

To the Board of Trustees and Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Callen-Lorde Community Health Center 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements December 31, 2024

Note 1 - Description of Plan

The following description of Callen-Lorde Community Health Center 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan, adopted on January 1, 2009, is a defined contribution retirement plan established under Internal Revenue Code (the "IRC") Section 403(b) covering all employees of Community Health Project, Inc. (d/b/a Michael Callen - Audre Lorde Community Health Center) (the "Organization" or "Plan Sponsor"), subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Organization's Board of Trustees.

The Plan's assets are held by Reliance Trust Company, the custodian of the Plan. The Plan's recordkeeping and administration is conducted by T. Rowe Price Retirement Plan Services, Inc. ("TRP").

Eligibility

All employees of the Organization are eligible for the Plan pursuant to the Universal Availability Rule ("Universal Availability"). Universal Availability states that if an organization permits one employee to defer his or her salary into a 403(b) plan, the Organization must extend this offer to all employees of the Organization. Active employees are eligible to make salary deferral contributions to the Plan immediately following their date of hire. Employees who are employed on the last day of a Plan year in which they have worked at least 1,000 hours are eligible to receive any discretionary employer contributions for that Plan year.

Contributions

Participants may make salary deferral contributions to the Plan equal to a percentage or dollar amount of their pre-tax annual compensation, as defined by the Plan, up to the maximum amount allowed by the IRC, not to exceed \$23,000 for the year ended December 31, 2024. Participants may elect to designate all or a portion of their salary deferral contributions as Roth deferral contributions. Employees 50 years of age and older are allowed to contribute an annual \$7,500 catch-up contribution to the Plan for the year ended December 31, 2024. Participants may also contribute amounts representing rollovers or transfers from other qualified plans. Participants may change their salary deferral elections quarterly.

The Plan contains a safe harbor matching contribution provision for all union employees equal to 100% of the first 4% of their salary deferral contributions, provided they have completed one year of service with the Organization, as defined.

In addition, each year, the Plan Sponsor may make discretionary matching or nonelective contributions on behalf of eligible employees. The Organization's discretionary (non-safe harbor) matching contributions are limited to \$20,000 per year for all highly-compensated employees, as defined. For the year ended December 31, 2024, the Plan Sponsor did not make any discretionary contributions to the Plan. All contributions are subject to IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Organization matching contributions, as well as allocations of any discretionary nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant investment options

Participants direct the investment of their contributions and the Organization's contributions to selected investment options as offered by the Plan. Participants may change their investment options at any time throughout the year via direct phone or via the TRP website, on behalf of Reliance Trust Company.

Vesting

Participants are immediately vested in their salary deferral contributions, rollover contributions, safe harbor matching contributions, and any non-safe harbor matching contributions. Participants become 100% vested in any nonelective employer contributions after three years of service, as defined by the Plan.

Payment of benefits

On termination of service for any reason, participants will receive benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested balance less than \$1,000 will receive a mandatory distribution. For terminated participants with a vested account balance greater than \$1,000, but less than \$7,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$7,000 may defer payment of benefits until a later date.

Withdrawals from the salary deferral and rollover contribution portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified by the Plan. Participants who are at least 59½ years of age may withdraw all of a portion of the vested balance in his or her account prior to termination for any reason.

Forfeited accounts

Upon termination of service, any unvested interest of the employer nonelective contribution portion of a participant's account will be forfeited. Forfeitures are retained in the Plan and

may be used to pay Plan expenses or to reduce future employer contributions. There were no forfeited nonvested accounts as of December 31, 2024 or 2023. No amounts were utilized from forfeited nonvested accounts during the year ended December 31, 2024.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements are prepared on the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the organization are recorded in the year in which the employee contributions are withheld from compensation. Any nonelective contributions from the Organization are recorded in the year in which the contributions are earned.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to payment of benefits and asset-based investment management and administrative fees are charged directly to the participant's account and are included in administrative expenses. Indirect investment related expenses are included in the net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the custodian of the Plan.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by CCH Incorporated, dba ftwilliam.com ("CCH"). CCH received an advisory letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the volume submitter 403(b) plan document, as then designed, satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC; therefore, the Plan is deemed to be qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer nonelective contributions.

Note 7 - Related party transactions

Plan investments include shares of mutual funds held by Reliance Trust Company and administered by TRP. Reliance Trust Company is the custodian and the TRP is the third-party administrator, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value investments. Fees paid directly by the Plan to TRP for administrative expenses amounted to \$69,530 for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plans operations.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
