Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of A & B Distributors Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of A & B Distributors Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from Minnesota Life Insurance Company as of December 31, 2024, and for the period ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with the modified cash basis of accounting. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of A & B Distributors Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis for Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the A & B Distributors Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering qualified employees of A & B Distributors, Inc. (collectively, the "Company") Retirement Plan. Participating employers in the plan include: A & B Distributors, Inc. of Muskogee, Specialty Brands, A & B Beverage Company LLC, and A & B Distributors of Arkansas, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended. The Plan is administered by the Company and Minnesota Life Insurance Company serves as the trustee. Earnings and losses on investments are allocated to the participants' accounts.

Effective Date

The Plan's initial effective date was January 1, 1988. The plan was amended and restated effective August 1, 2021. The plan has since been amended effective May 15, 2024. Amendments included changing eligibility requirements, employer matching contributions and employer matching vesting schedules.

Eligibility

Employees hired before August 1, 2023 are eligible to participate in the Plan if they are 21 years of age and have completed one year of service during which they must have completed 1,000 hours of service. Employees hired after August 1, 2023 are eligible to participate in the Plan if they are 21 years of age and have completed three months of service during which they must have completed 250 hours of service. If they do not complete 250 hours of service within the first three months of employment, then the service requirement will be satisfied after completing one year of service.

Entry Date

The participant entry date will be the first day of the Plan year quarter coinciding with or next following the date eligibility requirements are satisfied.

Contributions

Each year, participants may make salary deferral contributions up to 100% of their annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. The Plan allows Pre-Tax deferral and Roth deferral contributions. The Plan allows participants to contribute amounts representing distributions from other qualified plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan provides for a Company discretionary matching of 100% up to a maximum of 5% of the employee's covered compensation.

The Company may also make a discretionary profit-sharing contribution to the employee's account. No such additional discretionary profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's deferrals and allocations of the Company's matching contribution, Plan earnings, and is debited with Plan expenses. Allocations are based on eligible participant compensation or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Plan participants may direct their entire account balances in partial increments to any of the various investment options offered by the Plan. Participants may change their investment options on a daily basis. Participants should review each investment option's prospectus for a description of the investment objectives.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are fully vested in their contributions and the earnings thereon. For discretionary employer matching contributions and employer profit sharing contributions, the vesting schedule is as follows: less than two years of service - 0%, two years of service - 25%, three years of service - 50%, four years of service - 75%, five years of service - 100%.

Forfeitures

The Company may pay Plan expenses and reduce employer contributions by forfeitures occurring during the Plan year. The Plan paid administrative expenses and reduced employer contributions for the years ended December 31, 2024 and 2023 by \$4,648 and \$2,938, respectively. The Plan maintained a balance of \$3,625 and \$8,820 in the forfeiture account at December 31, 2024 and 2023, respectively.

Withdrawn Participants

Included in the net assets available for benefits are the amounts allocated to individuals who have elected to withdraw from the Plan, but who have not been paid. There were no Plan assets allocated as of December 31, 2024 or 2023.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have no more than one outstanding loan at any time. Loan terms range from one to five years, or longer for the purchase of a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined by the Plan administrator, prime rate (7.5% at December 31, 2024) plus 2% during the year ended December 31, 2024. Principal and interest are paid ratably through payroll deductions. Interest income from participant loans is recognized as received.

Participant Loans (Continued)

As of December 31, 2024 and 2023, no loans were past due or delinquent. If a participant ceases to make loan repayments and the Plan administrator deems the participant to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Participants may elect to receive a distribution of the vested portion of their accounts either as a lump-sum or annual installments as defined in the Plan document upon termination of service, retirement, or disability. Participants that reach normal retirement age or become disabled while an employee will become 100% vested in all of their accounts under the Plan. Terminated participants with balances of \$7,000 or less will receive an automatic lump-sum distribution of their vested amount. Distributions may be made at the participant's request prior to termination upon attainment of age 62 or hardship as defined in the Plan document. In-service distributions can only be made from accounts which are 100% vested. Benefit payments to participants are recorded upon distribution.

Death Benefits

A designated beneficiary of the participant is entitled to a death benefit distribution equal to the participant's vested account balance upon death of the participant.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the modified cash basis, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles, and is an acceptable method of reporting under Department of Labor regulations. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Valuation and Income and Loss Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Notes 4 and 5 for discussion of fair value measurements and contract value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold during the year as well as those held at the end of the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Plan Administrative Expenses

Certain administrative expenses are paid by the Company and accordingly are not reflected in the accompanying financial statements of the Plan. Certain transaction processing fees are charged to the participants and therefore, are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

Subsequent Events

The Company has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available for issuance, and noted no events which require adjustments to, or disclosure in the 2024 financial statements.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As of December 31, 2024 and 2023, and for the year ended December 31, 2024, Securian Financial, an affiliate of Minnesota Life Insurance Company, held the Plan's investment assets and executed investment transactions.

Accordingly, as permitted under such election, the following information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was certified as complete and accurate by Minnesota Life Insurance Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a) Total investments shown in the accompanying statements of net assets available for benefits - modified cash basis of \$4,867,380 and \$3,772,752 as of December 31, 2024 and 2023, respectively.
- b) Net appreciation of investments of \$532,727 and interest and dividend income of \$4,442 as shown in the accompanying statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024.
- c) All investment-related information in the accompanying supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures ("ASC 820") establishes a framework for measuring fair value. That framework provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in an active market that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are both unobservable and significant to the overall fair value measurement.

Fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used must maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate: Valued daily at net asset value (“NAV”) based on the fair value of the observable market prices of the underlying assets within that account less liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluates the transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

NOTE 5 - INVESTMENT CONTRACT WITH MINNESOTA LIFE INSURANCE COMPANY

As of December 31, 2024 and 2023, the Plan held a fully benefit-responsive investment contract with Minnesota Life Insurance Company that contains a guaranteed return account. The MN Life Guaranteed Return Account is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

The average yield earned by the plan for the benefit-responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The averages for the years ended December 31, 2024 and 2023 are 1.54% and 1.50%, respectively. The actual yield earned by the plan during the years ended December 31, 2024 and 2023 are 1.54% and 1.50%, respectively. The actual yield earned is derived by averaging the Plan's quarterly interest rates.

By definition, a group annuity contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. Interest is credited to the guaranteed return account on a daily basis from the date deposits are accepted until paid, transferred or applied in full.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of a Plan's interest and (2) termination of the contract. The Plan's contract shall be terminated on the date when both no current deposit arrangements have been made between Minnesota Life Insurance Company and the Company and there are no guaranteed return accounts with a value greater than zero. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

There are no circumstances that would allow Minnesota Life Insurance Company to terminate the contract and settle at a value other than the contract value.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be related parties.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are managed by an affiliate of Minnesota Life Insurance Company, the asset custodian and trustee as defined by the Plan. Therefore, the investment transactions with the custodian qualify as party-in-interest transactions.

Notes receivable from participants and the related interest income are also considered party-in-interest transactions. Certain fees and expenses of the Plan may be paid by the Company. These transactions qualify as party-in-interest transactions. The Plan is not required to repay expenses paid by the Company on its behalf.

The Plan paid \$3,558 and \$2,645 for investment management services for the years ended December 31, 2024 and 2023, respectively.

A & B Distributors, Inc. of Muskogee provides to the Plan certain accounting and administrative services for which no fees are charged. The Plan Sponsor representative is currently a participant in the A & B Distributors Retirement Plan.

NOTE 8 - INCOME TAX STATUS

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions and could be subject to income tax if certain issues were found by the Internal Revenue Service that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with section 401 of the IRC. Although the Plan has been amended since receiving the initial determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
