Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Community Services for Every1, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of Community Services for Every1, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan sponsored by Community Services for Every1, Inc. (the Organization or Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Life Insurance Company and its affiliates (Principal) are the Plan's recordkeeper and custodian of investments held by the Plan. The Organization is responsible for oversight of the Plan and monitoring investment performance.

Eligibility — Employees of the Organization, except those classified by the Organization as "mobile work crew," who have completed six months of service, as defined, and are at least age eighteen, are eligible to participate in the Plan.

Contributions — Participants may make voluntary pre-tax and Roth (after-tax) contributions to the Plan based on their eligible compensation, as defined. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. All newly eligible employees are automatically enrolled in the Plan on the first day of the next calendar quarter upon meeting eligibility requirements unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their salary reduction contributions set at 2% of eligible compensation, as defined, on a pre-tax basis, and their contributions are invested in a designated default investment until changed by the participant. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan provides for discretionary matching and profit-sharing contributions, as approved by the Organization's Board of Directors (the Board). The discretionary matching contribution percentage is determined by the Board on an annual basis and applies to the entire plan year. For the year ended December 31, 2024, the discretionary match was equal to 25% of the participant's voluntary contributions and are calculated on a pay period basis. Discretionary profit sharing contributions are provided to participants that are employed on the last day of the Plan year and have attained at least 500 hours of credited service, as defined, and is allocated based on eligible compensation. The Board approved a discretionary profit-sharing contribution of \$2,518,819 for the year ended December 31, 2024 which was received by the Plan and allocated to eligible participants on April 21, 2025.

Contributions are subject to the Internal Revenue Code (the Code) limitations.

Participant Accounts — Each participant's account is credited with the participant's contributions, employer matching and profit-sharing contributions, an allocation of plan earnings (losses), reduced for benefits paid, and charged directly for benefit processing fees, if applicable. Allocation of Plan earnings are based on the investment balances held in the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Employee elective deferral contributions and employer contributions are invested as directed by plan participants. Participants may change their investment allocation at any time. The various Principal LifeTime Hybrid Collective Investment Funds (target-date funds) are the default investments used when a participant has not made an investment election for all or any portion of their accounts.

Vesting — Participants are vested immediately in their contributions plus actual earnings thereon. Employer matching and profit-sharing contributions become 20% vested after attaining one year of credited service, as defined, with vesting increasing at 20% increments each year thereafter, to 100% after five years of credited service. Vesting is immediate upon death, termination of employment due to a disability or attainment of retirement age, as defined.

Notes Receivable from Participants — Participants may borrow from their vested account balance ranging from a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance during the prior twelve-month period, or (b) 50% of their vested account balance. A participant may have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator. Loan terms may not exceed five years, except for loans used to purchase a principal residence.

Principal and interest are paid ratably through monthly payroll deductions.

Forfeitures – Participants not fully vested in Employer contributions upon separation from the Organization, as defined in the Plan document, forfeit their non-vested balances. Forfeitures may be used to reduce employer contributions, pay administrative expenses or be allocated to eligible participants, as defined, based on their proportion of eligible compensation compared to the eligible compensation of all eligible participants.

For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$611,741 and \$540,668, respectively. Forfeitures of employer contributions amounted to \$304,709 for the year ended December 31, 2024 and forfeitures allocated to participants in 2024 amounted to \$315,101.

Payment of Benefits — Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial payments. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and for participants who have attained age 59½.

2. Summary of Significant Accounting Policies

Basis of Accounting — The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition — The Plan's investments are reported at fair value, with the exception of pooled separate accounts and common/collective trust funds which are reported at net asset value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the Plan's custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net (depreciation) appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document and are included in the statements of changes in net assets available for benefits as deemed distributions from defaulted notes receivable from participants.

Payment of Benefits — Benefit payments to participants are recorded when paid.

Administrative Expenses — Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution processing fees are charged directly to the participant's account and are included in administrative expenses. The Plan also pays for certain recordkeeping fees. Other investment expenses related to fund management are included as an offset of net (depreciation) appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan.

Use of Estimates — The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Subsequent Events — Plan management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- Level 2 – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, substantially for the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.

- Level 3 – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Collective Investment Trusts – Investments in collective investment trusts are valued by Principal based upon the redemption price of units held by the Plan, which is based on the current fair value of the collective investment trusts’ underlying assets. The net asset value (“NAV”) per unit is determined by the financial institution sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. The NAV is used as a practical expedient to estimate fair value. There are no unfunded commitments and no redemption restrictions in the common collective trust funds. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts – Pooled separate accounts are valued by Principal at market value of the underlying investments. The accounts are not publicly quoted on an active market. The accounts can be redeemed at NAV, as determined by the Custodian, as of the measurement date. The NAV is used as a practical expedient to estimate fair value. Certain redemption fees and transfer restrictions may exist. The pooled separate accounts do not have any unfunded commitments relating to their investments, nor any restrictions on redemptions. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemption rights may be restricted or eliminated in the future. Were the Plan to initiate a full redemption of the underlying investments, the investment advisor has reserved the right to temporarily delay withdrawal from the pooled separate accounts to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related-Party and Party-In-Interest Transactions

Principal is the custodian as defined by the Plan and therefore, any transactions with Principal and its affiliates qualify as party-in-interest transactions. Fees incurred by the Plan for recordkeeping and administrative costs are included in net (depreciation) appreciation in fair value of investments, as they are paid through revenue sharing, and some fees are made by direct payments.

Certain employees and/or officers of the Organization, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan. The Organization pays directly other fees related to the Plan's operations.

Equitable Advisors, LLC (Equitable) provides broker and investment advisory services to the Plan and, therefore, transactions with Equitable also qualify as party-in-interest transactions. Equitable received indirect compensation for broker and investment advisory services.

Additionally, notes receivables from participants are considered party-in-interest-transactions.

5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

6. Tax Status

The Plan adopted a pre-approved plan document sponsored by Principal Financial Group. Principal Financial Group received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Certified Investment Information

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Principal Life Insurance Company and Principal Trust Company and furnished to the Company. The Company has obtained certifications from Principal Life Insurance Company and Principal Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
