Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chemistry Communications, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. NOTE A – DESCRIPTION OF PLAN

The following description of Chemistry Communications, Inc 401(k) Profit Sharing Plan (hereinafter referred to as “the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General:

The Plan is a multiple-employer, defined contribution plan covering all employees of Chemistry Communications, Inc., Chemistry South, LLC, Pinta USA, LLC, Test Tube Productions and React Digital, Inc. (the Companies) who have completed six consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year a participant may elect to make salary deferral contributions equal to a minimum of one percent of eligible compensation but no more than one hundred percent of compensation, per pay period subject to the Internal Revenue Code Section 402(g) limits. Participants may also contribute amounts representing rollovers from other qualified plans.

The Companies make a Safe Harbor matching contribution equal to 3% of the participant’s eligible compensation. In addition, the Companies may make a discretionary profit-sharing contribution. There were no profit-sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts:

Each participant’s account is credited with salary reduction amount, and employer contributions, and an allocation of Plan earnings and administrative expenses. Allocations of Plan earnings and administrative expenses are based on participant earnings or account balances, as defined.

Investment Options:

Each participant directs the manner in which contributions are to be allocated among the investment options available under the Plan.

Vesting:

Participants become fully vested in their elective deferrals, Safe Harbor contributions and rollover accounts immediately. Participants become vested in profit-sharing contributions as follows: 20% after 2 years of service, 40% after 3 years of service, 60 % after 4 years of service, 80% after 5 years of service, and 100% after 6 years of service. A year of service is defined as at least 1,000 hours in each Plan year.

Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime plus two percentage points. The interest on the outstanding loans is currently between 5.25% - 10.50%. Loans must be fully repaid within five years unless the loan is used for the purchase of a primary residence. Principal and interest are paid ratably through standard payroll deductions.

Payment of Benefits:

On termination of service due to death, disability, retirement, or other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 45 and hardship distributions subject to plan provisions.

Forfeited Accounts:

Forfeitures are used to reduce employer contributions and/or to pay administrative expenses. During the years ended December 31, 2024 and 2023, no forfeitures were used to reduce employer contributions and/or to pay administrative expenses. At December 31, 2024 and 2023, forfeited accounts totaled \$0.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefit and change therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on the investments purchased and sold as well as held during the year.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Administrative expenses are paid by the Plan or the Companies, at the discretion of the Companies. Expenses paid by the Companies are excluded from these financial statements.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in profit-sharing contributions.

NOTE D – TAX STATUS

The Companies adopted a volume submitter profit sharing plan with a cash or deferral arrangement which received a favorable determination letter from the IRS on March 31, 2014 which stated that the Plan is acceptable under the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E – CERTIFIED INVESTMENTS

Certified information related to investments in pooled separate accounts and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments in pooled separate accounts and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments in pooled separate accounts, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock, custodian, as of December 31, 2024 and 2023.

NOTE E – CERTIFIED INVESTMENTS (CONTINUED)

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G – PARTY-IN-INTEREST TRANSACTIONS

The Plan makes loans to participants. Plan investments include units of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A) and, therefore, these transactions qualify as party-in-interest transactions under ERISA. In addition, the Plan pays investment management fees, which amounted to \$4,091 and \$2,930 for the years ended December 31, 2024 and 2023, respectively.

NOTE H — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability as a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair Value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024.
