We have performed audits of the accompanying financial statements of Gottsch Employers Group 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

DECEMBER 31, 2024 AND 2023

1. Description of the Plan

The following description of Gottsch Employers Group 401(k) Plan (the “Plan”) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering employees, excluding union and leased employees, of Gottsch Employers Group, LLC (the “Company”) controlled group of companies. Employees become eligible to participate in the Plan upon having attained age 19 and having worked at least 400 hours in three consecutive months. If an employee does not complete 400 hours within three months, they become eligible after one year of service. Plan entry dates include the first day of each calendar quarter following the date eligibility requirements are met. The Plan trustee is responsible for oversight of the Plan, including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 14, 2024, the participant accounts from the Omaha Fixture Manufacturing, Inc. P/S 401(k) Plan and effective October 15, 2024, the participant accounts from the Standard Iron 401(k) Plan were transferred into the Plan.

B. Contributions

Each year, participants may elect to contribute up to 100 percent of their annual pretax compensation, as defined by the Plan not to exceed the maximum allowed by the Internal Revenue Code. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing roll-over distributions from other qualified benefit plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company may make separate discretionary matching contributions for participants working in different business units or locations, equal to a percentage of the participant’s elective deferrals, as determined by the Company. For the years ending December 31, 2024 and 2023, the Company made discretionary matching contributions of 35% of the first 8% of eligible compensation for all business units and locations which amounted to total Company contributions of \$216,035 and \$164,442, respectively.

C. Participant Accounts

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of investment losses and administrative fees paid by the plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

D. Vesting

Except as described below, participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching contribution is based on years of credited service. A participant is 20% vested after two years of service and an additional 20% each year thereafter until fully vested after six years of service. Participants become fully vested in Company's contributions upon death or total and permanent disability.

Employer matching and non-elective profit-sharing contributions for participants transferred into the Plan from the Omaha Fixture Manufacturing, Inc. P/S 401(k) Plan vest 20% after the first year of service and an additional 20% each year thereafter until fully vested after five years of service.

E. Payment of Benefits

Upon attainment of age 59 ½, termination of service, death, or disability, a participant (or their beneficiaries) may elect to receive the vested portion of his or her account in a lump sum or partial withdrawal in the form of cash, insurance contracts, or annuity contracts. Account balances not exceeding \$5,000 will be automatically rolled over to an individual retirement account (IRA).

F. Forfeited Accounts

Forfeitures of \$15,870 and \$17,169 were used to pay administrative expenses and reduce employer contributions during 2024 and 2023, respectively. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$8,280 and \$15,380, respectively.

2. Summary of Significant Accounting Policies

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

B. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The most significant estimate in the accompanying financial statements is the valuation of investments at contract value by The Standard Insurance Company (“The Standard”). Because of the inherent uncertainties in this process, actual results, including the realization of contract value of the investments, could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at contract value. Contract value represents the accumulated contributions plus allocated earnings (losses), less withdrawals and allocated expenses.

Contributions to the general account and allocation of separate account accumulation units are recorded the day of, or the day following, receipt of contributions by the plan, provided the New York Stock Exchange is open for trading. Income is allocated daily to the separate accounts as defined by the contract. Interest is credited to the general account daily.

Benefits are recorded when paid.

E. Expenses

Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses reduce the net appreciation in value of investments.

F. Risks and Uncertainties

The Plan provides various investment options. The investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits. The Plan's net assets available for benefits are significantly concentrated among two investments totaling \$5,486,214 or 45% of plan assets as of December 31, 2024.

G. Subsequent Events

Management evaluated transactions and events occurring subsequent to December 31, 2024, and through October 6, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

4. Group Annuity Contract with Minnesota Life Insurance Company

All plan assets are subject to a group annuity contract (“the contract”) entered into by the Plan with Minnesota Life Insurance Company (“Minnesota Life”) in 2007. In 2022, Minnesota Life entered into agreements with The Standard under which The Standard assumed responsibility for administrative and investment-related services associated with the contract. Minnesota Life remains the issuer of the contract and retains ultimate responsibility for benefits under the contract. Minnesota Life maintains the contributions in a general account and pooled separate accounts. The general account is credited with interest and charged for participant withdrawals and applicable expenses. Minnesota Life is contractually obligated to repay all contributions to the general account and a specified interest rate that is guaranteed to the Plan. The effective annual crediting rate is declared by Minnesota Life and may not be less than 1.5%. When contributions are made to separate accounts, Minnesota Life allocates accumulation units of the separate accounts to the plan. The separate accounts’ accumulation unit value (“unit value”) is increased by investment income and gains of the underlying investments of the separate account and charged for investment losses and applicable expenses. Minnesota Life is contractually obligated to pay the unit value. At any time, the unit value may be less than the initial investment.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals, investment losses, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

A lump sum liquidation of Plan assets upon termination of the contract may limit the ability of the Plan to transact at contract value with Minnesota Life and may also limit the ability of the Plan to transact at contract value with the participants. Termination of the contract is not probable of occurring. Certain events allow Minnesota Life to terminate the contract with the Plan which may limit the ability to transact at contract value. Such events include (1) the Plan is no longer deemed to be a “qualified plan” under Section 401 of the Internal Revenue Code or other section of the Code allowing similar tax treatment, (2) the Plan is terminated, or (3) Minnesota Life determines that because of a change in the Plan or in the benefits to be provided, it is necessary to amend or modify this contract, and the Company does not assent to the amendment or modification.

5. Party-in-Interest Transactions

All Plan assets are held in investment options managed by The Standard on behalf of Minnesota Life; therefore, these transactions qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Plan is a non-standardized pre-approved 401(k) profit sharing plan created by Minnesota Life and adopted by the Company on September 1, 2021. On June 30, 2020, the Internal Revenue Service stated this pre-approved 401(k) profit sharing plan adopted by the Company, as then designed, qualifies under Section 401(a) of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan. The plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


