Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Heritage Family Federal Credit Union 401(k) Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Heritage Family Federal Credit Union 401(k) Plan and Trust and to meet our other ethical responsibilities

in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Heritage Family Federal Credit Union 401(k) Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. opinion on the effectiveness of Heritage Family Federal Credit Union 401(k) Plan and Trust's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Heritage Family Federal Credit Union 401(k) Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. 1. DESCRIPTION OF PLAN

The following description of the Heritage Family Federal Credit Union 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan’s provisions.

- (a) General - The Plan is a defined contribution 401(k) plan established by Heritage Family Federal Credit Union (the “Credit Union”). Participants may join the Plan on the first full pay period of the month coinciding with or next following the date the participant satisfies the eligibility requirements. In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan’s provisions and applicable law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Eligibility - Employees of the Credit Union are eligible to participate in the Plan upon completion of three consecutive months of service, or one year of service, if earlier. All employees must be age 18 or older in order to participate in the Plan. All new eligible employees will be automatically enrolled in the Plan with a 3% deferral percentage, unless the employee elects a different percentage.
- (c) Employee Contributions - Eligible employees are allowed to contribute, through payroll deductions, up to 100% of pre-tax annual compensation not to exceed Internal Revenue Service (“IRS”) established limits. Participants that are 50 years or older by plan year-end are allowed to make catchup contributions not to exceed IRS established limits. Eligible compensation is defined in the Plan adoption agreement. Participants are permitted to make rollover contributions to the Plan.
- (d) Employer Contributions - Participants receive the employer match after completion of one year of service of at least 1,000 hours and have been employed on the last day of the year. The Plan provides for employer matching contributions in an amount equal to 50% of employee deferral contributions, which is subject to a maximum of 6% of eligible compensation. Any salary deferrals that are “catch-up contributions” will also be matched.

Effective July 1, 2024, the plan was amended to remove eligibility requirements for the match contribution, therefore, there is no conditions needed by participants to meet the match requirement and all eligible participants automatically share in the allocation.

In 2021 the Plan implemented a discretionary profit sharing contribution to participants hired on or subsequent to July 1, 2019. All employees acquired in conjunction with the Tri State Area Federal Credit Union acquisition are eligible for this contribution regardless of hire date.

The discretionary contribution amount equals 3% of eligible compensation based on one year of service of at least 1,000 hours, who are at the age of 18, and have been employed on the last day of the year.

- (e) Participant Accounts - Each participant's account is credited with the participant's allocation of (a) the participant's contribution; (b) the Credit Union's matching contributions; and (c) Plan earnings. The allocation of the profit-sharing contribution is based on the relationship of the participant's compensation to the total compensation earned by participants in the Plan. The allocation of the Plan's earnings is based on participants' account balances. The benefit to which a participant is entitled is that which can be provided from the vested balance in the participant's account.
- (f) Investment Allocation - Participants elect to have all contributions invested in any of the investments offered by the Plan.
- (g) Vesting - Participants are immediately fully vested in all employee contributions and earnings thereon. Employer discretionary contributions are subject to the following vesting schedule: Participants are 20% vested after two years of service; the vested portion increases to 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. A participant who dies, becomes permanently disabled, retires at 55 and completes 5 years of service, or retires after age 65 immediately becomes 100% vested in matching contributions. Any profit-sharing contributions made by the Credit Union are vested after the employee has completed 1,000 hours of service during the Plan year.
- (h) Forfeitures - The part of any participant account that is not vested upon distribution will be transferred to a "forfeiture account". The balance of the forfeiture account attributable to the Credit Union contributions may be used to pay administrative expenses of the Plan or reduce the Credit Union contributions. The forfeiture account balance as of December 31, 2024 and 2023 was \$1,292 and \$1,760, respectively. Forfeitures used during the years ended December 31, 2024 and 2023 were \$20,169 and \$5,572, respectively.
- (i) Notes Receivable - Loans are not permitted to participants.
- (j) Payment of Vested Benefits - Upon termination of service, a participant may elect to receive a lump-sum distribution or choose to wait until they reach retirement age to receive a lump-sum amount equivalent to their vested benefits. The Plan permits for a hardship distribution assuming there is an immediate and heavy financial need and the participant is 100% vested and currently employed with the Credit Union. The Plan also permits for an in-service distribution if the employee is at least 59 ½ years old. No other in-service distributions are allowed.

2. SUMMARY OF ACCOUNTING POLICIES

- (a) Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

SUMMARY OF ACCOUNTING POLICIES (continued)

- (b) Investment Valuation and Income Recognition - Investments are stated at fair value determined using quoted market prices in active markets. Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are based on the differences of beginning of the year fair values or cost if purchased during the current year, and year-end fair values. Interest income is accrued as earned, dividends are recorded on the ex-dividend date.
- (c) Expenses - Expenses of administering the Plan are generally paid by the Credit Union.
- (d) Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Risks and Uncertainties - The Plan invests in securities, which in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
- (f) Payment of Benefits - Benefits are recorded when paid.
- (g) Subsequent Events - The Plan evaluated subsequent events through October 15, 2025, the date the Plan's financial statements were available to be used.

3. PARTY-IN-INTEREST TRANSACTIONS

The Plan has a number of different service providers. Such providers are considered parties in interest under ERISA.

4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Credit Union has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination and payment of all expenses, the assets of the Plan would be distributed to participants based on amounts outstanding in their account as of the date of liquidation. Additionally, the Credit Union may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participants' accrued benefit.

5. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the closing price reported on the active market on which the underlying individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. TAX STATUS

The Plan is based on a prototype plan sponsored by the Standard Retirement Services Inc. who has obtained an opinion letter dated June 30, 2020, stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code. Generally the plan administrator and the Plan may rely on the determination letter received by the Standard Retirement Services Inc. as to the form of the plan qualifying under the Internal Revenue Code (except as otherwise noted in the determination letter). Additionally, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and remains tax-exempt. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. INFORMATION CERTIFIED BY THE PLAN'S INSURANCE CARRIER

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company, the insurance carrier of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.
