Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Building Plastics, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Building Plastics, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note H to the financial statements is complete and accurate.

Opinion

Basis for Opinion

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of Building Plastics, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a salary deferral plan pursuant to Section 401(k) of the Internal Revenue Code covering all employees who have attained the age of eighteen. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Contributions receivable is recorded at the estimated net realizable value. An allowance for credit losses is recorded based upon management's estimate of expected credit losses, determined by using subsequent collections. Management has determined that an allowance for credit losses is not considered necessary as of December 31, 2024.

Eligible employees may elect to defer (contribute) up to 100% of their compensation, as defined, not to exceed the maximum annual contribution permitted by the Internal Revenue Code. Participants may elect to invest their contributions in any of the available investment funds offered by the trustee. Participants are able to direct all contributions to their account in 1% increments to the investment funds offered by the trustee.

The employer's contributions to the Plan can include:

- a) a discretionary matching contribution equal to a designated percentage of specified salary deferral amounts as determined each year by the employer; and
- b) an employer's discretionary contribution amount.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and the allocation of the employer's contributions, plan earnings and forfeitures of terminated participants' nonvested accounts. Allocations are based on participant earnings and account balances, as defined in the Plan agreement. Participants who are not employed on the last working day of a plan year are not eligible for an allocation of the employer's discretionary contribution for that year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

4. Vesting

Participants are immediately vested in their salary deferrals, matching employer contributions, and any earnings thereon.

5. Notes Receivable from Participants

The Plan makes loans available to all participants on a uniform and non-discriminatory basis. Participants may borrow up to one-half of their vested account balance not to exceed \$50,000. Generally, loans must be repaid through payroll deduction over a period not to exceed five years; however, if the loan is for the purchase of a principal residence the Plan administrator may permit a longer repayment term. Interest will be charged on loans at 2% over the prime rate. The notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

6. Payment of Benefits

Generally, a distribution of a participant's benefit from the Plan is made only upon disability, death or retirement of the participant. Participants normally receive their benefits in the form of lump-sum cash payments, installments, or partial distributions, as provided under the Plan.

7. Forfeited Accounts

Participant forfeitures may first be used to pay administrative expenses of the Plan or to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested amounts totaled \$1,444 and \$1,424, respectively. For the year ended December 31, 2024, no amount of forfeitures were used to pay administrative expenses of the Plan or reduce employer contributions.

8. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Recordkeeping and other administrative expenses may be charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Additional fees are charged to participants based on their use of certain plan features.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. Estimates

In preparing financial statements in conformity with GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the guaranteed investment contract, which is reported at contract value. The shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. See Note C for disclosure of fair value measurement.

4. Date of Management's Review

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

5. Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributed based upon the terms of the Plan document.

6. Purchases and Sales of Securities

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

7. Benefits

Benefits are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value investment accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quote prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The fair value of the Plan's investments in registered investment companies are computed using Level 1 inputs, which are based on the quoted net asset value of the shares held by the Plan at year end.

The contract value of the Plan's investment in the Empower Key Guaranteed Portfolio Fund, which is a guaranteed investment contract, is reported daily using Level 2 inputs, which are based on the valuation method disclosed in the guaranteed investment contract, as calculated by the contract provider.

Gains and losses (realized and unrealized) included in the Statements of Changes in Net Assets Available for Plan Benefits for the years ended December 31, 2024 and 2023, are reported in Net appreciation (depreciation) in Fair Value of Investments.

NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan is invested in a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America that maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal interest at a specified interest rate of 1.41% that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- a) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
- b) premature termination of the contracts;
- c) plan termination or merger;

- d) changes to the Plan's prohibition on competing investment options; and
- e) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- a) an uncured violation of the Plan's investment guidelines;
- b) a breach of material obligation under the contract;
- c) a material misrepresentation; and
- d) a material amendment to the agreements without the consent of the issuer.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of a guaranteed investment contract managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Plan custodian at December 31, 2024 and 2023. Accordingly, these transactions qualify as parties-in-interest transactions. In addition, certain administrative expenses are paid directly by the Plan sponsor. All such transactions are exempt from the prohibited transaction provisions of the Employment Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code.

NOTE G - RISK AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks, including interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, Building Plastics, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE I - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian, jointly Empower Annuity Insurance Company of America and Empower Trust Company, LLC, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate with respect to: investments at fair value; notes receivable from participants; net appreciation (depreciation) in fair value of investments; interest on notes receivable; schedule of assets held for investment; and schedule of reportable transactions. The Plan's independent certified public accountants did not perform auditing procedures with respect to this information included in the financial statements.

NOTE J - TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020, stating that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA, which the Plan adopted, was designed in accordance with applicable Internal Revenue Code requirements. The Plan has not requested a determination letter of its own. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records the Plan to ascertain if any such taxable income exists but no such examination has occurred or is pending.
