

Eligibility Employees are eligible to enter on the January 1 or July 1 that is coincident with or next following the date the participant completes 12 months of service with 1000 hours and attains the age of 21

Excluded Employees Non-resident aliens with no US income, employees whose employment is governed by the terms of a collective bargaining agreement between Employee representatives (within the meaning of Code Section 7701(a)(46)) and the Employer, leased employees, Highly Compensated Employees with neither direct nor attributed ownership

Normal Retirement All participants are eligible to retire upon the later of attainment of age 62 and 5 years of participation.

Normal Retirement Benefit Upon retirement a participant will be entitled to a benefit payable in the normal form which is actuarial equivalent of the hypothetical account balance.
