Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Wellman Plastics Recycling, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Wellman Plastics Recycling, LLC (“Company”, “Plan Sponsor”, or “Plan Administrator”) 401(k) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. *General* – The Plan is a profit-sharing plan adopted by Wellman Plastics Recycling, LLC and related companies (the “Company”) for the benefit of their eligible employees. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Trustee of the Plan is Empower Annuity Insurance Company of America (“Empower”). Eligibility to participate in the Plan is based upon the completion of ninety days of eligibility service and attaining the age of twenty-one.
2. *Investment Options* – Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time via direct phone or internet access to the Trustee.
3. *Participant Accounts* – Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s discretionary contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined in the Plan. Participants are automatically enrolled in the Plan upon completion of eligibility requirements unless the participant opts out of participation. Automatically enrolled participants are defaulted to a 2% deferral rate.
4. *Payment of Benefits* – Upon termination, vested balances are available for distribution upon participant requests. If a participant’s vested account is less than \$5,000, the participant will receive a lump-sum distribution, as soon as practical, following termination. In the event of death of a participant, the Company’s contributions become 100% vested.
5. *Forfeited Accounts* – Participant forfeitures of Company distributions can be used to pay administrative expenses of the Plan. To the extent forfeitures are not used to pay administrative expenses, they may be used to reduce future Company contributions. No forfeitures were used during the year ended December 31, 2024. As of December 31, 2024 and 2023 forfeiture balances totaled \$8,390 and \$3,804, respectively.
6. *Vesting* – Participants are immediately vested in their employee contributions plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion, plus any earnings thereon, is based on years of service on a three-year cliff. A participant is 100% vested after three years of credited service and is 0% vested at less than three years.
7. *Contributions* – Company matching contributions to the Plan are solely at the discretion of the Company’s Board of Directors. The Company matching contribution equaled 50% and 25% for the years ended December 31, 2024 and 2023, respectively, for every 1% of employee deferral, capped at 4% of employee deferral. Additionally, a participant had to be employed on the last day of the year to receive a matching contribution.

Note 1. Description of Plan (continued)

7. *Contributions (continued)* – A participant may elect to contribute up to the maximum allowable by law of their aggregate compensation earned while a participant under the Plan. For the year ended December 31, 2024, contributions and eligible compensation were limited to \$23,000 (additional \$7,500 catch-up contribution allowed for eligible participants) and \$345,000 respectively. Participant contributions are fully vested at all times.
8. *Participant loans* – Participant loans are not allowed under the Plan.

Note 2. Summary of Accounting Policies

1. *Basis of Accounting* – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.
2. *Investment Valuation and Income Recognition* – Investments are reported at fair value, with the exception of the fully benefit responsive investment contract discussed at Note 6, which is measured at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. *Use of Estimates* – The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and use assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The most significant estimate affecting these financial statements is the fair value of investments. Actual results could differ from those estimates.
4. *Payment of Benefits* – Benefits paid to participants of the Plan are recorded by the Trustee when paid.
5. *Forfeitures* – The balance of the Plan's forfeitures was \$8,390 and \$3,803 at December 31, 2024 and 2023, respectively. No forfeitures were used to pay Plan expenses or reduce Plan Sponsor contributions during the year ended December 31, 2024.
6. *Uncertain Tax Positions* – The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability, nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's tax returns are subject to examination by the appropriate regulatory authorities, and, as of December 31, 2024, the Plan's tax returns remain open for the last three years.

Note 2. Summary of Accounting Policies (continued)

7. *Administrative Expenses* – Administrative expenses of the Plan are paid by the Plan or the Company as provided in the Plan document and consist of trust management fees, compliance service fees, and other miscellaneous fees. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.
8. *Employer Contributions Receivable* – The Company’s matching contribution, as previously described in Note 1, is contributed after the Plan’s year end. There was no allowance for credit losses necessary at December 31, 2024 and 2023.

Note 3. Recordkeeping and Participants’ Accounts

The Company engaged Empower Trust Company, LLC as the “Trustee” and “Recordkeeper” of the Plan’s assets. As such the Recordkeeper maintains all financial information regarding the Plan and participants accounts within the Plan. All Plan earnings, contributions and deductions are posted to the Plan’s records including participant records by the Recordkeeper.

Information regarding a participant’s account is furnished to the participant quarterly in printed form but also is available at any time via internet or telephone. The Recordkeeper posts participant and Company contributions to a participant’s account based on information received from the Company. The allocation of the contributions to the appropriate investment options or transfers of investment amounts is participant directed and can be initiated directly via web access or telephone.

Plan withdrawals are initiated through the Recordkeeper. Benefit payments are made to the participants directly by the Trustee. The Plan Administrator also notifies the Recordkeeper of deaths, disabilities, retirements, or terminations of participants.

Note 5. Fair Value Measurements

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Investments in pooled separate accounts are valued on a net asset value per unit basis which approximates their fair value. The pooled separate accounts are credited with earnings on the underlying investments and charged for Plan benefits paid and deductions for investment expenses, risk, profit, and annual management fees. Redemptions may occur on a daily basis. The use of net asset value as fair value is deemed appropriate as the pooled separate accounts do not have a finite life, unfunded commitments relating to investments, or significant restrictions on redemptions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Investment Contract with Insurance Company

The Plan offers an investment option in the MassMutual General Account. The investment holds a fully benefit-responsive group annuity contract with the MassMutual Life Insurance Company. MassMutual provides administrative and other services for the insurance policies for MassMutual Life Insurance Company and accepts and applies all deposits to the applicable investment options and pays all claims, including all withdrawals to plans and plan participants. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

MassMutual Life Insurance Company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. The crediting rate at December 31, 2024 was 2.80%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the contract will reflect the performance of the underlying portfolio.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's (MassMutual Life Insurance Company) ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 6. Investment Contract with Insurance Company (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (3) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Note 7. Plan Termination

In the event of partial or complete termination of the Plan, the rights of each affected participant to the entire amount credited to his/her account on the date of termination shall be nonforfeitable and fully vested. Unless directed otherwise by the Board or committee, the Trustee shall continue to administer the Plan and shall make distributions only in the event of death, disability, hardship, retirement, or termination of employment as provided under the Plan. Currently, there are no intentions to terminate the Plan. However, the Company reserves the right to terminate, suspend, withdraw, or amend the Plan at any time.

Note 8. Party-In-Interest Transactions

Certain Plan investments are managed by the Trustee therefore qualifying these transactions as party-in-interest transactions. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Fees paid directly by the Plan for administration, Trustee, and investment management services amount to \$44,028 for the year ended December 31, 2024.

Note 9. Tax Status

As of December 31, 2024, the Plan's determination letter was dated in June 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 12. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and totaled \$12,290 and \$9,575 for the years ended December 31, 2024 and 2023, respectively.

Note 13. Subsequent Events

The Company has evaluated events and transactions occurring subsequent to the balance sheet date of December 31, 2024. The evaluation was conducted through October 6, 2025, the date these financial statements were available to be issued, and there were no subsequent events that required disclosure in these financial statements.
