## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan

The following description of the Array Tech, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all regular employees of Array Tech, Inc. (the "Company"), who are eligible to participate in the Plan immediately upon the later of their date of hire or reaching age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### Administration

The Plan is administered by an administrator appointed by the Company. A certain specified employee of the Company serves as trustee. Fidelity Management Trust Company ("Fidelity Trust") serves as the trustee of the plan and Fidelity Workplace Services LLC ("Fidelity Workplace") serves as the recordkeeper.

#### Participant Contributions

Eligible employees are automatically enrolled into the Plan as soon as administratively possible, and pre-tax contributions are withheld at 3% of their eligible compensation and invested in a designated fund until elected otherwise by the participant. Eligible employees may contribute between 1% and 100% of their total annual eligible compensation to the Plan, not to exceed the limitation set forth in Section 402(g) of the Internal Revenue Code ("IRC"), \$23,000 in 2024 and \$22,500 in 2023. Additionally, participants who turn at least age 50 by the end of any calendar year can make an additional catch up contributions a maximum of \$7,500 for 2024 and 2023. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Employer Contributions

The Company makes enhanced qualified automatic enrollment agreement ("QACA") safe harbor matching contributions. For the years ended December 31, 2024 and 2023, the Company matched participants' contributions to the Plan at a rate of 100% (dollar for dollar) up to the first 3% of eligible compensation, plus 50% of the amount of the matched employee contributions that exceed 3% of compensation and 50% (50 cents for dollar) on the next 2% of compensation. After the end of each year, the Company reviews the percentage of compensation participants contributed over the year and makes a "true-up" matching contribution, if necessary, to ensure that participants received all the QACA safe harbor matching contributions to which they are entitled. During the years ended December 31, 2024 and 2023, the QACA safe harbor matching contributions were \$1,836,953 and \$1,840,170, respectively. During the years ended December 31, 2024 and 2023, the qualified non-elected contributions ("QNEC") were \$9,229 and \$92,237, respectively. The Company may also elect to make additional discretionary matching and profit-sharing contributions; however, the Company did not make any additional contributions during 2024 and 2023.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of Plan earnings, net of administrative expenses. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

#### Participant Notes Receivable

Participants may borrow from their account, a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Loan terms may not exceed five years, or 10 years if used for the purchase of a principal residence. Principal and interest are paid through payroll deductions. As of December 31, 2024 and 2023, loans bore interest at rates ranging from 4.25% to 9.50%. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### Vesting

Participants are vested immediately in their contributions, rollovers, Company profit-sharing contributions and any income or loss thereon. A participant becomes 100% vested in all Company contributions upon either death or disability while working for the Company.

Forfeitures are first used to pay for Plan administrative expenses and then to reduce future Company contributions. During the years ended December 31, 2024 and 2023, \$151,012 and \$0 of forfeitures were used to pay Plan administrative expenses or reduce Company discretionary matching contributions and QNEC. At December 31, 2024 and 2023, unused forfeitures of \$497,061 and \$316,591, respectively, were included in net assets available for benefits.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement, or attainment of age 59 ½, a participant (or his or her designated beneficiary in the event of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or to have the account balance distributed in installments. In-service withdrawals are allowed by the Plan after the participant has attained age 59 ½. If the account balance is \$5,000 or less, the Plan may, upon termination of service, pay the benefits owed in a lump-sum. Participants are eligible to receive hardship withdrawals when certain conditions are met.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of investments, participant notes receivable, and distributions are charge directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at year end. The Plan's interest in pooled separate account is valued based on the value of the underlying assets. The Plan's interest in collective trusts are stated at the fair value as determined by the Trustee based upon the quoted market values of the underlying assets.

Purchases and sales of securities are recognized as of the settlement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation of investments held at the end of the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as loan fees and are expensed when they are incurred.

#### Benefit Payments

Benefits are recorded when paid.

### 3. Fair Value Measurements

ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses the market approach, which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued at the NAV of units based on the quoted market price of the underlying security and the number of units owned by the Plan. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

*Collective trusts:* Valued at the NAV of units of a collective trust. The NAV, as provided by the Trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust to ensure that securities liquidations will be carried out in an orderly business manner.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by the Trustee and Custodian (Unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and participant notes receivable disclosed in the accompanying financial statements and supplemental schedules, including investments and participant notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on the notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**5. Tax Status**

The Plan has adopted a non-standardized form of a prototype plan sponsored by Fidelity Management & Research Company that is designed to comply with provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001 ("EGTRRA"). Such plans are pre-approved by the Internal Revenue Service ("IRS") by reference to the Cumulative List of Changes in Plan Qualification Requirements (the "Cumulative List") provided under EGTRRA. The prototype plan provider received an opinion letter from the IRS dated June 30, 2020 as to the prototype plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believes that the Plan is designed, and is correctly being presented, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

### **5. Tax Status, continued**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

### **7. Party-in-Interest Transactions**

Certain Plan investments are in accounts managed by the Trustee, and the Plan issues participant notes receivable. As described in Note 1, the Plan paid expenses related to the plan operations. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

### **8. Subsequent Events**

Plan management has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued and has concluded that there are no significant subsequent events to report.
