Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Opinion

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Arrowstreet, Inc. 401(k) Profit Sharing Retirement Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

General

The Plan is a defined contribution profit sharing plan with a cash deferred arrangement covering all employees of Arrowstreet, Inc. (the “Employer”), except for non-resident aliens who have no earned income from sources within the United States and those employees whose employment is governed by a collective bargaining agreement, (“Participants”). Employees may enter the Plan on the first day of employment.

Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively “Empower”) provides trustee and asset custodian services to the Plan. Empower Retirement, LLC provides recordkeeping services.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are Participant-directed.

Plan Administration

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual Participant accounts may be charged with an allocation of administrative expenses, if not paid by the Employer. Individual Participant accounts are charged directly for loan recordkeeping, if applicable.

Participant Contributions

Each year, Participants may defer up to 100% of their eligible compensation as defined by the Plan, up to a dollar limit established under the Internal Revenue Code (the “Code”). Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

Employees, upon eligibility to participate in the Plan, are automatically enrolled to defer 5% of their eligible compensation, as defined in the Plan document. A Participant may choose not to defer or may choose a different percentage once enrolled. A Participant’s deferral rate is automatically increased on an annual basis by one percentage point up to a maximum of 8%. Automatic enrollment deferrals are invested in the applicable lifecycle fund based on the employee’s birth date. The automatic pre-tax deferral election, automatic deferral escalation, and the default investment option remain in effect until the Participant changes them.

Employer Contributions

Employer Matching Contributions

The Employer may make matching contributions equal to a discretionary percentage of the Participants' elective deferral as determined by the Board of Directors annually. The annual maximum employer matching contribution is \$2,000 per Participant. To be eligible for employer matching contributions Participants must have attained 21 years of age, completed at least one year of service (defined as twelve consecutive months worked) and be employed by the Employer on the last day of the Plan year unless their employment has terminated due to death, total and permanent disability, or retirement, as defined by the Plan document. For the year ended December 31, 2024, the Employer elected not to make an employer matching contribution.

Employer Nonelective Contributions

The Employer may elect to make a discretionary nonelective contribution as determined by the Board of Directors annually. To be eligible for Employer nonelective contributions Participants must have attained 21 years of age, completed at least one year of service (defined as twelve consecutive months worked) and be employed by the Employer on the last day of the Plan year, unless their employment has terminated due to death, total and permanent disability, or retirement, as defined by the Plan document. Nonelective contributions are allocated among all eligible Participants based on employee classification. Each Participant constitutes a separate classification. For the year ended December 31, 2024, the Employer elected to make a discretionary nonelective contribution of \$109,213.

Participant Accounts

Each Participant's account is credited with the Participant's deferral contributions, their respective employer contributions, an allocation of the Plan's investment earnings and losses, and is charged with an allocation of certain administrative expenses, if applicable. Allocations are based on Participants compensation or account balances, as defined in the Plan document. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance.

Vesting

Participants are immediately vested in all contributions and the investment earnings thereon.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, both reduced by any outstanding loan balance. Loan terms range from one to five years (or longer for the purchase of a primary residence). A Participant may have up to two loans outstanding at a time. Loans are secured by the vested balance in the Participant's account and bear interest equal to 2% above the prime rate. Loans are considered due and payable upon termination of employment. Principal and interest are paid ratably through payroll deductions. If a Participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the Participant's loan balance is reduced, and a benefit payment is recorded as soon as a distributable event occurs. Interest rates on loans outstanding at December 31, 2024 and 2023 range from 5.25% to 10.00%, and mature at various dates through December 2031.

Payment of Benefits

Participants are entitled to their vested account balance upon death, disability, retirement, or termination of employment. A Participant may elect to receive either a lump-sum amount equal to the value of his or her account, partial payments or installment payments of such amounts, frequency, and duration as the Participant or beneficiary may elect. The payment can either be a cash distribution to the Participant or beneficiary, subject to income tax withholdings, a tax-free rollover into an Individual Retirement Account ("IRA") or another qualified plan. Upon termination, if a Participant's account balance is less than \$1,000, the plan administrator, after notification, may distribute to the Participant his or her entire account balance. If a balance is less than \$7,000 but greater than \$1,000 the plan administrator, after notification, may deposit the balance into an individual retirement account.

In-service withdrawals are allowed from a Participant's rollover accounts at any time. In-service withdrawals upon reaching age 59 ½ are allowed from all Participant's accounts. Hardship withdrawals may be taken from the Participant's elective deferral account and rollover account if certain criteria are met.

Forfeited Accounts

A Participant who leaves the employment of the Employer forfeits any non-vested balance. Non-vested balances relate to employer contributions from prior periods. Forfeited balances of terminated Participants' accounts may be used to pay administrative expenses, applied to reduce Employer contributions, or allocated to all Participants in proportion to each Participant's compensation for the plan year relative to the total compensation of all Participants. At December 31, 2024 and 2023, unused forfeiture balances amounted to \$987 and \$942, respectively.

Administrative Expenses

Expenses resulting from participant loans, certain investment fees, and fees related to distributions are deducted directly from participant accounts. All other administrative expenses are paid by the Employer, which are not reflected in these financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes thereon and disclosure of contingent asset and liabilities. Actual results could differ from these estimates.

Investments, Investment Valuation, and Income Recognition

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Guaranteed interest account: The Plan has a guaranteed interest account contract with Empower Annuity Insurance Company of America. The guaranteed interest account is reported at contract value. Contract value is the relevant measurement attribute to fully benefit-responsive investment contracts because contract value is the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for information on the guaranteed interest account.

Mutual funds: As of December 31, 2024 and 2023, mutual funds amounted to \$17,554,720 and \$17,887,563, and are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

Investments, Investment Valuation, and Income Recognition (continued)

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value, see Note 4 for discussion of the investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payments of Benefits

Benefits payments to participants are recorded during the period in which the Participant is paid.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, interest income from guaranteed interest account, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, qualified institutions.

4. Group Annuity Contract with Empower Annuity Insurance Company of America

The Plan has a fully benefit-responsive group annuity contract, that participants invest in the through a guaranteed interest account ("GAC" or guaranteed interest account) with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. The GAC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants invest in the GAC through a guaranteed interest account.

Since the GAC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GAC. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less Participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate for the year ended December 31, 2024 was 1.70%. The crediting interest rate is based on a formula agreed upon with the Trustee. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the Empower Annuity Insurance Company of America. Such events include the following: (i) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with plan Participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (i) certain instances of a participant termination of employment as listed in the contract, (ii) removal from the Plan of one or more groups or classifications of participants, (iii) partial or complete plan termination, or (iv) plan disqualification.

5. Risk and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Party-In-Interest Transactions

Plan investments include a guaranteed interest account managed by Empower Annuity Insurance Company of America and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA. The Employer pays directly for any other fees related to the Plan's operations.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to Participant accounts and distributed in such a manner as the employer may determine.

8. Tax Status

The underlying volume submitter profit sharing plan had received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, in which the IRS stated that the form of the plan is qualified under Section 401(a) of the Code, was in compliance with the applicable requirements of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and that the Plan is qualified and the related trust is tax-exempt as of the date of this report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. Subsequent Events

The Plan administrator has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued, and determined that there have been no subsequent events, that would require recognition in, or disclosure in the notes to, the financial statements.

Effective January 1, 2025, the Plan's automatic escalation feature was amended to increase the maximum deferral rate from 8% to 10% of eligible compensation.
